


TYPICAL CHARACTERISTICS (Ta = 25 °C)




FORWARD BIAS SAFE OPERATING AREAS




TRANSIENT THERMAL RESISTANCE





DRAIN CURRENT vs. DRAIN TO SOURCE




DRAIN CURRENT vs. DRAIN TO SOURCE VOLTAGE








DRAIN ON RESISTANCE vs. GATE TO SOURCE VOLTAGE
