1. About QE for AFE

1.1 Summary

QE for AFE is an evaluation tool for embedded system development that performs graphical tuning with an integrated analog front end (AFE). Using this tool, you can configure AFE registers, write register into evaluation board and monitor the AFE tuning results in a waveform.

1.2 Functions

The main functions are listed below:

- 1. Connect and operate the evaluation board
- 2. Config AFE related registers with GUI
- 3. Display graphics of the AFE tuning results and digital filter frequency response
- 4. Interact with FSP property and generate code by FSP when working as one of e² studio plug-in,

1.3 New Functions

1.3.1 Release QE for AFE e² studio plug-in

From QE for AFE V2.0.0, you can use QE for AFE in e² studio, which can interact with FSP property and generate code by FSP configuration.

1.3.2 Support emulator connection

From QE for AFE V2.0.0, when work as e² studio plug-in, you can tune AFE by emulator connection with evaluation board.

1.3.3 Improve some functions on configuration diagram

From QE for AFE V2.0.0, the following functions are improved:

 ADC16 sampling time selection is changed to an editable combo box with the maximum and minimum sampling time. User can select directly, also can enter any other value within the range manually.




Figure 1-1. ADC16 sampling time selection

SINC3 filter setting is moved to a pop-up dialog, which is open by clicking "Config" button on SDADC24 configuration diagram.




Figure 1-2. SINC3 filter setting

AVCC0 and DAC output voltage value are displayed on DAC8 and DAC12 GUI.




Figure 1-3. AVCC0 and DAC output voltage value

ADC16 calibration function is performed on all A/D channels once.




Figure 1-4. ADC16 calibration function

2. Installation and Uninstallation

2.1 Installing This Product

Use either of the following procedure to install this product.

2.1.1 Install from the "Renesas Software Installer" menu of e2 studio

- 1. Start e² studio.
- 2. Select the "Renesas Views" "Renesas Software Installer" menu of e² studio to open the "Renesas Software Installer" dialog box.
- 3. Select the "Renesas QE" and click the "Next >" button
- 4. Select the "QE for AFE (v2.0.0)" check box and click the "Finish" button.
- 5. Check that the "Renesas QE for AFE" check box is selected in the "Install" dialog box and click the "Next >" button.
- 6. Check that the "Renesas QE for AFE" check box is selected as the target of installation and click the "Next>" button.
- 7. After confirming the license agreements, if you agree to the license, select the "I accept the terms of the license agreements" radio button, and click the "Finish" button.
- 8. When the dialog box for selecting a trusted certificate appears, check the displayed certificate, and then click on the "Trust Selected" button to continue installation.
- 9. Restart the e2 studio by following the instructions on the screen.
- 10. Start this product from the "Renesas Views" "Renesas QE" menu of e² studio. For details about how to use this product, see the "Help" menu of e² studio.

2.1.2 Install using QE (zip file) downloaded from the Renesas website

A downloaded zip file has both a plugin version and a standalone version.

2.1.2.1 Install Plugin Version

- 1. Extract the downloaded zip file.
- 2. Start the e² studio.
- 3. Click on "Help", and then click on the "Install New Software..." menu item to open the "Install" dialog box.
- 4. Click on the "Add..." button to open the "Add Repository" dialog box.
- 5. Click on the "Archive..." button, select the installation file (zip file under the QE-AFE folder) in the opened file selection dialog box, and then click on the "Open" button.
- 6. Click on the "Add" button in the "Add Repository" dialog box.
- 7. Expand the "Renesas QE" item shown in the "Install" dialog box, select the "Renesas QE for AFE" check box, and then click on the "Next>" button.
 - *If you check off the "Contact all update sites during install to find required software" checkbox, you can shorten the installation time.
- 8. Confirm that the installation target is "Renesas QE for AFE", and then click on the "Next>" button.
- 9. After checking the license, select the "I accept the terms of the license agreements" radio button if you agree it, and then click on the "Finish" button.
- 10. When the dialog box for selecting a trusted certificate appears, check the displayed certificate, and then click on the "Trust Selected" button to continue installation.
- 11. Restart the e² studio by following the instructions on the screen.
- 12. Start this product from the "Renesas Views" "Renesas QE" menu of the e² studio. . For details about how to use this product, see the "Help" menu of e² studio.



2.1.2.2 Install Standalone Version

- Extract ".zip" file to a user-specified location on the PC.
 Note: Please do not put the tool under OS program folder (C:\Program Files)
- 2. Start this product by double clicking "\QE-AFE\eclipse\ qe-afe.exe".
- 3. For the first time this product starts, there is a dialog of license agreement. After checking the license, you can select "Agree" or "Disagree".




Figure 2-1. License agreement dialog

4. If "Agree" is selected in above step, the product is launched then you can use it; if "Disagree" is selected in above step, the product won't be launched.

2.2 Updating This Product

If you have already used this product, you can update it in the same way as the procedure for installation.

2.3 Uninstalling This Product

2.3.1 Uninstall Plugin Version

- 1. Start the e² studio.
- 2. Select "Help -> About e² studio" to open the "About e² studio" dialog box.
- 3. Click the "Installation Details" button to open the "e2 studio Installation Details" dialog box.
- 4. Select "Renesas QE for AFE" displayed on the "Installed Software" tabbed page and click on the "Uninstall..." button to open the "Uninstall" dialog box.
- 5. Check the displayed information and click on the "Finish" button.
- 6. Restart the e2 studio by following the instructions on the screen...

2.3.2 Uninstall Standalone Version

Delete the entire folder which .zip package is extracted.

3. Notes / Restrictions

3.1 Usage Considerations

Please pay attention to the following items.

3.1.1 Notes on configuring ADC16 sampling time

The sampling time of ADC16 is limited by the PCLKB/PCLKD clock setting. For different PCLKB/PCLKD clock, you should set sampling time within the special range. Otherwise, ADC16 tuning can't perform successfully. The detailed information can be found in "RA2A1 Group Board Control Program for "QE for AFE"" application note.

3.1.2 Notes on configuring SDADC24 and ADC16

SDADC24 and ADC16 source clock is got from the firmware running on the evaluation board, please connect with evaluation board before configuring SDADC24 and ADC16.

3.1.3 Notes on X-Axis Time Width setting on [Monitor] view

To display a waveform by clicking "Read AFE tuning data from file", X-Axis Time Width setting should not be too large. As a recommendation, X-Axis Time Width should be set no more than 10s with maximum SPS 15625.

3.1.4 Notes on clicking [Write Value to The Target Board] button after configuring one AFE component setting

It is recommended to click [Write Value to The Target Board] button each time completing one AFE component configuration and move to next AFE component configuration. The reason is that firmware will check the validity of the register value basing on the register value on the evaluation board. Keeping the register values on the evaluation board always consistent with the GUI configuration can avoid unexpected errors when writing new registers value to the evaluation board.

3.1.5 Notes on ADC16 One-shot and Auto mode selection on [Monitor] View

ADC16 has 2 tuning modes: One-shot and Auto. The waveform of these 2 modes is depending on ADC16 sampling time setting:

- When ADC16 sampling time is short (performing high-speed conversion)
 - One-shot mode: QE for AFE reads data from evaluation board and draws the waveform only once
 - Auto mode: QE for AFE reads data from evaluation board and draws the waveform continuously
- When ADC16 sampling time is long (performing low-speed conversion)
 - Either One-shot mode or Auto mode, the waveform are same: QE for AFE reads data from evaluation board and draws the waveform continuously

3.1.6 Notes on closing [AFE Monitor (QE)] view

- In standalone version, while tuning is in progress and close monitor view, the tuning is stopped automatically.
- In e² studio plugin version, if several perspectives exist, and one [AFE Monitor (QE)] monitor view is closed while tuning is in progress, the tuning won't be stopped. You can still observe the tuning result in other perspective. Until the last monitor view is closed, the tuning is stopped automatically.



3.1.7 Notes on UART connection after evaluation board reset

After reset of the evaluation board, please take note to set bitrate as 1,000,000 bps (default bitrate), then click "connect" button to set up connection.

3.1.8 Notes on monitor multiple channels data

When monitoring multiple channels data, usually the data quantity of each channel should be same. If you see the data quantity is not same, it means certain channel data is invalid and was discarded when drawing waveform. QE for AFE V2.0.0 doesn't output any message for invalid data. So please kindly take note about it.




Figure 3-2 Multiple channel waveform

3.1.9 Notes on OPAMP trimming function failed using emulator

When using emulator, OPAMP trimming function occasionally fails. The phenom is that even click "Next" and wait a while on Step1 or Step2, the wizard can't move to next step. So to execute OPAMP trimming function, please take priority to use USB or UART connection mode.

3.1.10 Notes on downloading AFE adjustment project

To download AFE asjustment project, please kindly take note to set the region using the following steps. Otherwise, project can't be downloaded.

- 1) Select [Window] > [Show View]>[Smart Browser] menu.
- 2) Select [Setting] in the Smart Browser [View menu].
- 3) Select one region in the settings dialog and click [Apply and Close] button.




Figure 3-3 Smart Browser Region setting

3.1.11 Notes on pressing [Stop AFE Tuning] button

User presses [Stop AFE Tuning] button, then the waveform doesn't stop and an error message output in [Console] view as the following image. If you met this case, please try to press [Stop AFE Tuning] button again. By this way, usually tuning can stop correctly without reset the board.




Figure 3-4 Stop Failed Case

3.2 Functional Restrictions

The following restrictions apply to QE for AFE[RA] V2.0.0. These restrictions will be solved in next or future version.

3.2.1 Restrictions on showing a video about how to use QE AFE

The video is not ready for publish, so you can't open the video even if you press the video button.

3.2.2 Restrictions on ACMPLP configuration.

- "DAC8 channel 0 output" is selected as ACMPLP0 input (refer to figure 3-4 (1))
 - When switcher (A) selects Vref (refer to figure 3-4 (A))
 - ➤ When ACMPLP0 is disabled (refer to figure 3-4 (D))
 - When switcher (B) selects IVREF0, switcher (C) selects Vref (refer to figure 3-4 (B) and (C)) and ACMPLP1 is enabled (figure 3-4 (E) selects "Enable")




Figure 3-6 ACMPLP1 example setting

Either of above ACMPLP0 settings will cause the register value cannot be successfully written to the EK-RA2A1 board with the following 1) - 3) settings.

1) Set P013 as DA8_0 function in DAC8 page, P013PFS = 0A018000 can't be write to test board successfully




Figure 3-7 DA8_0 example setting

 Select DA8_0 as OPAMP1 input in OPAMP page, AMP1PS = 80 can't be write to test board successfully.




Figure 3-8 OPAMP example setting

3) Select "DAC8 channel 0 output" as input in ACMPHS page, CMPSEL1 = 08 can't be write to test board successfully.




Figure 3-9 ACMPHS example setting

[Workaround]

In above ACMPLP0 setting, (1) setting is invalid. So please change (1) from "DAC8 channel 0 output" to "CMPREF0".

- "DAC8 channel 1 output" is selected as ACMPLP1 input (refer to figure 3-4 (2))
 - When switcher (B) selects IVREF0 (refer to figure 3-4 (B))
 - ➤ When switcher (C) selects Vref (refer to figure 3-4 (C))
 - ➤ When ACMPLP1 is disabled (refer to figure 3-4 (E))

Either of above ACMPLP1 settings will cause the same limitations 1) and 2) as selecting" DAC8 channel 0 output "above.

[Workaround]

In above ACMPLP1 setting, (2) setting is invalid. So please change (2) from "DAC8 channel 1 output" to "CMPREF1".



3.2.3 Restrictions on abnormal phenomena in AFE tuning operation

When the following abnormal phenomena occur, it indicates that the data got from evaluation board has some errors under the current AFE configuration.

- (1) After a period of tuning operation, the waveform stops without any error message output in [Console] view.
- (2) User clicks "Stop AFE Tuning" button, then the waveform seems stopped but an error message output in [Console] view as the following image.




Figure 3-10 "Stop AFE Tuning" error message

General Precautions in the Handling of Microprocessing Unit and Microcontroller Unit Products

The following usage notes are applicable to all Microprocessing unit and Microcontroller unit products from Renesas. For detailed usage notes on the products covered by this document, refer to the relevant sections of the document as well as any technical updates that have been issued for the products.

1. Precaution against Electrostatic Discharge (ESD)

A strong electrical field, when exposed to a CMOS device, can cause destruction of the gate oxide and ultimately degrade the device operation. Steps must be taken to stop the generation of static electricity as much as possible, and quickly dissipate it when it occurs. Environmental control must be adequate. When it is dry, a humidifier should be used. This is recommended to avoid using insulators that can easily build up static electricity. Semiconductor devices must be stored and transported in an anti-static container, static shielding bag or conductive material. All test and measurement tools including work benches and floors must be grounded. The operator must also be grounded using a wrist strap. Semiconductor devices must not be touched with bare hands. Similar precautions must be taken for printed circuit boards with mounted semiconductor devices.

2. Processing at power-on

The state of the product is undefined at the time when power is supplied. The states of internal circuits in the LSI are indeterminate and the states of register settings and pins are undefined at the time when power is supplied. In a finished product where the reset signal is applied to the external reset pin, the states of pins are not guaranteed from the time when power is supplied until the reset process is completed. In a similar way, the states of pins in a product that is reset by an on-chip power-on reset function are not guaranteed from the time when power is supplied until the power reaches the level at which resetting is specified.

3. Input of signal during power-off state

Do not input signals or an I/O pull-up power supply while the device is powered off. The current injection that results from input of such a signal or I/O pull-up power supply may cause malfunction and the abnormal current that passes in the device at this time may cause degradation of internal elements. Follow the guideline for input signal during power-off state as described in your product documentation.

4. Handling of unused pins

Handle unused pins in accordance with the directions given under handling of unused pins in the manual. The input pins of CMOS products are generally in the high-impedance state. In operation with an unused pin in the open-circuit state, extra electromagnetic noise is induced in the vicinity of the LSI, an associated shoot-through current flows internally, and malfunctions occur due to the false recognition of the pin state as an input signal become possible.

5. Clock signals

After applying a reset, only release the reset line after the operating clock signal becomes stable. When switching the clock signal during program execution, wait until the target clock signal is stabilized. When the clock signal is generated with an external resonator or from an external oscillator during a reset, ensure that the reset line is only released after full stabilization of the clock signal. Additionally, when switching to a clock signal produced with an external resonator or by an external oscillator while program execution is in progress, wait until the target clock signal is stable.

- 6. Voltage application waveform at input pin
 - Waveform distortion due to input noise or a reflected wave may cause malfunction. If the input of the CMOS device stays in the area between V_{IL} (Max.) and V_{IH} (Min.) due to noise, for example, the device may malfunction. Take care to prevent chattering noise from entering the device when the input level is fixed, and also in the transition period when the input level passes through the area between V_{IL} (Max.) and V_{IH} (Min.).
- 7. Prohibition of access to reserved addresses

Access to reserved addresses is prohibited. The reserved addresses are provided for possible future expansion of functions. Do not access these addresses as the correct operation of the LSI is not quaranteed.
