3.1 Note on updating the version

After the license manager is updated to V2.00.00 or a later version, the setting for using a floating license is disabled by default. If you wish to use a floating license, enable this through the following step.

Click on the [Option] button in the [License Manager] window, and then click on the [Enable] button in the [Floating License Option] dialog box.

Chapter 4. Changes

This chapter describes the main changes in the license manager from V2.00.00 to V2.01.00.

4.1 Indication of license agreement

The timing which indicates license agreement has been changed.

[Before change] At the time of launching license manager and validating floating license.

[After change] At the time of registering license key.

4.2 Function of notification regarding the version

The icon indicates mismatches between versions registered with the license manager and the floating license server.




Figure 1 Icon of notification regarding the version

4.3 Improved function of notification regarding license expiration date

The function which notify the annual license expiration date has been improved. The user is informed of the approaching expiry of annual licenses at the following times: one month, two weeks, and one day before expiration.




Figure 2 Icon of notification of license expiration date
