# General Precautions in the Handling of Microprocessing Unit and Microcontroller Unit Products

The following usage notes are applicable to all Microprocessing unit and Microcontroller unit products from Renesas. For detailed usage notes on the products covered by this document, refer to the relevant sections of the document as well as any technical updates that have been issued for the products.

- 1. Precaution against Electrostatic Discharge (ESD)
  - A strong electrical field, when exposed to a CMOS device, can cause destruction of the gate oxide and ultimately degrade the device operation. Steps must be taken to stop the generation of static electricity as much as possible, and quickly dissipate it when it occurs. Environmental control must be adequate. When it is dry, a humidifier should be used. This is recommended to avoid using insulators that can easily build up static electricity. Semiconductor devices must be stored and transported in an anti-static container, static shielding bag or conductive material. All test and measurement tools including work benches and floors must be grounded. The operator must also be grounded using a wrist strap. Semiconductor devices must not be touched with bare hands. Similar precautions must be taken for printed circuit boards with mounted semiconductor devices.
- 2. Processing at power-on
  - The state of the product is undefined at the time when power is supplied. - 3. Input of signal during power-off state
  - Do not input signals or an I/O pull-up power supply while the device is powered off. The current injection that results from input of such a signal or I/O pull-up power supply may cause malfunction and the abnormal current that passes in the device at this time may cause degradation of internal elements. Follow the guideline for input signal during power-off state as described in your product documentation.
- 4. Handling of unused pins
  - Handle unused pins in accordance with the directions given under handling of unused pins in the manual. The input pins of CMOS products are generally in the high-impedance state. In operation with an unused pin in the open-circuit state, extra electromagnetic noise is induced in the vicinity of the LSI, an associated shoot-through current flows internally, and malfunctions occur due to the false recognition of the pin state as an input signal
- 5. Clock signals
  - After applying a reset, only release the reset line after the operating clock signal becomes stable. When switching the clock signal during program execution, wait until the target clock signal is stabilized. When the clock signal is generated with an external resonator or from an external oscillator during a reset, ensure that the reset line is only released after full stabilization of the clock signal. Additionally, when switching to a clock signal produced with an external resonator or by an external oscillator while program execution is in progress, wait until the target clock signal is stable.
- 6. Voltage application waveform at input pin
  - Waveform distortion due to input noise or a reflected wave may cause malfunction. If the input of the CMOS device stays in the area between  $V_{IL}$  (Max.) and  $V_{IH}$  (Min.) due to noise, for example, the device may malfunction. Take care to prevent chattering noise from entering the device when the input level is fixed, and also in the transition period when the input level passes through the area between  $V_{IL}$  (Max.) and  $V_{IH}$  (Min.).
- 7. Prohibition of access to reserved addresses
  - Access to reserved addresses is prohibited. The reserved addresses are provided for possible future expansion of functions. Do not access these addresses as the correct operation of the LSI is not quaranteed.
- 8. Differences between products
  - Before changing from one product to another, for example to a product with a different part number, confirm that the change will not lead to problems. The characteristics of a microprocessing unit or microcontroller unit products in the same group but having a different part number might differ in terms of internal memory capacity, layout pattern, and other factors, which can affect the ranges of electrical characteristics, such as characteristic values, operating margins, immunity to noise, and amount of radiated noise. #### 1. Introduction

This Quick Start Guide (QSG) provides:

- An overview of the Quick Start example project that the AIK-RA4E1 board comes pre-programmed with.
- Instructions for running the Quick Start example project.
- Instructions for importing, modifying, and building the Quick Start example project using Flexible Software Package (FSP) and e2 studio Integrated Development Environment (IDE)

#### 1.1 Assumptions and Advisory Notes

- 1. Tool experience: It is assumed that the user has prior experience working with IDEs such as e2 studio and terminal emulation programs such as Tera Term.
- 2. Subject knowledge: It is assumed that the user has basic knowledge about microcontrollers, embedded systems, and FSP to modify the example project described in this document.
- 3. Prior to running the Quick Start example project or programming the AIK -RA4E1 board, default jumper settings must be used. Refer to the AIK -RA4E1 user's manual for the default jumper settings.
- 4. The screen shots provided throughout this document are for reference. The actual screen content may differ depending on the version of software and development tools used.

#### 2. Kit Contents

The following components are included in the kit:

- 1. AIK-RA4E1 board.
- 2. Renesas ICM-42670-P PMOD Board
- 3. Micro USB device cable (type-A male to micro-B male)
- 4. Micro USB device cable (type-A male to type-C male)




Figure 1. AIK-RA4E1 Kit Contents

#### 3. Overview of the Quick Start Guide Project – Asset Movement Recognition (AMR)

The AMR project uses the accelerometer module to perform motion recognition as described in the table below:

No	Movement	LED Indicator
1	Drop	Red LED blinks
2	Motion	Cyan LED blinks
3	Circle	Yellow LED blinks
4	Wave	All LEDs blink
5	Idle	Green LED blinks

Power on the AIK-RA4E1 Kit with any of the USB connectors that are available.

The AMR operation is demonstrated in renesas.com/aik-ra4e1.




Figure 2. Quick Start Guide Project Flow

#### **Running the Quick Start Example Project**

This section lists the requirements and instructions to power up the AIK-RA4E1 board and run the Quick Start Guide project.

#### **Hardware Requirements**

- AIK-RA4E1 board
- Micro USB device cable
- A PC with at least 1 USB port

#### **Software Requirements**

Windows® 10 operating system

#### 4.1 Connecting and Powering Up the AIK-RA4E1 Board

- 1. Attach the Accelerometer in the PMOD1
- 2. Switch SW4-PMOD1 to IIC
- Connect the micro-USB end of the micro-USB device cable to micro-AB USB Full Speed port (J10) of the AIK-RA4E1 board.
- Connect the other end of this cable to the USB port of the host PC. Power LED (LED2) on the AIK-RA4E1 board lights up blue, indicating that the AIK-RA4E1 board is powered on.

#### 4.2 Running the Quick Start Guide Project

To run the Quick Start Guide project, use the following instructions:

1. On power up or RESET.

Note: The debug LED (LED4) will blink or light up orange; this can be ignored for now.

- 2. LED1 turns green when idle.
- 3. Lightly move the board and LED1 turns Cyan, movement detected.
- 4. Fast move down the board and LED1 turns Red, drop movement detected.
- 5. Shake the board and LED1 blinks all colors, wave movement detected.
- 6. Rotate the board with ETH connector down LED1 turns yellow, circle movement detected.

#### 5. Customizing the Quick Start Guide Project

This section lists the requirements and instructions for customizing the AMR project.

#### **Hardware Requirements**

- AIK-RA4E1 board
- Renesas ICM-42670-P PMOD Board
- · Micro USB device cable
- · A PC with at least 1 USB port

#### **Software Requirements**

- Windows® 10 operating system
- e2 studio IDE
- FSP
- AMR project

#### 5.1 Downloading and Installing Software and Development Tools

Before the Quick Start example project can be modified, it is necessary to download and install software and development tools on the host PC.

The FSP, J-Link USB drivers, and e2 studio are bundled in a downloadable platform installer available on the FSP webpage at <a href="renesas.com/ra/fsp">renesas.com/ra/fsp</a>. New users are recommended to use the **Quick Install** option provided in the installation wizard, to minimize the amount of manual configuration needed.

There is no need to download and install software, development tools, and drivers separately.

#### 5.2 Downloading and Importing the Quick Start Example Project

- Download and extract the AMR project to a local directory on the host PC.
  - a. The AMR project (source code and project files) is available in https://github.com/renesas/aiot-ready
  - b. Download the AMR project to a local directory on the host PC.
- 2. Launch e2 studio.
- 3. Browse to the Workspace where the project file is to be imported. Enter the name in the Workspace dialog box to create a new workspace.




Figure 4. Creating a New Workspace

4. Click Launch.




Figure 5. Launching the Workspace

5. Click Import from the File drop-down menu.




Figure 6. Importing the Project

6. In the Import dialog box, select General, and then select Existing Projects into Workspace.




Figure 7. Importing Existing Projects into the Workspace

7. Click Next.




Figure 8. Clicking Next to Import Existing Projects into the Workspace

8. Click **Select root directory** and click **Browse** to go to the location of the Quick Start example project folder.




Figure 9. Selecting the Root Directory

9. Select the Quick Start Guide project and click Finish.




Figure 10. Finishing Importing the Quick Start Guide Project

#### 5.3 Modifying, Generating, and Building the Quick Start Guide Project

This section provides instructions to modify the AMR project. The AMR project can be modified by editing the source code and reconfiguring the properties of the MCU peripherals, pins, clocks, interrupts, and so forth.

Note: The specific modifications that can be performed to the AMR project are not prescribed in this QSG. User discretion is advised while modifying the AMR project.

Once AMR project is imported, click the configuration.xml file to open the configurator. The configurator
provides an easy-to-use interface to configure the properties of MCU peripherals, pins, clocks, and so
forth.




Figure 11. Opening the Configurator

 For example, in the **Stacks** tab of the configurator, the user can click to select modules to modify the configuration settings, as required. The following screen shot illustrates modifying the I2C Communication Device configuration.




Figure 12. Modifying the Configuration Settings

3. After the desired modifications are made, click **Generate Project**. A dialog box may appear with an option of saving the configuration changes. Click **Proceed**.




Figure 13. Saving the Configuration Changes

- 4. Modify the source files in the /src folder as needed and save the changes.
- 5. Build the project by clicking the build icon.

#### 5.4 Setting Up Debug Connection between the AIK-RA4E1 board and Host PC

To program the modified AMR project on to the AIK-RA4E1 board, a debug connection is necessary between the AIK-RA4E1 board and host PC.

- 1. Connect the USB cable in the micro-B USB debug port (J10) of the AIK-RA4E1 board.
- 2. Verify that the debug LED (LED4) stops blinking and lights up orange indicating that the J-Link drivers are detected by the AIK-RA4E1 board.

Note: The debug LED (LED4) continues to blink when J-Link drivers are not detected by the AIK-RA4E1 board. In that case, make sure that the AIK-RA4E1 board is connected to the host PC through the micro-B USB debug port (J10) and that J-Link drivers are installed on the host PC by checking in the Windows Device Manager (expand **Universal Serial Bus controller**, and locate **J-Link driver**)

1. In e2 studio, click the drop-down menu for the debug icon, select Debug As option, and choose Renesas GDB Hardware Debugging.




Figure 17. Selecting the Debug Option

2. A dialog box may appear. Click Yes.




Figure 18. Opening the Debug Perspective

4. The modified AMR project is programmed into the AIK-RA4E1 board and is running. The project can be paused, stopped, or resumed using the debug controls.
