This sample program may include operations of unused bit functions for the convenience of the SFR bit layout. Set the values according to the operational conditions of the user system.

### 3.1 Pulse Width Measurement

Outline: Timer X counts the "H" width of the pulses input to the P54/CNTR0 pin in the pulse width measurement mode.
Specifications:

- Timer X counts the "H" width of the pulses input to the P54/CNTR0 pin. The initial value of timer X is 65535 .
- Measurable values of timer X range from 65535 to 0 .
- Error processing is executed when timer X is in underflow status and " H " width cannot be measured.
- The end of the input pulse " H " is detected by the CNTR0 interrupt.
