#### 3.1 Method 1 for interrupt handling

- 1. Modify interrupt vector table in the Startup file (cstratup.s31) and replace the default function name (init C) with interrupt function name. The interrupt vector table lists the interrupt source access address which individual MCU has.
- 2. Declare interrupt function by "interrupt" command in C language source program.
