4. 操作

(1) 如果选择软件触发,将软件 DMA 请求位置"1",就产生一次 DMA 请求。

(2) 如果允许 DMAC,当数据传输时开始,由 DMAi 正向地址指针所指向的地址的内容被传送到由 DMAi 目标指针所指向的地址处。如果 DMAC 允许后,就开始数据传送,DMAi 传送计数器内的值将被重新加载到 DMAi 重加载传送计数器内,同时 DMAi 源指针被重新加载到 DMAi 正向地址指针内。每产生一次 DMA 请求,就传送两个字节的数据。DAMi 传送计数器进行减计数,DMAi 的正向地址指针进行加计数。

(3) 即便 DMAi 传送计数器发生下溢, DMAi 传送允许位仍然为"1"。同时, DMA 中断请求位置"1"。

(4) DMA 传送计数器下溢后,如果发生下一次 DMA 请求,就从(1)重新开始 DMA 传送。





图 1. 单次传送模式时的工作时序图




