## 定时器 A 操作(脉宽调制模式、8 位 PWM)

### 1. 要点

在 PWM 模式中,可以选择如表 1 中所列的各种功能。在表 1 中用符号"〇"表示本篇资料所选的项目,图 1 是定时器的工作时序图。本篇资料的参考例程是定时器 A1 选择 PWM 模式的例子。

## 2. 说明

本篇资料,适用于 M16C/65 群单片机。

本篇应用说明也适用于 M16C 族中与上面所述的群具有相同 SFR(特殊功能寄存器)定义的产品。关于产品功能的改进,请参看手册中的相关信息。在使用本篇应用说明的程序前,需进行详细的评价。

#### 4. 定时器 A 的操作

- (1) 当 TAilN 引脚输出电平由"高"变为"低",并且把计数开始标志位置为"1"时,计数器开始对计数脉冲源的下降沿计数。同时,TAiouT 引脚输出"高"电平。
- (2) 计数经过预设的周期长度之后,TAiouT 引脚输出电平从"高"变为"低"。同时,定时器 Ai 中断请求位置为"1"。
  - (3) 每次在 PWM 输出一个周期之后, 重加载寄存器的设定值被加载到计数器, 计数器继续进行计数。
  - (4) 把计数开始标志位置为"0",计数器停止计数,并且保持当前值。同时,TAiouT输出"低"电平。 注意.

PWM 周期为(m + 1) X ( $2^8$  – 1) / fi,高电平宽度为 n X (m + 1) / fi。如果定时器 Ai 寄存器的高 8 位值被设定为 "00h", PWM 功能不会工作,并且 TAioUT 引脚输出电平为 "L", 因此定时器 Ai 中断请求也不会产生。

(fi: 计数源频率 f1TIMAB/f2TIMAB/f8TIMAB/f32TIMAB/f64TIMAB/foco-s/fc32

m: 定时器 Ai 寄存器的低 8 位值 n: 定时器 Ai 寄存器的高 8 位值)

触发发生后,TAiout 引脚输出一段与所设的 PWM 高电平宽度相同的低电平,然后开始 PWM 输出。



选择 PWM 模式的定时器工作时序图如下所示:




图 1. 选择 PWM 模式定时器的工作时序图






图 2. 定时器 A 的计数源




