Utilising the Serial Array Unit (SAU) in Sync Mode Sample Code Oct 12, 2012 for Cubesuite+

Introduction

The purpose of this Application Note is to show the user how to add the associated RL78/G14 sample code to a new or existing CubeSuite+ workspace; as well as give an explanation of what the sample code does.

The sample code provided with this Application Note demonstrates usage of the Serial Array Unit (SAU) in synchronous mode. The program runs on the RL78/G14 Renesas Starte Kit (RSK) and performs a loop back test between two SAU channels.




1. Installation

This section assumes CubeSuite+ IDE is already installed on the user's personal computer (PC). Create a new folder and name it as 'RSKRL78G14_Workspace'. Copy the zipped file Sync_Serial.zip, available in the Application Note package downloaded from the website, to this folder. Extract the Sync_Serial.zip file to the RSKRL78G14_Workspace folder.

2. Creating the Project Workspace

Open CubeSuite+ IDE by clicking the Windows Start button, select All Programs > Renesas Electronics CubeSuite+ > CubeSuite+.





From the menu bar select File > Project > Open Project...



CubeSuite+ will open a dialog.


Navigate to the unzipped Sync_Serial folder located in RSKRL78G14_Workspace.

Select the Sync_Serial.mtpj file.

Click <Open>.



A Progress Status dialog will appear briefly whilst CubeSuite+ loads the project.



3. Opening Sample Code and Source Files

Once the project has been opened, the source code and all dependant files can be opened in the editor by expanding the folders in the Project Tree window and double clicking the files listed. All files have been grouped according to their file type.



4. Source Code Functionality

The source code project is specifically written to run on the appropriate RSK. However this source code can be useful as an example even without the RSK.

The project was written using source files containing API functions generated using Code Generator. The project will contain a C source file 'r_main.c'. This source file includes the C function main(). All source files and dependant files whose filenames are prefixed with 'r_' were generated using Code Generator.

5. Code Execution

Before starting, configuration is set:

Wire Connections

JA2, pin 13 (SCL20) to J2, pin 15 (SCL21)

JA2, pin 14 (SI20) to J2, pin 13 (SO21)

JA2, pin 15 (SO20) to J2, pin 14 (SI21)

1. Build and download the sample code to the RSK.

2. Right click the variable gCSI20_RXBuffer and select 'Register to Watch 1'. Do the same for the variable

gCSI20_TXBuffer, gCSI21_RXBuffer and gCSI21_TXBuffer.

3. Click the 'Resume' button to start the program execution. The name of the sample will be displayed on the debug LCD.

4. The sample will then begin the data transfer. When the SAU activity is complete, the second line of the debug LCD will display either "Success" or "Failure".

5. You can observe the contents of gCSI20_RXBuffer being filled

with the contents of gCSI21_TXBuffer. The contents should match. The same should be done regarding gCSI20_TXBuffer and gCSI21_RXBuffer.

6. If the debug LCD reports "Failure", or shows "CSI0 Err" or "CSI1 Err" without changing; check the configuration specified is set and click on the "Restart" button to start again.

General Precautions in the Handling of MPU/MCU Products

The following usage notes are applicable to all MPU/MCU products from Renesas. For detailed usage notes on the products covered by this manual, refer to the relevant sections of the manual. If the descriptions under General Precautions in the Handling of MPU/MCU Products and in the body of the manual differ from each other, the description in the body of the manual takes precedence.

- 1. Handling of Unused Pins
 - Handle unused pins in accord with the directions given under Handling of Unused Pins in the manual.
 - The input pins of CMOS products are generally in the high-impedance state. In operation with an unused pin in the open-circuit state, extra electromagnetic noise is induced in the vicinity of LSI, an associated shoot-through current flows internally, and malfunctions occur due to the false recognition of the pin state as an input signal become possible. Unused pins should be handled as described under Handling of Unused Pins in the manual.
- 2. Processing at Power-on

The state of the product is undefined at the moment when power is supplied.

 The states of internal circuits in the LSI are indeterminate and the states of register settings and pins are undefined at the moment when power is supplied.

In a finished product where the reset signal is applied to the external reset pin, the states of pins are not guaranteed from the moment when power is supplied until the reset process is completed. In a similar way, the states of pins in a product that is reset by an on-chip power-on reset function are not guaranteed from the moment when power is supplied until the power reaches the level at which resetting has been specified.

- 3. Prohibition of Access to Reserved Addresses
 - Access to reserved addresses is prohibited.

The reserved addresses are provided for the possible future expansion of functions. Do not access
these addresses; the correct operation of LSI is not guaranteed if they are accessed.

4. Clock Signals

After applying a reset, only release the reset line after the operating clock signal has become stable. When switching the clock signal during program execution, wait until the target clock signal has stabilized.

 When the clock signal is generated with an external resonator (or from an external oscillator) during a reset, ensure that the reset line is only released after full stabilization of the clock signal. Moreover, when switching to a clock signal produced with an external resonator (or by an external oscillator) while program execution is in progress, wait until the target clock signal is stable.

5. Differences between Products

Before changing from one product to another, i.e. to one with a different type number, confirm that the change will not lead to problems.

— The characteristics of MPU/MCU in the same group but having different type numbers may differ because of the differences in internal memory capacity and layout pattern. When changing to products of different type numbers, implement a system-evaluation test for each of the products.
