2.0 Introduction


Specifications (1) Inputting a falling edge to the TAO_{IN} pin generates a timer A0 interrupt.

- (1) Set timer A0 to event counter mode, set timer to "0", and set interrupt priority levels in timer A0.
- (2) Inputting a falling edge to the $\mathsf{TA0}_{\mathsf{IN}}$ pin generates a timer A0 interrupt.
