1. About QE for TCP/IP

1.1 Summary

QE for TCP/IP is a dedicated solution tool for applications that employ TCP/IP. It is intended to shorten development times of embedded systems incorporating the M3S-T4-Tiny software library (hereafter referred to as the T4 library) for these communications protocols on RX-family products which are suitable for TCP/IP.

This product is an extension plugin for the e^2 studio integrated development environment. That is, the product is for use after being installed under the e^2 studio.

2. Installation and Uninstallation

2.1 Installing This Product

Use the following procedure to install this product.

- 1. Start e² studio V4.2.0 (or later).
- 2. From the [Help] menu, select [Install New Software...] to open the [Install] dialog box.
- 3. Click the [Add...] button to open the [Add Repository] dialog box.
- 4. Click the [Archive] button, select the zip file for installation in the opened dialog box, and click the [Open] button.
- 5. Click the [OK] button in the [Add Repository] dialog box.
- 6. Select the [Renesas QE for TCP/IP] check box displayed in the [Install] dialog box and click the [Next] button.
- 7. Check that [Renesas QE for TCP/IP] is selected as the target of installation, and click the [Next] button.
- 8. After confirming the license agreements, select the [I accept the terms of the license agreements] radio button, and click the [Finish] button.
- 9. A security warning message will appear; click the [OK] button to continue installation.
- 10. If the dialog of the trust certificate is displayed, check that certificate, and click the [OK] button to continue installation.
- 11. When prompted to restart e² studio, restart it.

2.2 Uninstalling This Product

Use the following procedure to uninstall this product.

- 1. Start e² studio.
- 2. Select [Help -> Installation Details] to open the [e2 studio Installation Details] dialog box.
- 3. Select [Renesas QE for TCP/IP] displayed on the [Installed Software] tabbed page and click the [Uninstall...] button to open the [Uninstall] dialog box.
- 4. Check the displayed information and click the [Finish] button.
- 5. When prompted to restart e² studio, restart it.

General Precautions in the Handling of Microprocessing Unit and Microcontroller Unit Products

The following usage notes are applicable to all Microprocessing unit and Microcontroller unit products from Renesas. For detailed usage notes on the products covered by this document, refer to the relevant sections of the document as well as any technical updates that have been issued for the products.

1. Handling of Unused Pins

Handle unused pins in accordance with the directions given under Handling of Unused Pins in the manual.

The input pins of CMOS products are generally in the high-impedance state. In operation with an unused pin in the open-circuit state, extra electromagnetic noise is induced in the vicinity of LSI, an associated shoot-through current flows internally, and malfunctions occur due to the false recognition of the pin state as an input signal become possible. Unused pins should be handled as described under Handling of Unused Pins in the manual.

2. Processing at Power-on

The state of the product is undefined at the moment when power is supplied.

- The states of internal circuits in the LSI are indeterminate and the states of register settings and pins are undefined at the moment when power is supplied.
 - In a finished product where the reset signal is applied to the external reset pin, the states of pins are not guaranteed from the moment when power is supplied until the reset process is completed.
 - In a similar way, the states of pins in a product that is reset by an on-chip power-on reset function are not guaranteed from the moment when power is supplied until the power reaches the level at which resetting has been specified.

3. Prohibition of Access to Reserved Addresses

Access to reserved addresses is prohibited.

 The reserved addresses are provided for the possible future expansion of functions. Do not access these addresses; the correct operation of LSI is not guaranteed if they are accessed.

4. Clock Signals

After applying a reset, only release the reset line after the operating clock signal has become stable. When switching the clock signal during program execution, wait until the target clock signal has stabilized.

When the clock signal is generated with an external resonator (or from an external oscillator) during a reset, ensure that the reset line is only released after full stabilization of the clock signal. Moreover, when switching to a clock signal produced with an external resonator (or by an external oscillator) while program execution is in progress, wait until the target clock signal is stable.

5. Differences between Products

Before changing from one product to another, i.e. to a product with a different part number, confirm that the change will not lead to problems.
