These three (3) test facilities are qualified as primary test supplier to Intersil for high volume of Quad Flat No-Lead (QFN) packaged products.

Impact on fit, form, function, quality & reliability:

The following summarizes the qualification of KESM, UNM and UTL facility to confirm there is no impact on the form, fit, function, quality, reliability and environmental compliance of the devices.

- Intersil supplied test software and product specific hardware were used at KESM, UNM, and UTL.
- The test equipment validation involved the testing of ISL95812HRZ-T at the KESM, UNM and UTL facility.
 - Continuous monitoring and comparison of the data from lots processed at multiple sites were completed by the responsible product engineers.
- The visual / mechanical inspection, tape & reel operations are compliance to JEDEC industry standards.
