B) Description of Operating Precautions

No.1	When PTP is set to 1-Step Mode Ethernet reception does not work	
	When the PTP module is set to one step mode by setting the ONE_STEP mode bit in the PTP_Config_n register the RXCLK is inverted to its normal operation. Thus MII data is output from the device at the same time the valid clock edge changes and data is latched by the MAC just when the data value is changing leading to corrupted reception.	
	Workaround For evaluation purposes it is possible to connect the TXCLK signal instead of the RXCLK signal to the MAC. However this results in a slightly increased Bit Error Rate and must not be used in Mass Production devices.	

No. 2	In RMII mode received data may be corrupted	
	<u>Details</u> The RMII interface may receive corrupted data due to an issue in the internal MII/RMII converter.	
	Workaround Do not use the RMII interface in production devices. For evaluation purpose note that some frames may get lost or received with a faulty CRC.
