DESCRIPTION


The PS2514-1 and PS2514L-1 are optically coupled isolator containing a GaAs light emitting diode and an NPN silicon phototransistor, enabling relatively high switching speed with high load resistor of several $k\Omega$. The PS2514-1 is in a plastic DIP (Dual In-line Package) and the PS2514L-1 is lead bending type (Gull-wing) for surface mount.





Lead Bending Type For Surface Mount








FORWARD CURRENT vs. FORWARD VOLTAGE




COLLECTOR TO EMITTER DARK CURRENT vs. AMBIENT TEMPERATURE






COLLECTOR CURRENT vs. **COLLECTOR TO EMITTER VOLTAGE**




COLLECTOR CURRENT vs. **COLLECTOR SATURATION VOLTAGE**




Collector Saturation Voltage VCE (sat) (V)






SWITCHING TIME vs. LOAD RESISTANCE




TURN-ON TIME vs. AMBIENT TEMPERATURE





CURRENT TRANSFER RATIO vs. FORWARD CURRENT






AMBIENT TEMPERATURE











Outline and Dimensions (Tape)







Dependence of maximum safety ratings with package temperature




Method a) Destructive Test, Type and Sample Test
