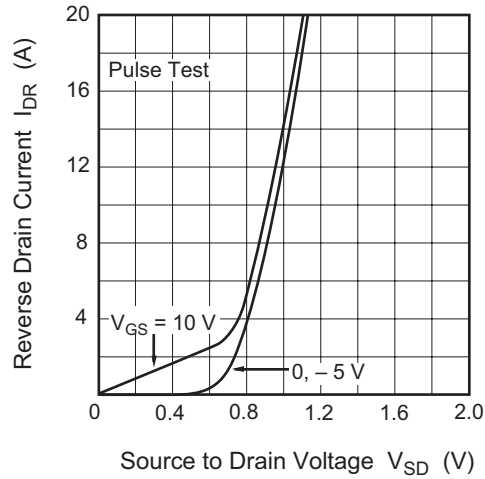

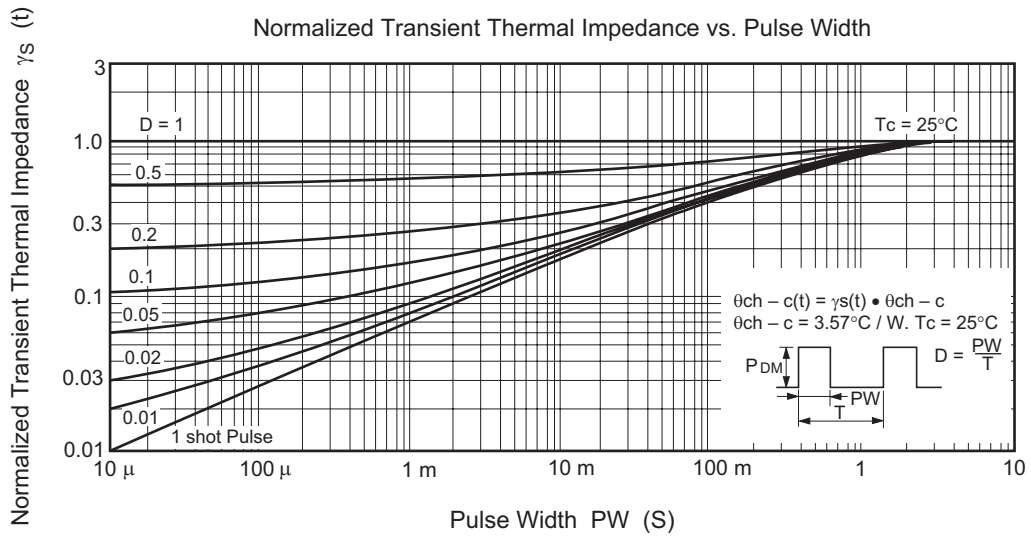




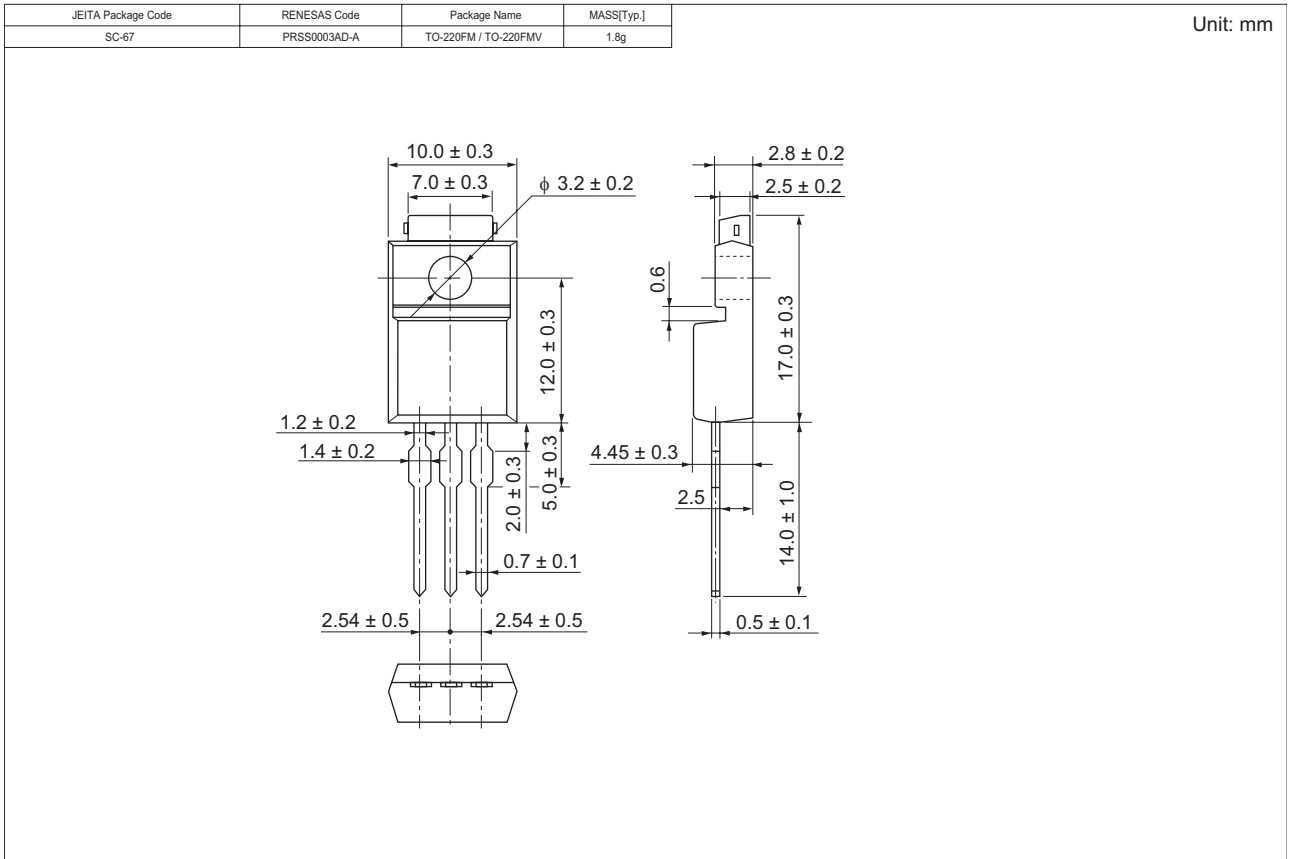
Reverse Drain Current vs. Source to Drain Voltage
