Main Characteristics



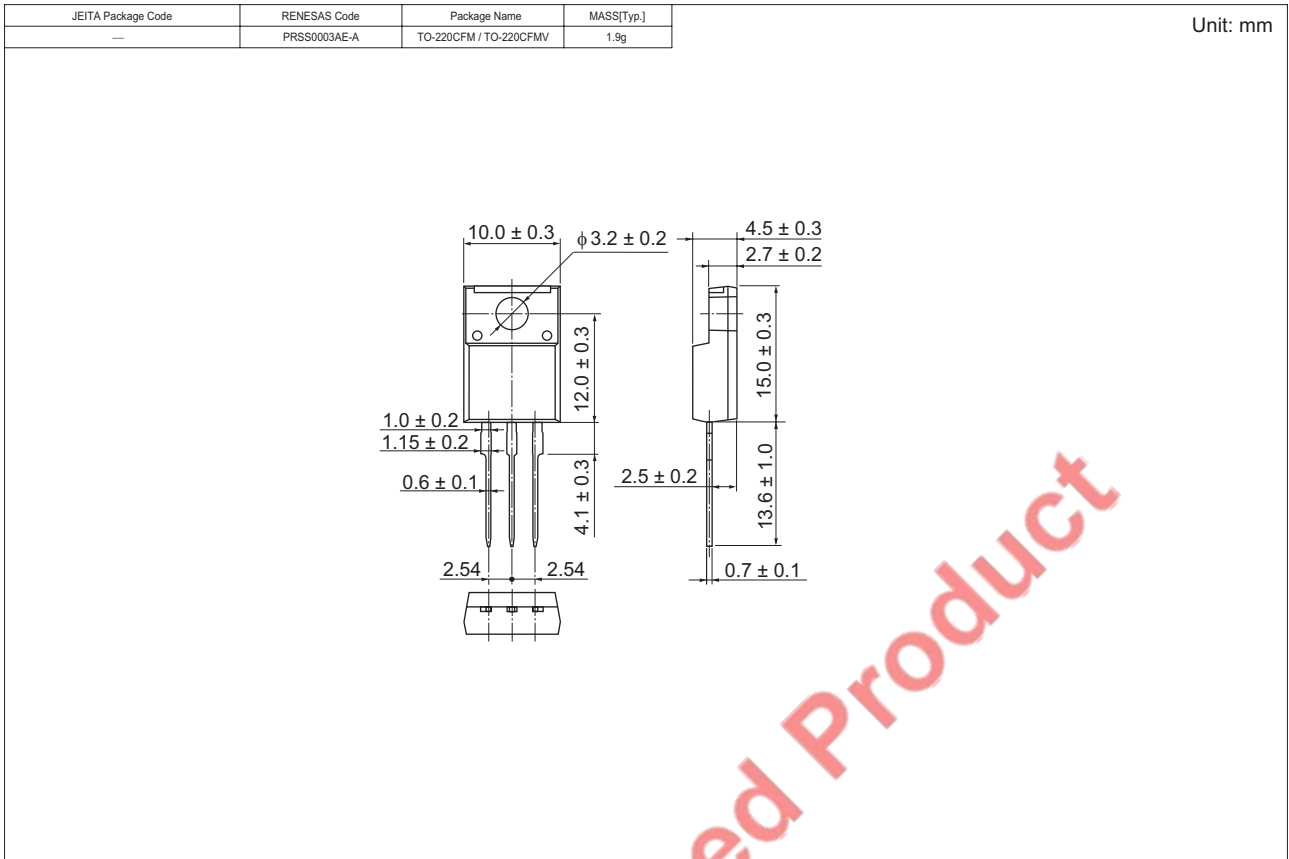
