Description

The HD74LV2GT240A has dual bus buffer inverted with 3-state output in an 8 pin package. Two inverters are included in one circuit. Each circuit can be independently controlled by the enable signal $\overline{1OE}$ or $\overline{2OE}$, which enables outputs when receiving a low-level signal. The input protection circuitry on this device allows over voltage tolerance on the input, allowing the device to be used as a logic-level translator from 3.0 V CMOS Logic to 5.0 V CMOS Logic or from 1.8 V CMOS logic to 3.0 V CMOS Logic while operating at the high-voltage power supply. Low voltage and high-speed operation is suitable for the battery powered products (e.g., notebook computers), and the low power consumption extends the battery life.

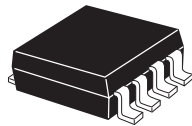

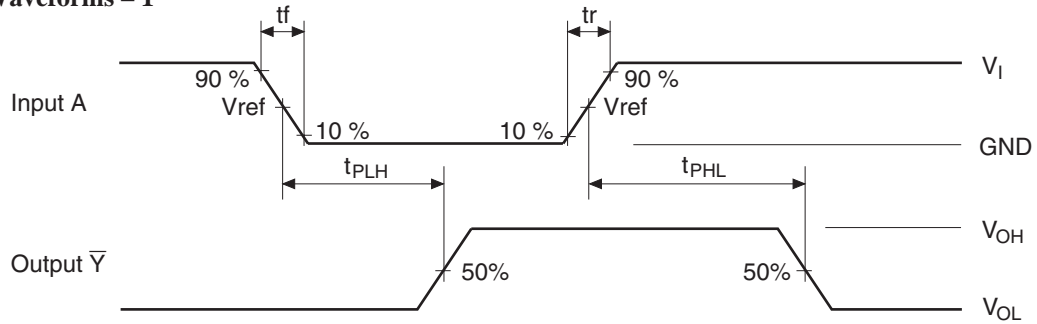

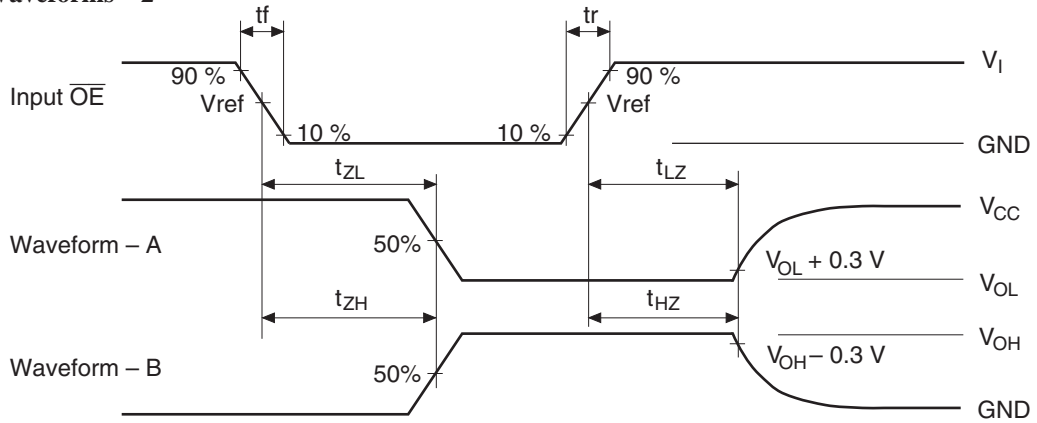

• Waveforms – 1



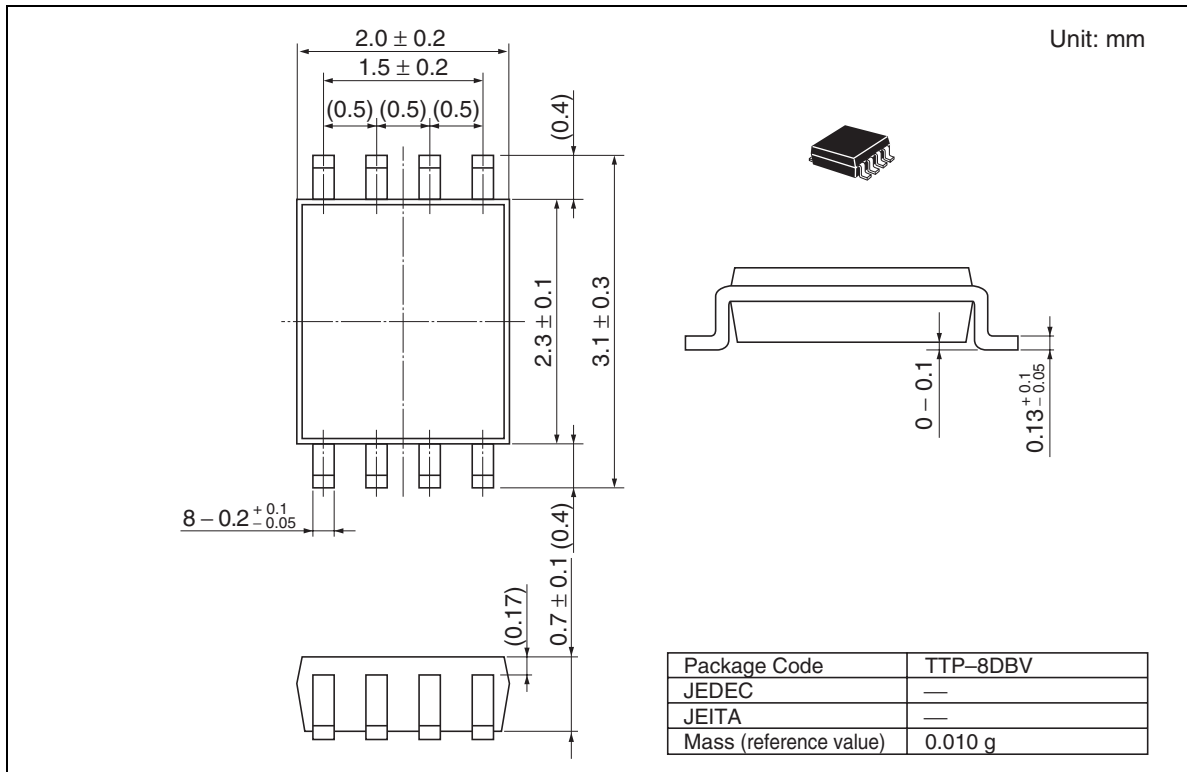
