DESCRIPTION

The PS2381-1 is an optically coupled isolator containing a GaAs light emitting diode and an NPN silicon phototransistor. This package is mounted in a plastic 4-pin LSOP (<u>L</u>ong Mini-Flat <u>S</u>mall <u>O</u>utline <u>P</u>ackage) for high density applications. The package has shield effect to cut off ambient light.
















COLLECTOR TO EMITTER DARK **CURRENT vs. AMBIENT TEMPERATURE**




TRANSISTOR POWER DISSIPATION vs. AMBIENT TEMPERATURE



COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE




COLLECTOR CURRENT vs. **COLLECTOR SATURATION VOLTAGE**




NORMALIZED CURRENT TRANSFER RATIO vs. AMBIENT TEMPERATURE




SWITCHING TIME vs. LOAD RESISTANCE




CURRENT TRANSFER RATIO vs. FORWARD CURRENT




NORMALIZED CURRENT TRANSFER RATIO vs. AMBIENT TEMPERATURE



SWITCHING TIME vs. LOAD RESISTANCE







2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between collector-emitters at startup, the output transistor may enter the on state, even if the voltage is within the absolute maximum ratings.

3. Measurement conditions of current transfer ratios (CTR), which differ according to photocoupler Check the setting values before use, since the forward current conditions at CTR measurement differ according to product.

When using products other than at the specified forward current, the characteristics curves may differ from the standard curves due to CTR value variations or the like. Therefore, check the characteristics under the actual operating conditions and thoroughly take variations or the like into consideration before use.






