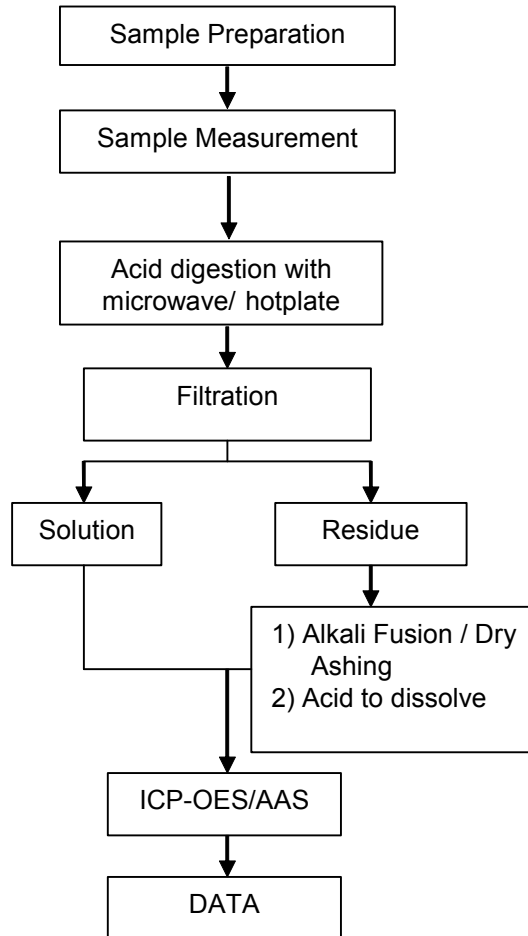

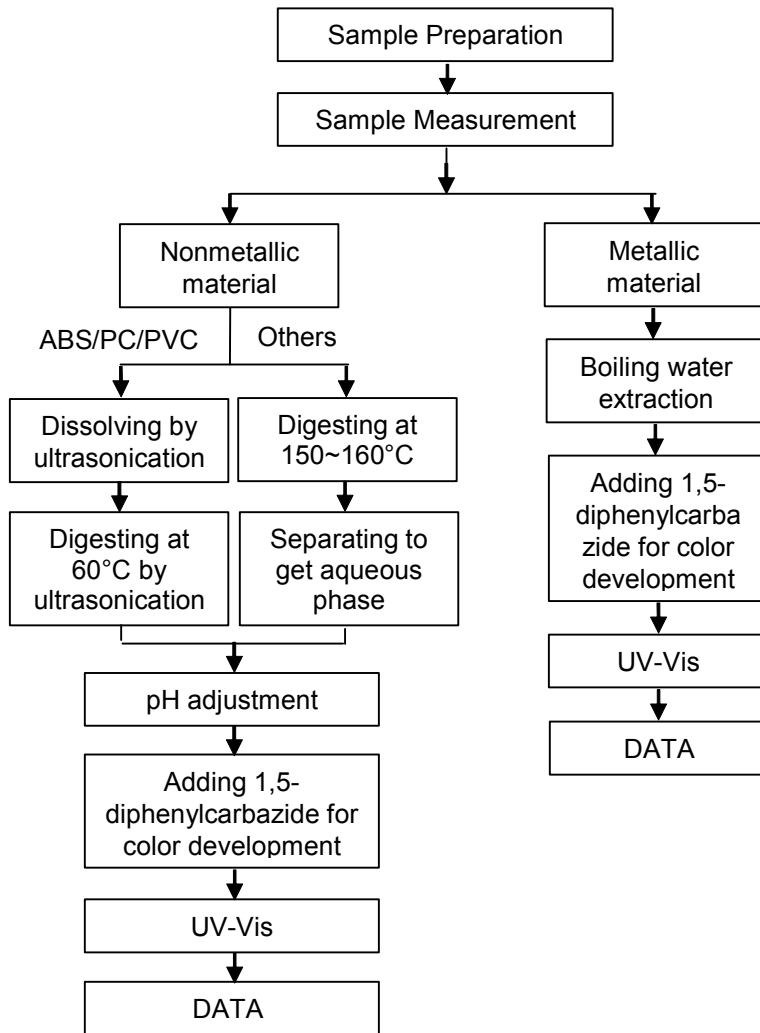

Hexavalent Chromium (Cr(VI)) Testing Flow Chart

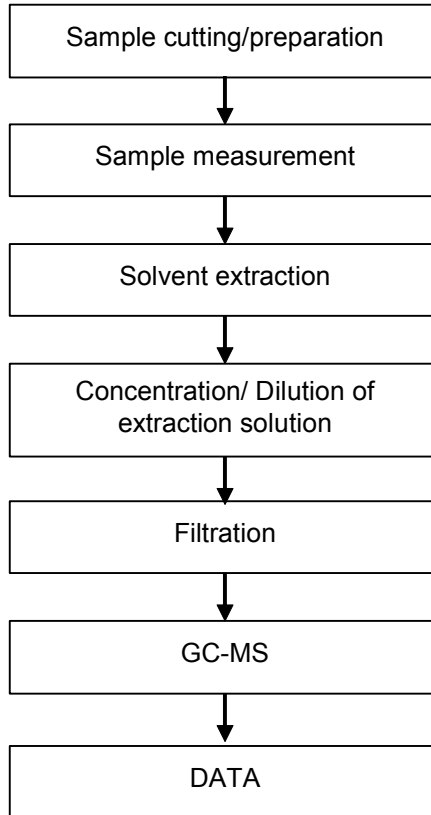

**PBBs/PBDEs Testing Flow Chart**

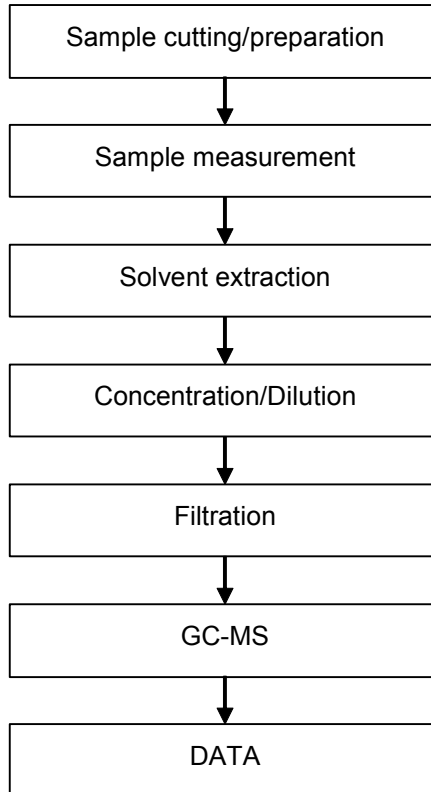

### Phthalates Testing Flow Chart

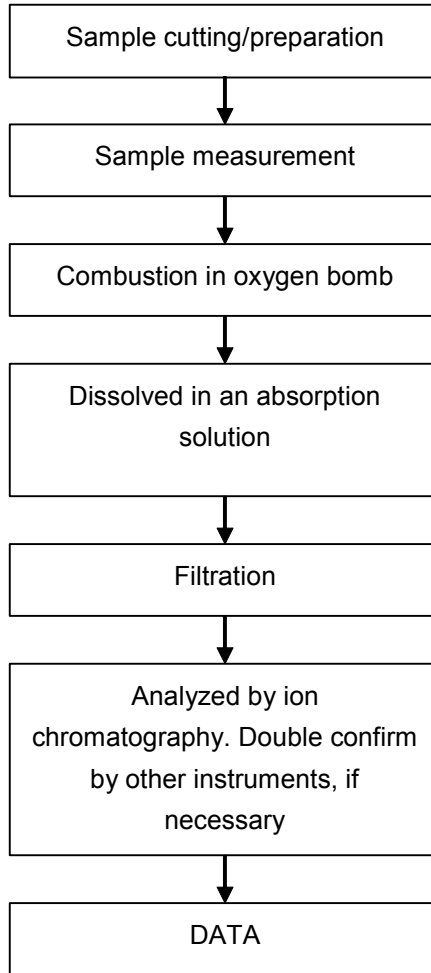

### Halogen Testing (oxygen bomb) Flow Chart

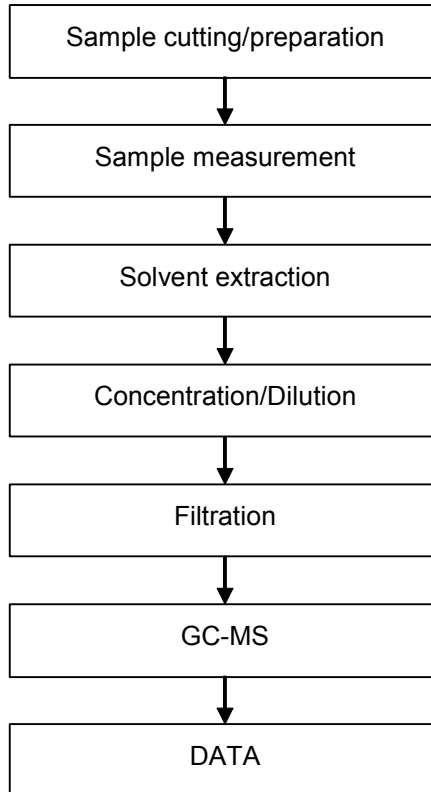

### HBCDD Testing Flow Chart

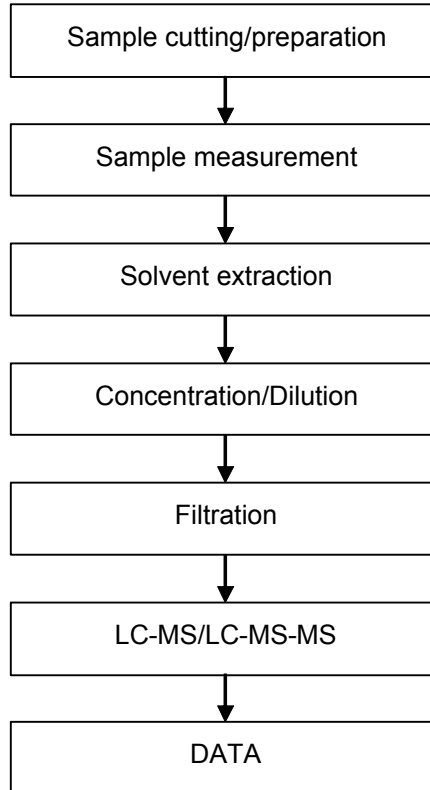

**PFOS/PFOA Testing Flow Chart**

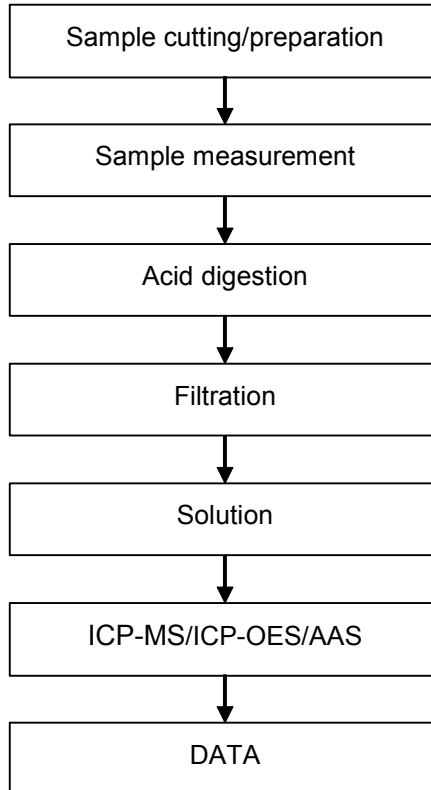

### Elements Testing Flow Chart

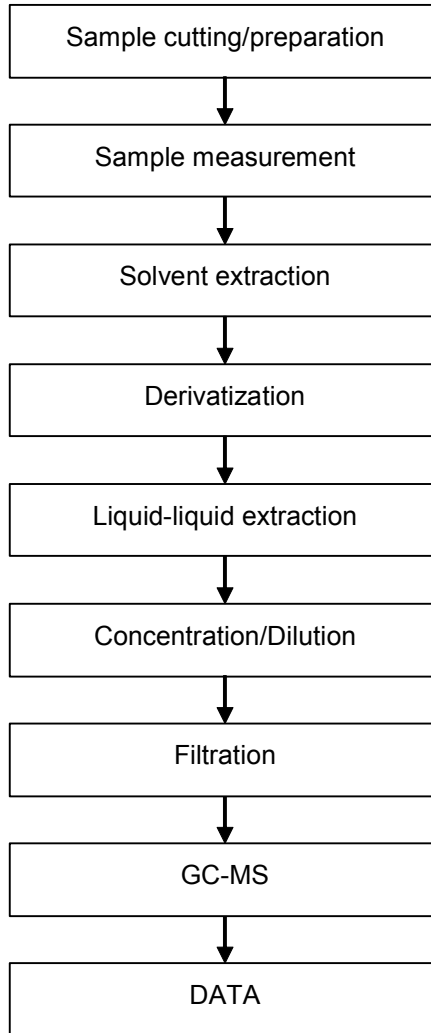

Organotin Testing Flow Chart

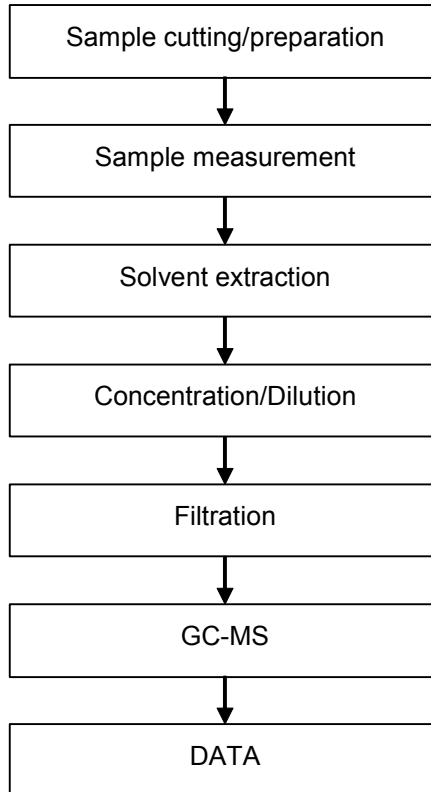

### PCB Testing Flow Chart

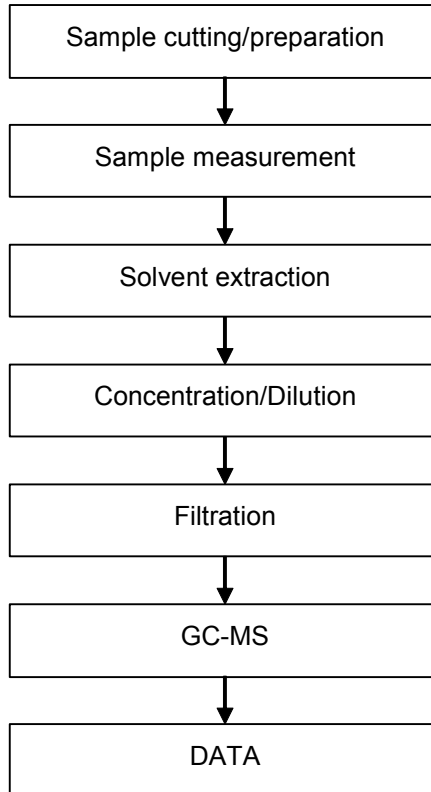

PCN Testing Flow Chart

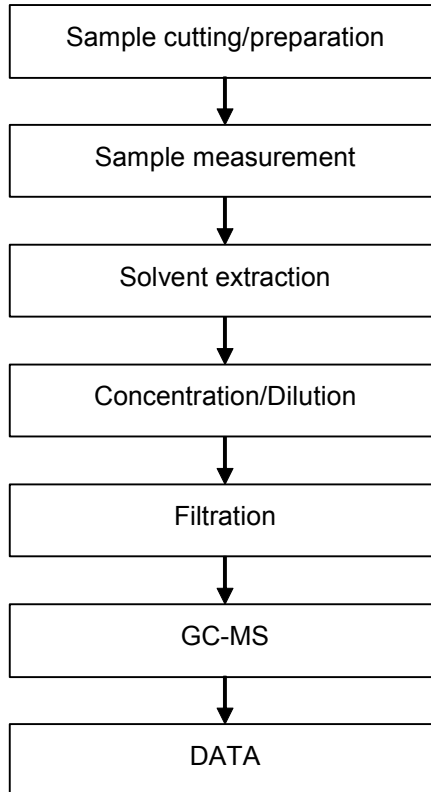

PCT Testing Flow Chart

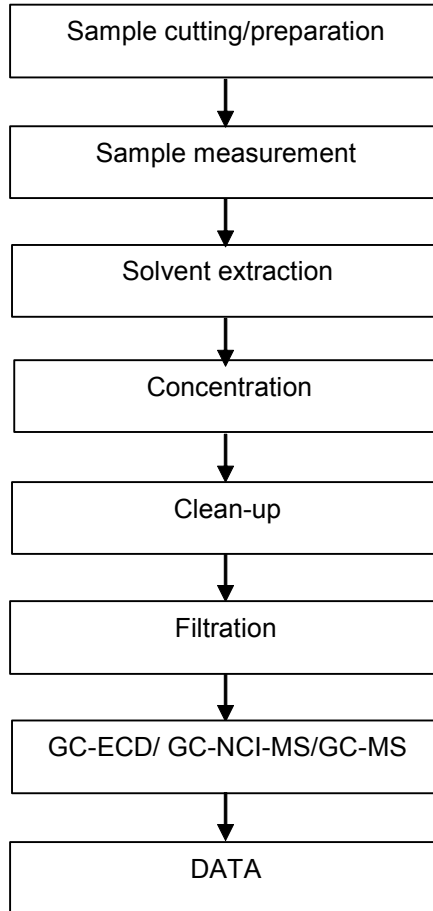
