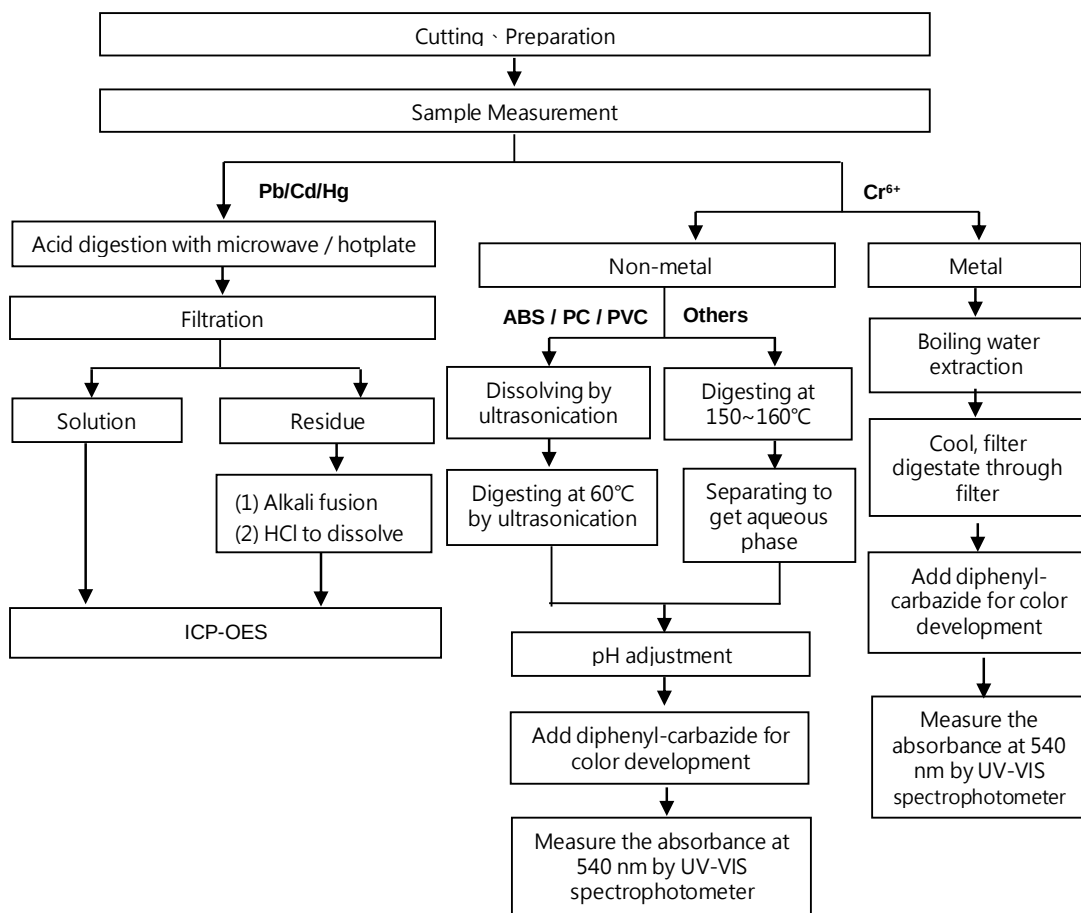

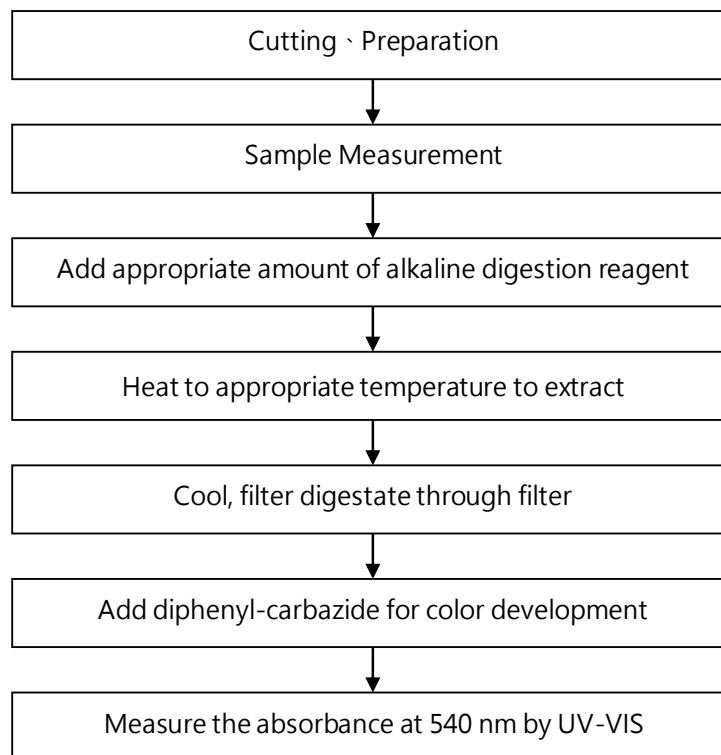
Analytical flow chart of Heavy Metal

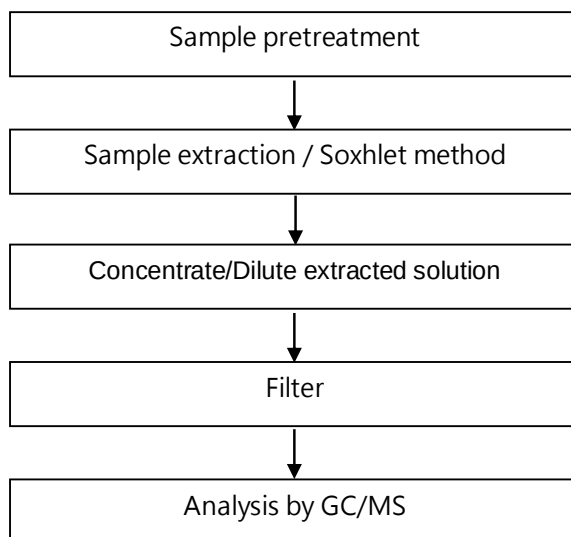

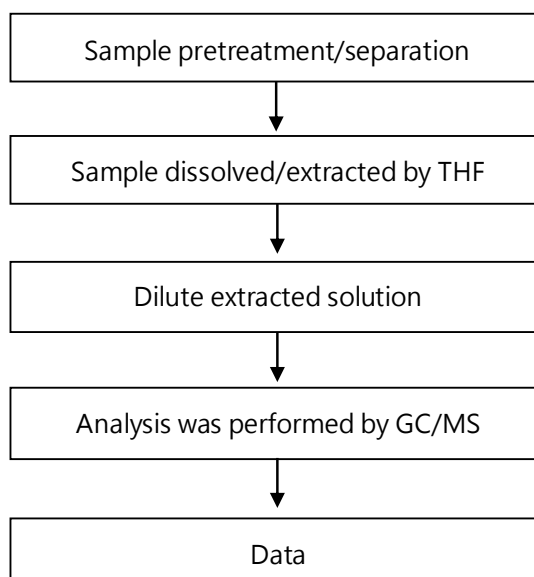
PBB/PBDE analytical FLOW CHART

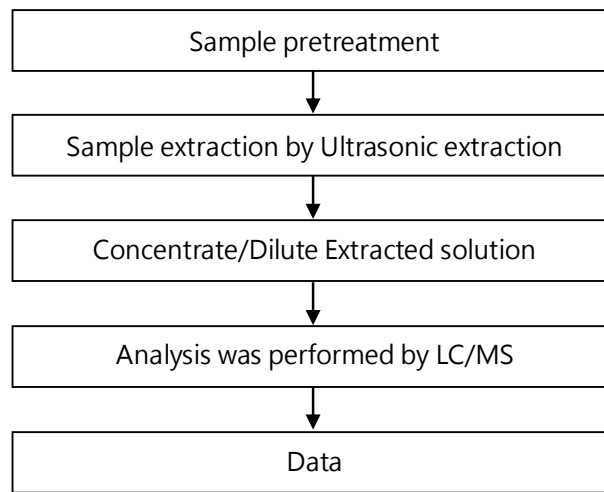

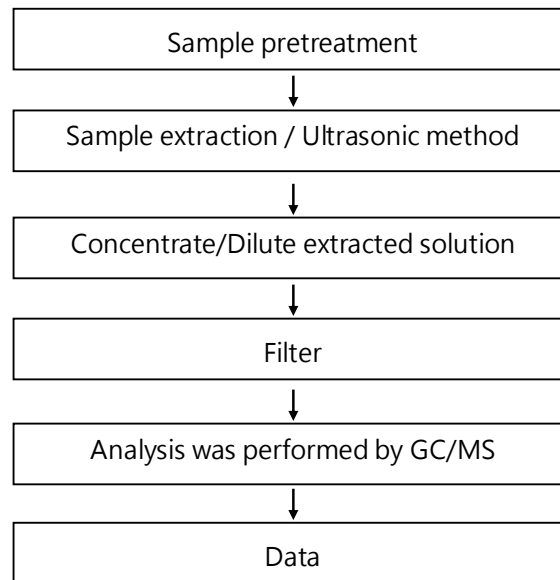

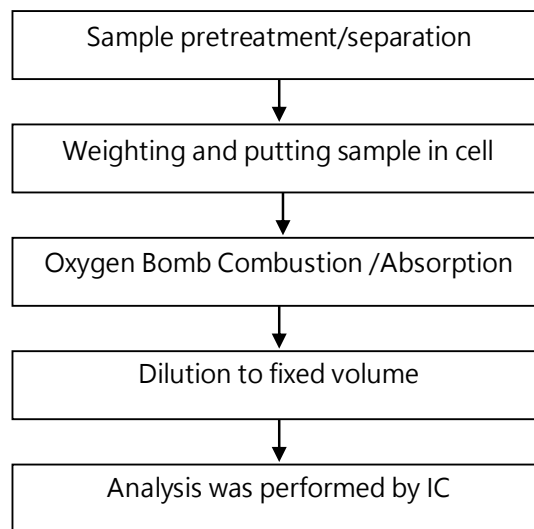

Analytical flow chart of Halogen

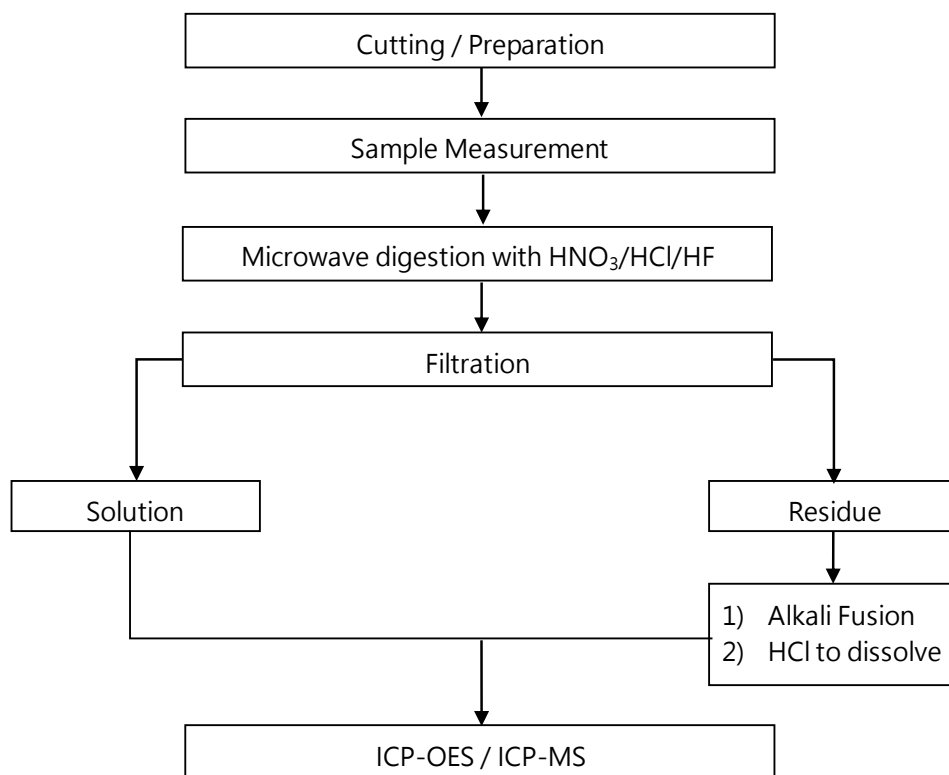

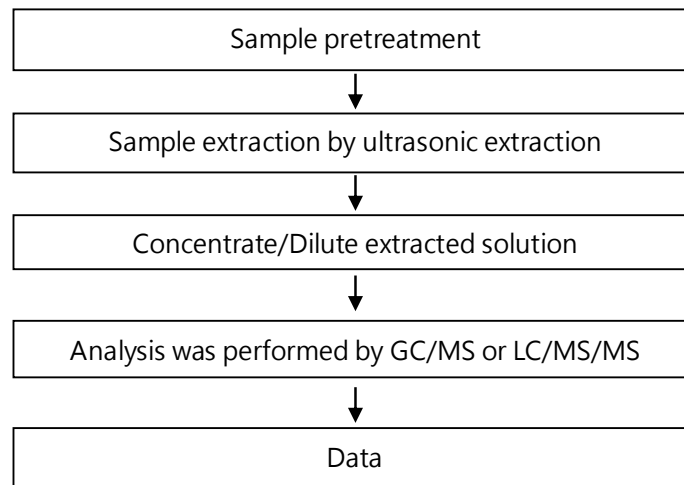

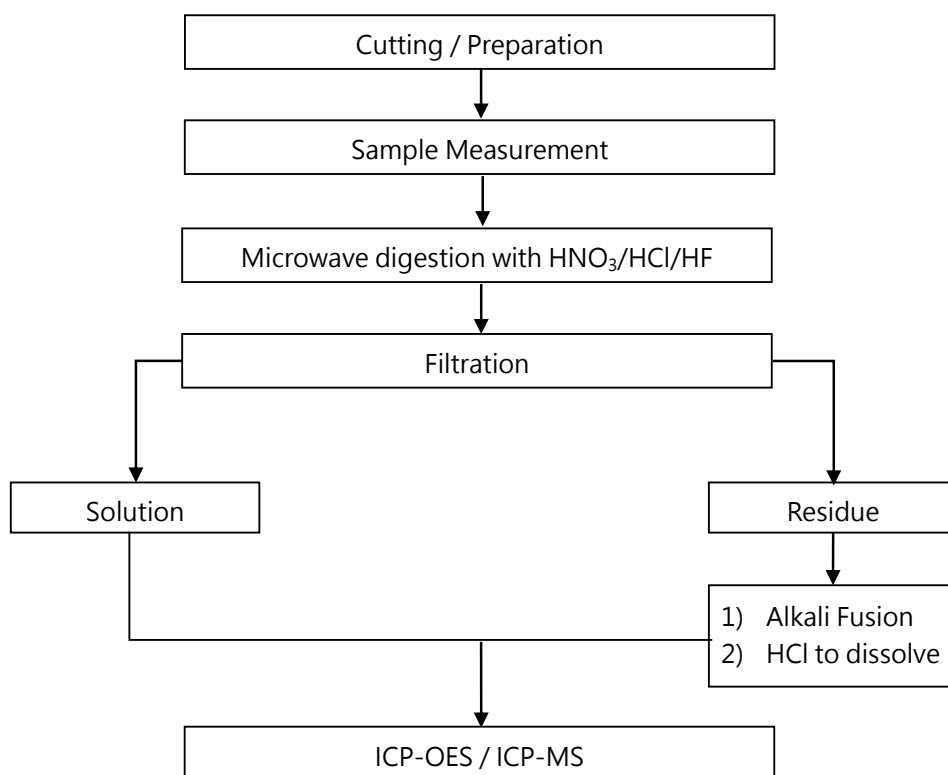
