Confirmation methods

The following two confirmation methods are available:


Method A

Check versions of toolchains which are registered in High-performance Embedded Workshop as components. If you have installed several compiler packages on your PC, there may be possible that several versions of the toolchains exist. You can check versions of the toolchains registered in High-performance Embedded Workshop, which you are currently using.

Method B

Check a version of toolchains which is currently being used to create Highperformance Embedded Workshop project.

You can check a version of toolchains, which are currently being used to create project in High-performance Embedded Workshop.






Method A

To check versions of toolchains registered in High-performance Embedded Workshop, which you are currently using:

- 1. Select [Tools] from Highperformance Embedded Workshop tool bar.
- 2. Select [Administration] from the pop-up menu.







Method A (Cont.)

- 3. The [Tools Administration] window is started up. This window shows a list of the components which are registered in High-performance Embedded Workshop you are currently using.
- 4. Click [Toolchains] in the components list.

SuperH RISC engine Standard Toolchain Ver.7.1.2.0 H8S, H8/300 Standard Toolchain Ver.5.0.2.0







Method B
