Exchange Adapter for Connecting RH850/E1x Series in 252-pin 0.8-mm-pitch BGA

1. Outline

The RTE7701202CBG252T000J is an exchange adapter (EA) for connecting the RTE7701202EPA00000J emulator pod for the RH850/E1x (subsequently referred to as the pod) to pad patterns for a 252-pin 0.8-mm-pitch BGA (PRBG0252GB-A).

2. Package Components

Check to see if the RTE7701202CBG252T000J package has all the following contents with reference to Contents of the Package included in the package after purchasing this product.

- (1) RTE7701202CBG252T000J exchange adapter 1 pc.
- (2) Table of Toxic and Hazardous Substance and Elements 1 sh.

4. Usage (See Figure 2)

The RTE7701202CBG252T000J can be used for debugging and on-board evaluation in common by mounting the TC on the target system.

(1) For debugging

Mount the TC on the pad pattern for the MCU on the target system board. In addition, connect the RTE7701202CBG252T000J to the pod, and then attach the RTE7701202CBG252T000J above the TC. The height of the socket is adjustable by inserting the SA1 or SA2 between the TC and RTE7701202CBG252T000J if this is desired.

(2) For on-board evaluation

The TC on the user system is used to attach the MA after it has been fitted with an MCU that has flash ROM or a one-time PROM. Before using the RTE7701202CBG252T000J, be sure to read the precautions on page 3.




Figure 1 External View of the RTE7701202CBG252T000J




Figure 2 Usage of the RTE7701202CBG252T000J




Figure 3 Procedure for Connecting the RTE7701202CBG252T000J

5. Connection Procedure (See Figure 3)

The procedure for connecting the RTE7701202CBG252T000J is shown below.

- (1) Mount the TC on the user system.
- (2) Attach the RTE7701202CBG252T000J to the pod.
- (3) Attach the RTE7701202CBG252T000J to the TC.

Confirm that there are neither cracks nor bends on the contact pins of the RTE7701202CBG252T000J at the time it is attached.

- Adjusting the height of the socket
 The height of the socket is adjustable by inserting an SA1 or SA2 between the TC and the RTE7701202CBG252T000J.




Figure 4 Drawing of the Socket Assembly




Figure 5 Drawing with Dimensions and a Pad Pattern for Reference
