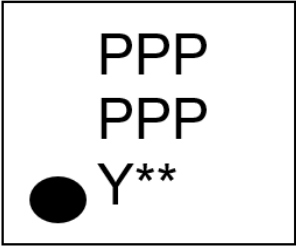
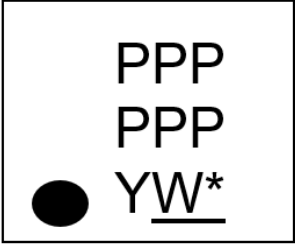
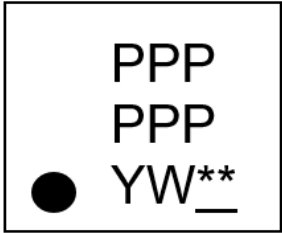
Revision Description:

Description of Change:

Renesas is further revising the marking format for Line 3 as shown in the diagram below. The proposed marking change announced in PCN230025 original version will be canceled. Furthermore, there is no actual implementation of the new marking after the PCN took effect.

There will be no change to part number, form, fit, function, reliability and quality of the products. During transition of change, customers are expected to receive shipment with two different markings till the inventories with old marking are depleted since the change is to enhance Renesas internal traceability.
