Subject: Test Site Change for the Listed Intersil Products - Carsem (CAS) Ipoh, Malaysia

This notice is to inform you that Intersil is transitioning the final electrical test, tape and reel, and packing operations for the listed products to the Carsem (CAS) facility located in Ipoh, Malaysia. The current facility STATS ChipPAC (SCM) located in Kuala Lumpur, Malaysia has officially announced plant closure by end of year 2014. http://www.statschippac.com/news/newscenter/2013/news06282013.aspx;

Intersil will migrate final electrical test, tape and reel and packing from the current facility, STATS ChipPAC (SCM), to Carsem (CAS) upon expiration of this notice and completion of all transfer activities. The product and site-specific verification activities are in progress for most of the products and scheduled to complete in May 2014. The ISL78600* are the only exception, the correlation activity is scheduled to complete August 2014.

The Carsem (CAS) facility is ISO 9001:2008 and ISO/TS 16949:2009 certified and currently qualified as a primary supplier to Intersil for testing of packaged products. The following summarizes the activities that will be conducted prior to production release to confirm there is no impact to form, fit, function, or interchangeability of the product.

- Intersil supplied test software and product specific hardware will be used at CAS.
- The test equipment validation plan involves the testing of control units and a correlation lot of select products at the CAS and current facility. The list of products selected as the qualification vehicles for this activity is included on the next page.
 - Control units will be tested at the current test site and retested at CAS, their performance recorded, and the results analyzed to validate the set-up.
 - A correlation lot of approximately 1000 units will be tested at the current test site and retested at CAS. The test results from each site will be compared.
 - Continuous monitoring and comparison of the data from lots processed at multiple sites are an ongoing function of the responsible product engineers.
- The visual/mechanical inspection and tape and reel operations are compliant to JEDEC industry standards used by all Intersil subcontractors.

Product affected by this change is identifiable via Intersil's internal traceability system

Intersil will take all necessary actions to conform to customer requirements and to ensure the continued high quality and reliability of Intersil products being supplied. Customers may expect to receive product tested at the CAS facility beginning *ninety* days from the date of this notification or earlier upon approval.
