2. Processing at power-on

5. Clock signals

After applying a reset, only release the reset line after the operating clock signal becomes stable. When switching the clock signal during program execution, wait until the target clock signal is stabilized. When the clock signal is generated with an external resonator or from an external oscillator during a reset, ensure that the reset line is only released after full stabilization of the clock signal. Additionally, when switching to a clock signal produced with an external resonator or by an external oscillator while program execution is in progress, wait until the target clock signal is stable.

6. Voltage application waveform at input pin

Waveform distortion due to input noise or a reflected wave may cause malfunction. If the input of the CMOS device stays in the area between V_{IL} (Max.) and V_{IH} (Min.) due to noise, for example, the device may malfunction. Take care to prevent chattering noise from entering the device when the input level is fixed, and also in the transition period when the input level passes through the area between V_{IL} (Max.) and V_{IH} (Min.).

7. Prohibition of access to reserved addresses

Access to reserved addresses is prohibited. The reserved addresses are provided for possible future expansion of functions. Do not access these addresses as the correct operation of the LSI is not guaranteed.

8. Differences between products

Before changing from one product to another, for example to a product with a different part number, confirm that the change will not lead to problems. 1. Introduction

This Quick Start Guide (QSE) provides:

- An overview of the Quick Start Guide project for the VK-RA8M1 board using the Audio Processing Front (APF), accompanied with Natural Language Understanding (NLU), Voice Anti-Spoofing (VAS) and Speaker Verification (CNSV) for identification of a speakers number that are registered to the device.
- Instructions for importing, modifying, and building the QSG used project using Flexible Software Package (FSP) and e2 studio Integrated Development Environment (IDE)

1.1 Assumptions and Advisory Notes

1. Tool experience: It is assumed that the user has prior experience working with IDEs such as e2 studio and terminal emulation programs such as Tera Term.
2. Subject knowledge: It is assumed that the user has basic knowledge about microcontrollers, embedded systems, and FSP to modify the example project described in this document.
3. The screen shots provided throughout this document are for reference. The actual screen content may differ depending on the version of software and development tools used.

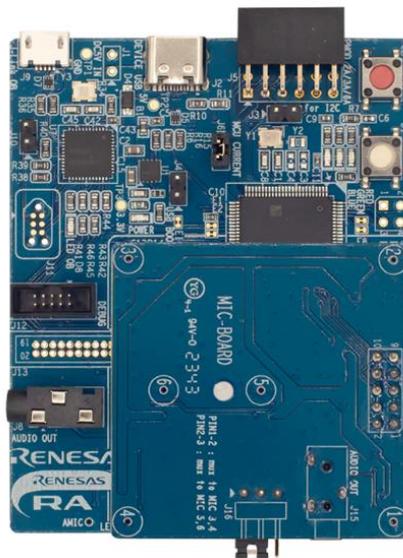


Figure 1. VK-RA8M1 Kit

3. Overview of the Quick Start Guide Project

This QSG is aimed to demonstrate a combo application of VCR-NLU, being used with APF, VAS and CNSV. It achieves a more accurate recognition of voice commands in any environment by removing interfering sounds captured by the microphone. The enhancement accompanies Renesas Voice User Interface solution with features such as

- Advanced Voice Commands Recognition with Natural Language Understanding
- Voice Activity Detection
- Multiple Languages Recognition
- Text to Speech decoding for voice prompts
- Wake-word customization feature at the end-user (via voice tagging)
- Speaker Identification
- Anti-Spoofing that identifies real human voice from machine generated voice
- An ultra-lightweight library of voice processing algorithms designed to enhance the recognition of voice commands

The application uses the mic-board microphones (check jumper positions) to perform voice command recognition.

3.1 Description of Audio Processing Front

The Audio Processing Frond (APF) is a library of voice processing algorithms designed to enhance the recognition of voice commands recognition and speech quality when noisy conditions are met.

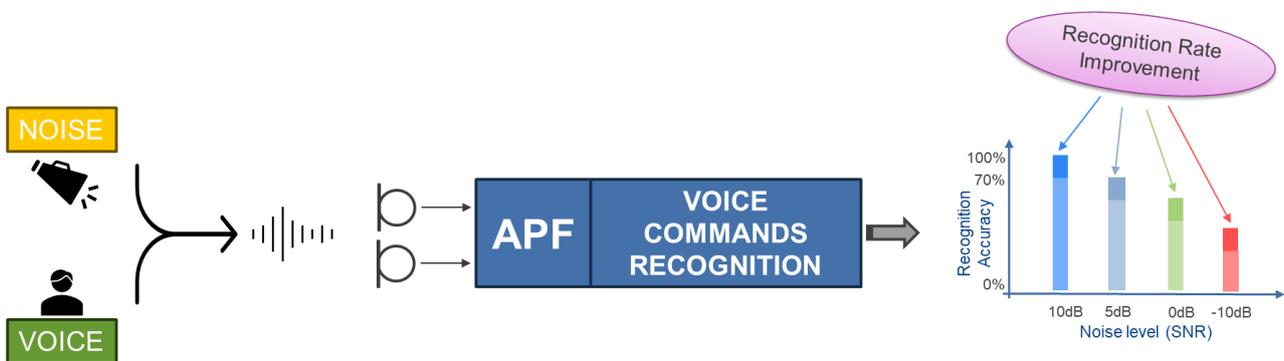


Figure 2. Recognition Rate improvement with APF

Operating Features:

- Two microphones acoustic beamformer (BF) with configuration for endfire & broadside operation
- Four-bands single channel noise suppression (NSUPP)
- Combined with smaller size Dspotter level
- API for controllable operation and tuning
- Methodology to configure for other microphones' distance
- Operation as USB audio enumerated device

Configuration Features:

- Activate / deactivate the complete APF
- Select for NSUPP (1 mic) or BF/NSUPP (2 mic) operation
- Select between end-fire / broad-side BF configurations
- Configure noise level activation threshold
- Configure attack / decay and timeout thresholds

3.2 Description of Voice Recognition and Natural Language Understanding

VCR is high-performance embedded voice recognition solution specially optimized for mobile phones, automotives, smart home devices, consumer products, and interactive toys. Based on phoneme acoustic models, it enables developers to create applications of speaker-independent (SI) voice recognition capability without requiring costly data collection process for specific commands. With Win32-based DSpotter Model Tool, developers can easily and quickly create their own voice command models simply by text input. Other important features include always-on keyword-spotting capability, highly noise immune, adjustable sensitivity, voice quality assessment, and more than 30 commonly used language versions available.

DSpotterNLU Engine is a Cyberon engine that can understand what the speaker's intent in a single full sentence. It can process natural language and hence the speaker do not need to say the exact fixed words. The sentence said by the speaker can contains words that are not relevant to the intent but the engine can still understand.

3.3 Description of Cyberon Speaker Verification

Cyberon CNSV is an engine designed to enable developers to integrate speaker verification capabilities into their applications and devices. CNSV leverages advanced neural network algorithms optimized for edge environments, providing high accuracy and low latency while maintaining efficient resource usage.

Speaker verification focuses on identifying specific speakers by analyzing vocal characteristics, unlike traditional speech recognition, which converts speech into text. This technology makes applications more user-friendly, as it can be used in scenarios where identifying the speaker is necessary, enhancing both convenience and intuitive operation.

Key Features of CNSV SDK:

- **Advanced Neural Network Technology for Edge Devices:** Utilizes state-of-the-art neural network models specifically optimized for edge computing environments, providing high accuracy with minimal computational overhead.
- **Optimized for Embedded Systems and ARM Platforms:** Designed to operate efficiently on resource constrained devices, making it ideal for embedded systems, ARM-based platforms, and other edge devices.
- **Efficient Resource Usage:** Low CPU and memory consumption ensures that the SDK can be deployed on devices with limited processing power and memory.
- **Robust Performance in Real-World Environments:** Maintains high accuracy and reliability in various conditions, including noisy environments and diverse microphone setups.

By leveraging neural network-based speaker verification, developers can enhance the user experience of their edge device applications. CNSV SDK is particularly suited for developers focused on building efficient and user-friendly solutions for embedded systems and ARM-based platforms.

3.4 Description of Voice Anti-Spoofing

The Renesas Reality AI Voice Anti-Spoofing library is used as an extension of the VUI - Voice Command Recognition from Cyberon, to detect Human real voice vs Machine generated or recorded voice. For demonstration purposes, limited amount of data and recording devices has been used to train the model on e2studio and Reality AI TOOLS®.

4. Running the Quick Start Guide Project

This section lists the requirements and instructions to power up the VK-RA8M1 board and run the Quick Start Guide project.

Hardware Requirements

- VK-RA8M1 board
- Micro USB device cable
- A PC with at least 1 USB port

Software Requirements

- Windows® 10 operating system

4.1 Connecting and Powering Up the VK-RA8M1 Board

1. Prior to running the Quick Start Guide project or programming the VK-RA8M1 board, Mic board need to be attached to VK-RA8M1 board. This will enable the digital microphones on the mic board.
2. Power up the voice-kit through the micro-B USB port (J9) of the VK-RA8M1 board (cable is included).
3. Connect the other end of this cable to the USB port of the host PC. The power LED on the VK-RA8M1 board lights up blue, indicating that the VK-RA8M1 board is powered on.

4.2 Programming the application example

Flash the device with the binary that has been provided with this document.

In the folder Flasher you will find the following files:

- Flash Device.bat
- Flash Device.jlink
- JLink.exe
- JLink_x64.dll
- RA8M1_VK_voice_combo.srec

Verify that the VK-RA8M1 board is connected to the PC and run the Flash Device.bat file, the project will be automatically downloaded to the DUT.

4.3 UART Terminal Output

On power on, the UART output is enabled.

For that the user needs to setup the serial terminal as follows:

- Speed / Baud Rate 460800
- Data 8 bit
- Parity none
- Stop bits 1 bit
- Flow Control none

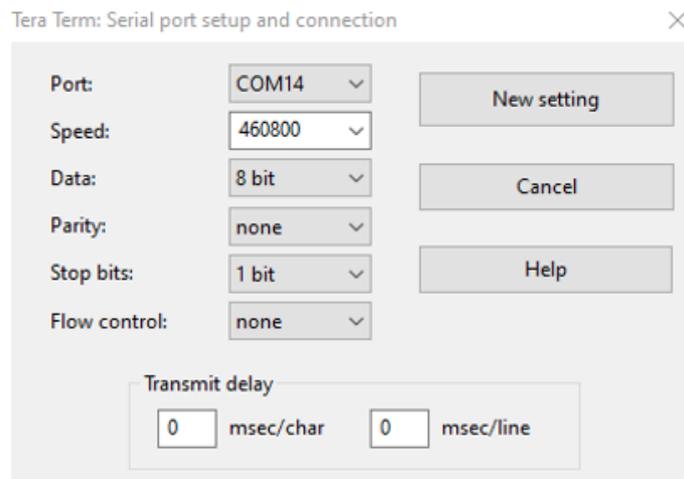


Figure 4. Serial Port Setup

4.4 Running the Quick Start Guide Project

Table 1. Mode configurations

To run the Quick Start Guide project, use the following instructions:

1. On power up or RESET.
2. The LEDs blink
3. The board starts in Bypass mode with NSUPP and BFNSUPP disabled, no LEDs are On

Note: The debug LED (OB) will blink or light up Yellow; this can be ignored for now.

4. Open Teraterm with Speed 460800, Data 8 bit, Parity none, Stop bits 1 bit.
5. Say “Train Speaker x”, with x being user from 1 to 6
6. The device will prompt user to say “Hi Renesas” 3 times for the registering to be completed

7. After registration is completed say “Hi Renesas” as wake word.
8. VAS will run and give a result if the voice is human or machine generated only in Bypass mode.
9. Give one of the following commands using natural language:
 - a. Open Light
 - b. Close Light
 - c. Play Music
 - d. Stop Music
 - e. Pause Music
 - f. Resume Music
 - g. Next Music
 - h. Previous Music
 - i. Volume Up
 - j. Volume Down
 - k. Volume too Low
 - l. Volume too Loud
10. Verify command received in Serial Terminal.
11. Press the S1 Button.
12. Board changed state and have Noise Suppression ON (NSUPP). Red LED is On.
13. Say “Hi Renesas” as wake word.
14. Give one of the commands in step 9.
15. Verify command received in Serial Terminal.
16. Press the S1 Button.
17. Board changed state to BFNSUP. Green LED is On.
18. Say “Hi Renesas” as wake word.
19. Give one of the commands in step 9.
20. Verify command received in Serial Terminal.

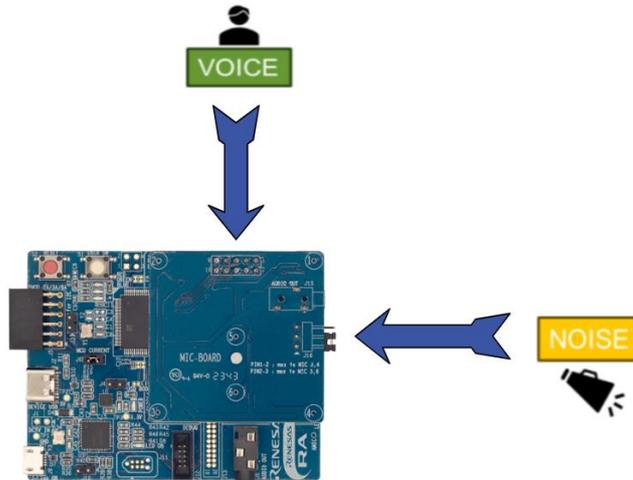


Figure 5. BFNSUPP Broadside configuration

For optimal results in BFNSUPP mode the Broadside configuration is suggested, for more details please review the r01an7593ee0100 application note (available on request).

5. Customizing the Quick Start Guide Project

This section lists the requirements and instructions for customizing the Voice Combo Demo project.

Hardware Requirements

- VK-RA8M1 board
- Micro USB device cable
- A PC with at least 1 USB port

Software Requirements

- Windows® 10 operating system
- e2 studio IDE
- FSP
- Voice Combo Demo project

5.1 Downloading and Installing Software and Development Tools

Before the Quick Start Guide used project can be modified, it is necessary to download and install software and development tools on the host PC.

The FSP, J-Link USB drivers, and e2 studio are bundled in a downloadable platform installer available on the FSP webpage at renesas.com/ra/fsp. New users are recommended to use the **Quick Install** option provided in the installation wizard, to minimize the amount of manual configuration needed.

There is no need to download and install software, development tools, and drivers separately.

5.2 Downloading and Importing the Quick Start Guide Project

2. Download and extract the Voice Command Recognition Demo (APF) project to a local directory on the host PC.
 - a. The Voice Combo Demo project (source code and project files) is available on request.

- b. Download the Voice Combo Demo project to a local directory on the host PC.
3. Launch e2 studio.
4. Browse to the Workspace where the project file is to be imported. Enter the name in the Workspace dialog box to create a new workspace.

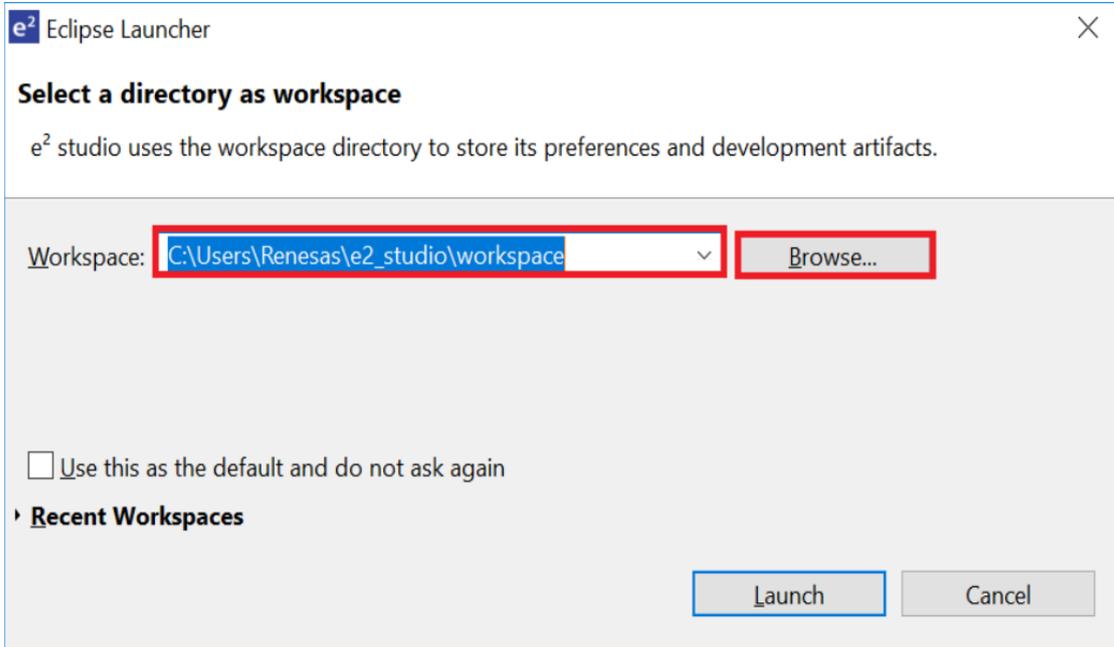


Figure 6. Creating a New Workspace

5. Click **Launch**.

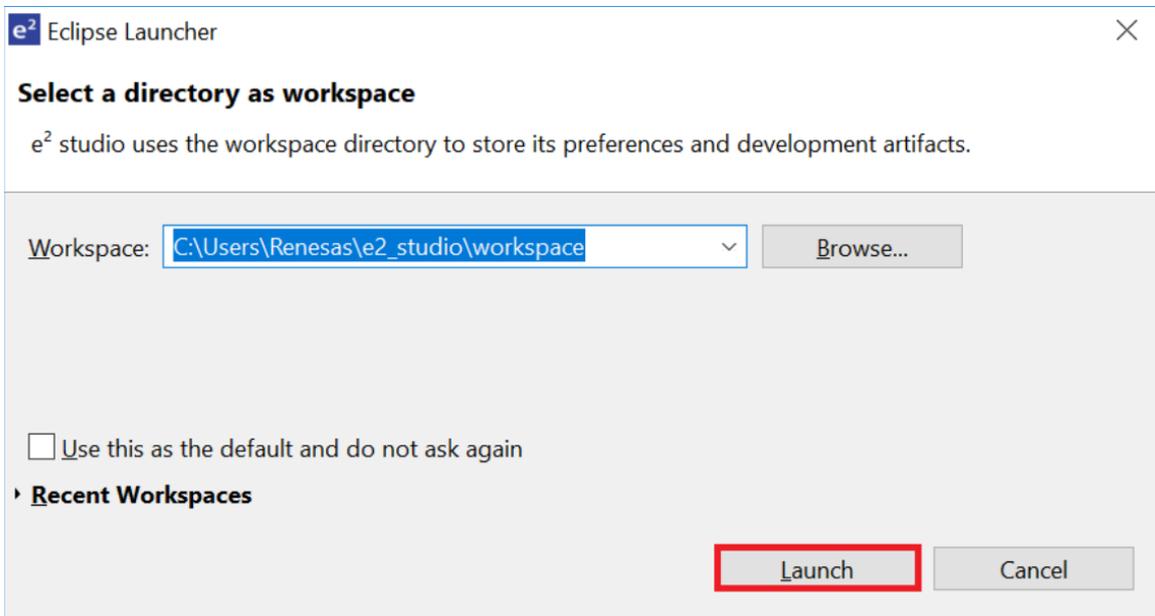


Figure 7. Launching the Workspace

6. Click Import from the File drop-down menu.

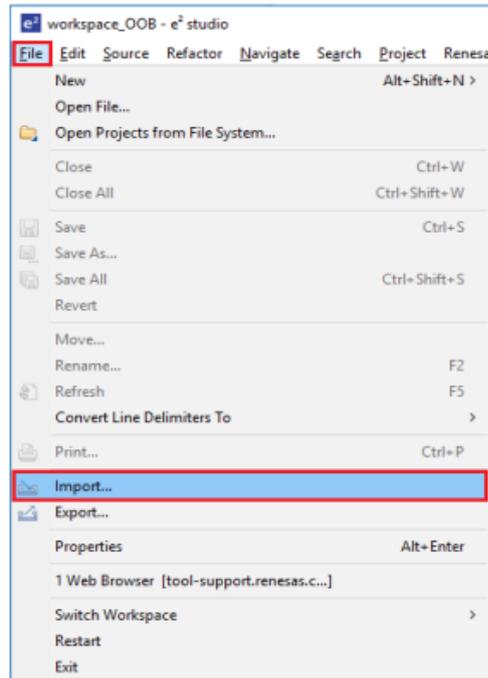


Figure 8. Importing the Project

7. In the **Import** dialog box, select **General**, and then select **Existing Projects into Workspace**.

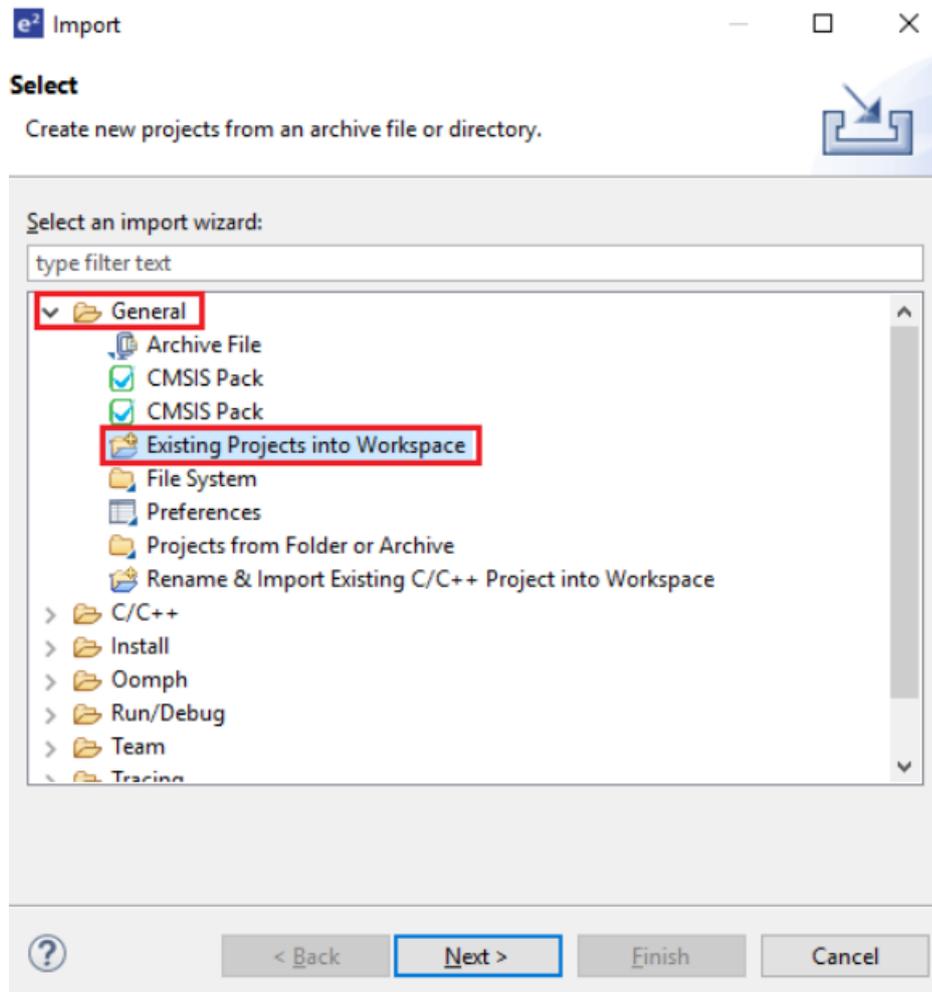


Figure 9. Importing Existing Projects into the Workspace

8. Click **Next**.

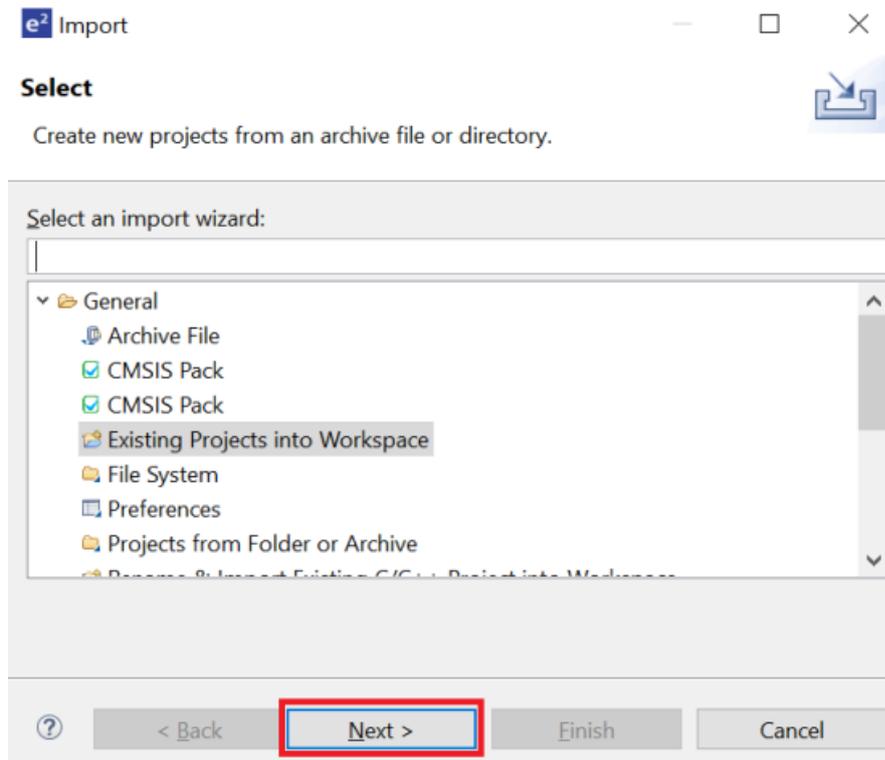


Figure 10. Clicking Next to Import Existing Projects into the Workspace

9. Click **Select root directory** and click **Browse** to go to the location of the Quick Start Guide project folder.

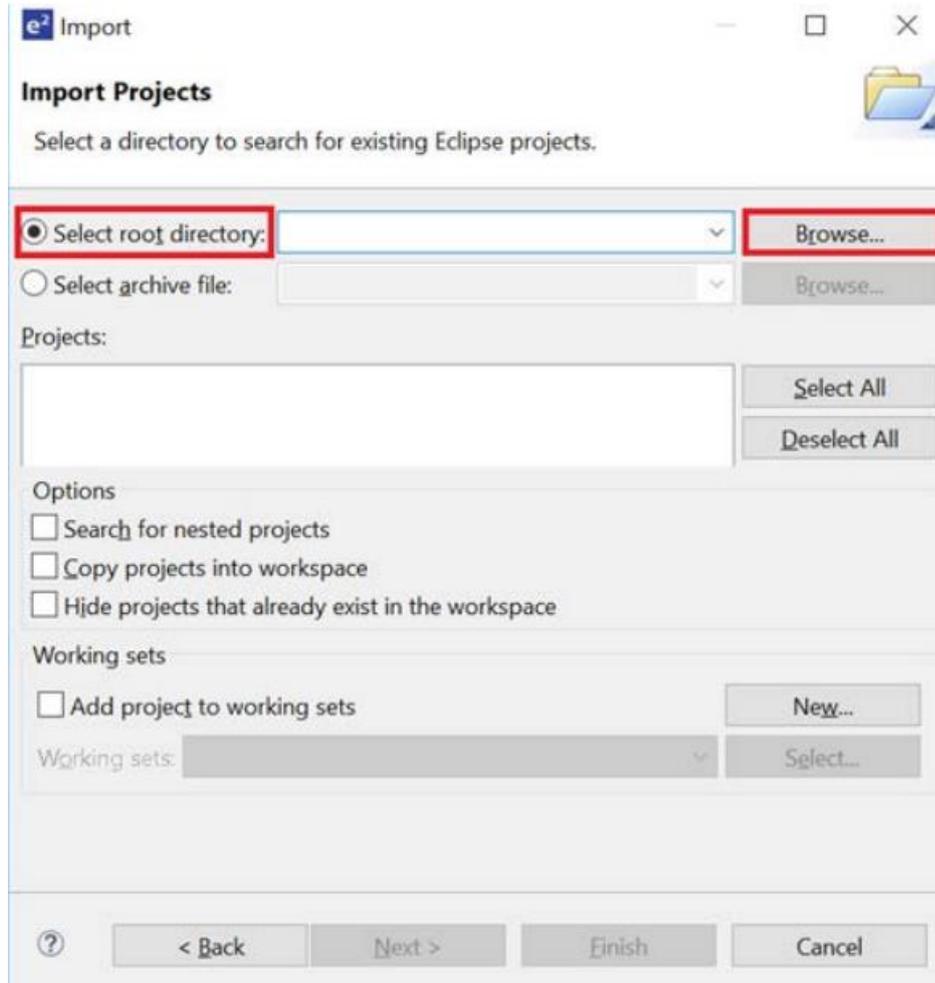


Figure 11. Selecting the Root Directory

10. Select the Quick Start Guide project and click **Finish**.

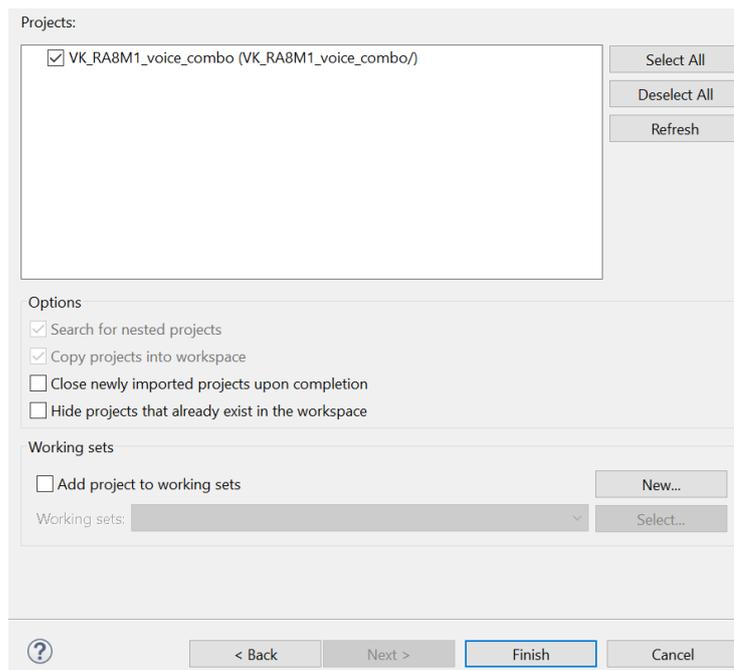


Figure 12. Finishing Importing the Quick Start Guide Project

5.3 Modifying, Generating, and Building the Quick Start Guide Project

This section provides instructions to modify the Voice Combo Demo project. The Voice Combo Demo project can be modified by editing the source code and reconfiguring the properties of the MCU peripherals, pins, clocks, interrupts, and so forth.

Note: The specific modifications that can be made to the Voice Combo Demo project are not prescribed in this QSE. User discretion is advised while modifying the Voice Combo Demo project.

Once Voice Combo Demo project is imported, click the configuration.xml file to open the configurator. The configurator provides an easy-to-use interface to configure the properties of MCU peripherals, pins, clocks, and so forth.

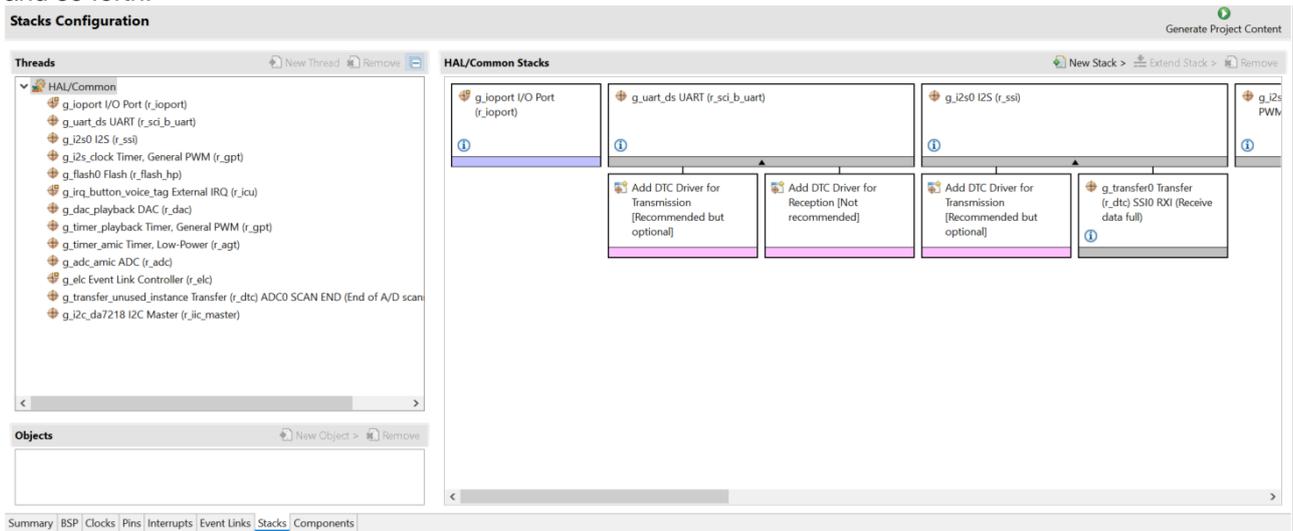


Figure. Opening the Configurator

For example, in the **Stacks** tab of the configurator, the user can click to select modules to modify the configuration settings, as required. The following screen shot illustrates modifying the UART configuration.

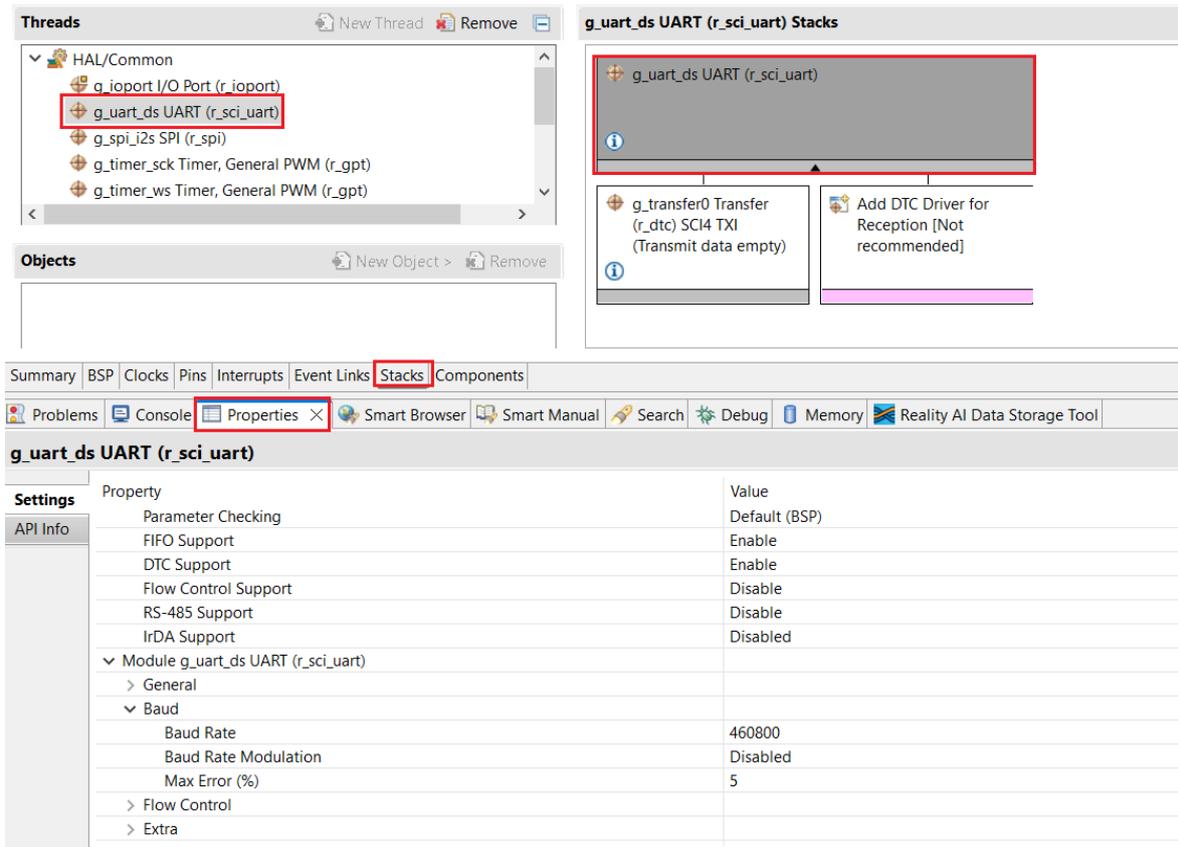


Figure 13. Modifying the Configuration Settings

1. After the desired modifications are made, click **Generate Project**. A dialog box may appear with an option of saving the configuration changes. Click **Proceed**.

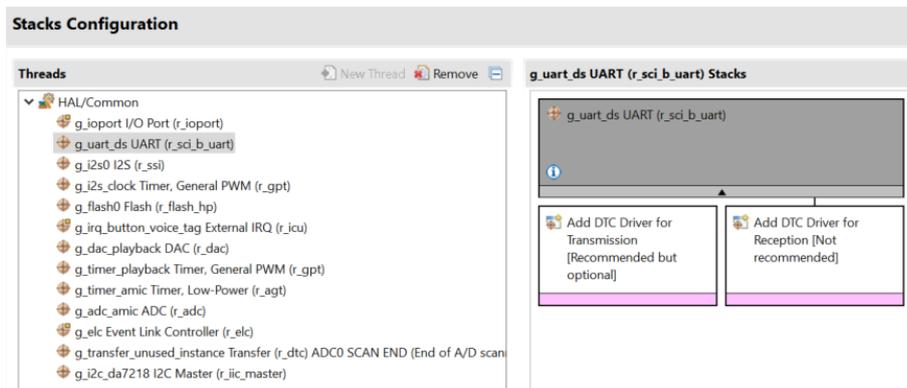


Figure 14. Saving the Configuration Changes

2. Modify the source files in the **/src** folder as needed and save the changes.
3. Build the project by clicking the build icon.

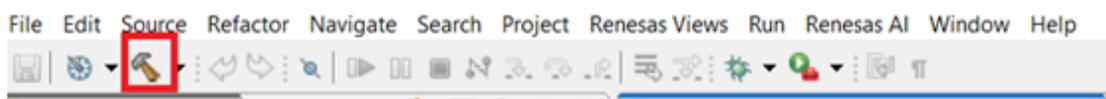


Figure 15. Building the Project

5.4 Setting Up Debug Connection between the VK-RA8M1 board and Host PC

To program the modified Voice Combo Demo project on to the VK-RA8M1 board, a debug connection is necessary between the VK-RA8M1 board and host PC.

1. Connect the USB cable in the micro-B USB debug port (J9) of the VK-RA8M1 board.
2. Verify that the debug LED (OB) stops blinking and lights up orange indicating that the J-Link drivers are detected by the VK-RA8M1 board.

Note: The debug LED (OB) continues to blink when J-Link drivers are not detected by the VK-RA8M1 board. In that case, make sure that the VK-RA8M1 board is connected to the host PC through the micro-B USB debug port (J9) and that J-Link drivers are installed on the host PC by checking in the Windows Device Manager (expand **Universal Serial Bus controller**, and locate **J-Link driver**)

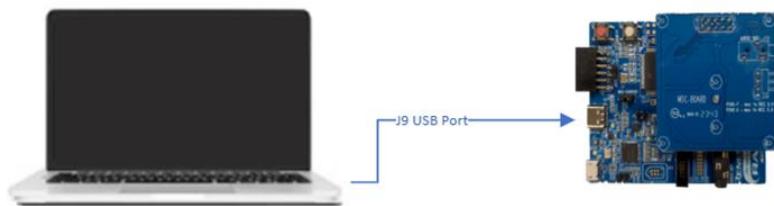


Figure 17. Connecting the VK-RA8M1 Board to the Host PC via USB Debug Port

5.5 Downloading and Running the Modified Quick Start Guide used project

1. In e2 studio, click the drop-down menu for the debug icon, select Debug As option, and choose Renesas GDB Hardware Debugging.

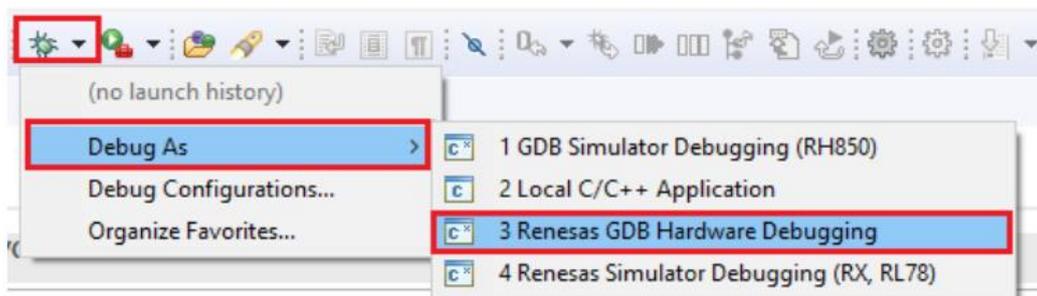


Figure 18. Selecting the Debug Option

2. A dialog box may appear. Click **Yes**.

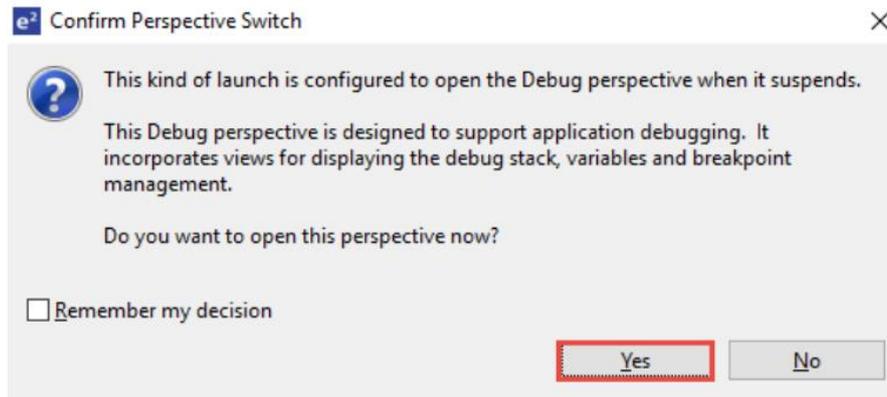


Figure 19. Opening the Debug Perspective

3. Press **F8** or click the **Resume** icon to begin executing the project.

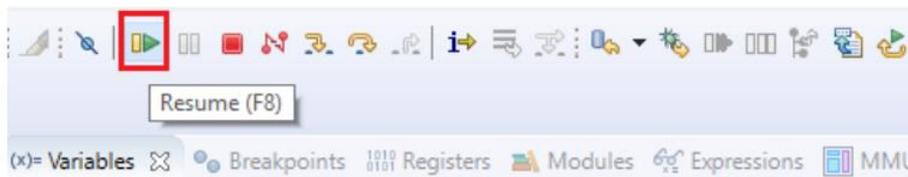


Figure 20. Executing the Project

4. The modified project is programmed into the VK-RA8M1 board and is running. The project can be paused, stopped, or resumed using the debug controls.
