1. 应用例子的说明

对于异步串行I/O（以下称UART），发送侧和接收侧统一波特率和传送数据格式，异步进行数据的发送和接收。

7544群根据UART控制寄存器的设定，能选择8种串行数据传送格式。

1.1 有关数据传送速度

位传送速率的计算式如下所示：

- 在选择内部时钟时（在使用波特率发生器时）

$$\text{位传送速率 [bps]} = \frac{f(\text{XIN})}{\text{分频比}^{\ast 1} \times (\text{BRG设定值}^{\ast 2} + 1) \times 16}$$

- 分频比^{*1}：选择“1”或者“4”（通过串行I/O控制寄存器的位0设定）
- BRG设定值^{*2}：设定0~255（00₁₆~FF₁₆）

- 在选择外部时钟时

$$\text{位传送速率 [bps]} = \text{SCLK管脚的输入时钟}/16$$

波特率发生器的设定值和位传送速率的选择例如表1所示：

串行I/O的UART设定方法如图1和图2所示。

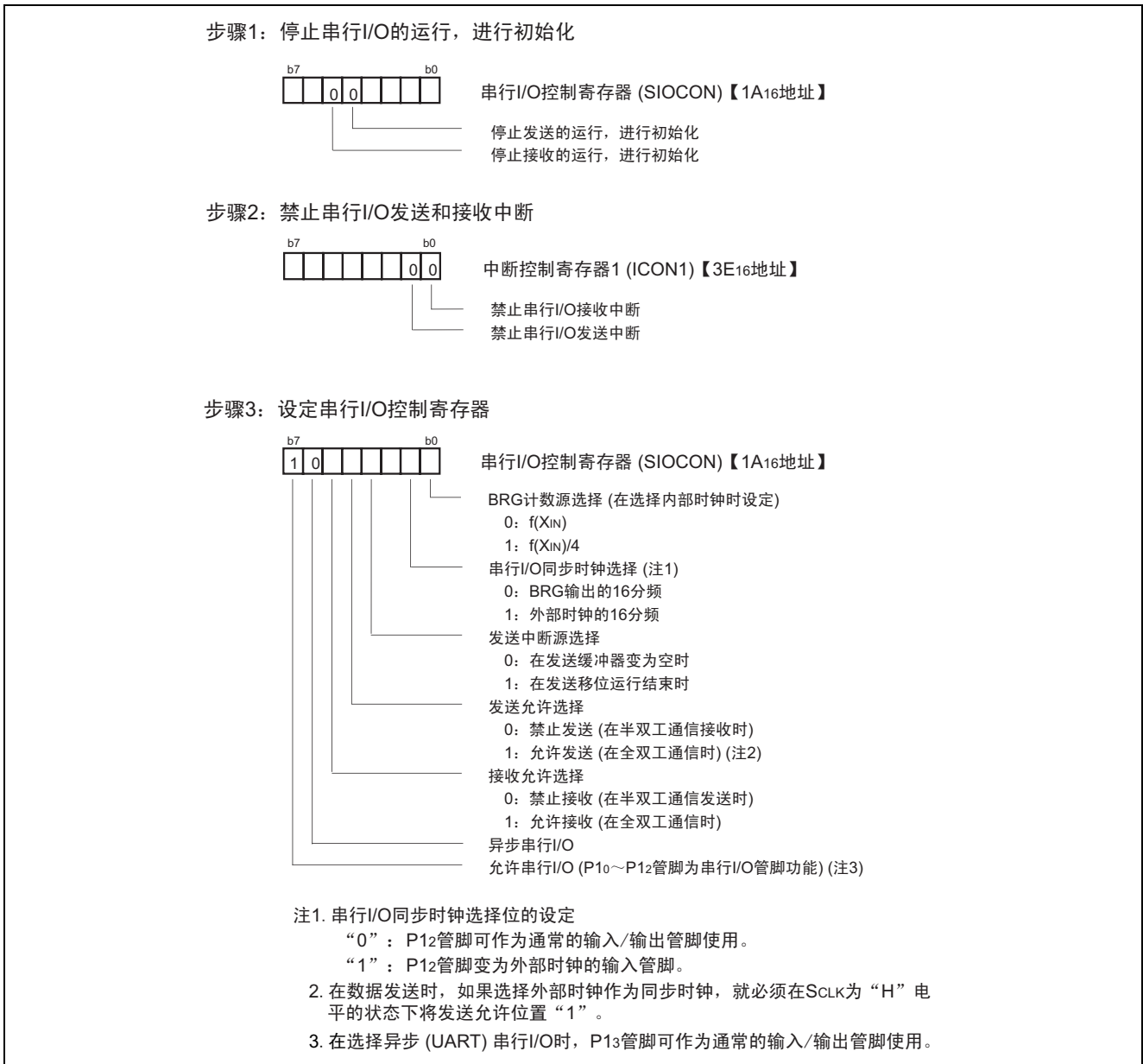
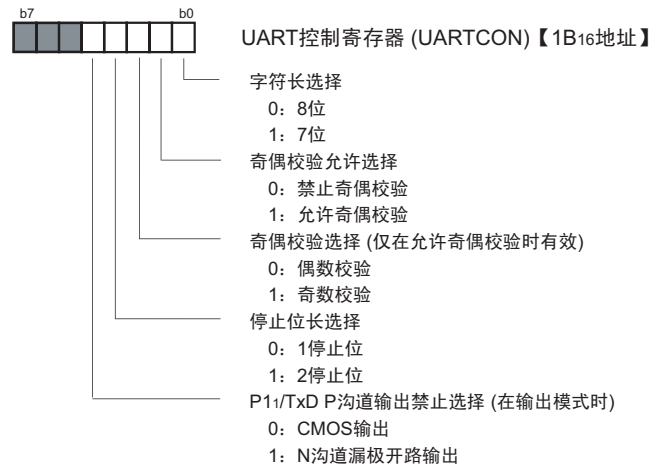
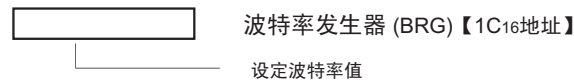


图1 串行I/O的UART设定方法(1)

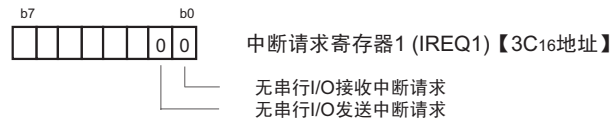
步骤4: 设定UART控制寄存器



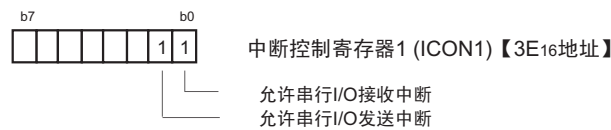
步骤5: 在选择BRG输出的16分频作为同步时钟时, 对波特率发生器进行设定



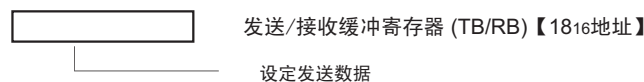
步骤6: 为了不执行不必要的中断处理, 必须将串行I/O发送和接收中断请求位置“0”(无请求)



步骤7: 在执行中断时, 必须将串行I/O发送和接收中断允许位置“1”(允许中断)



步骤8: 在发送时, 开始数据的发送 (注)



注. 在数据发送时, 如果选择外部时钟作为同步时钟, 就必须在SCLK为“H”电平的状态下进行。

1.3 使用 UART 的通信 (发送和接收)

■要点

使用UART, 发送和接收2字节的数据。通信控制使用端口P00。

■说明

使用串行I/O (选择UART), 位传送速率为9600bps (对 $f(XIN)=4.9152MHz$ 进行512分频)。

通信控制使用端口P00 (端口P00的输出电平由软件控制)。

每隔10ms (由定时器产生) 从发送侧将2字节数据传送给接收侧。

连接图、时序图、发送侧控制步骤的例子、接收侧控制步骤的例子分别如图3、图4、图5、图6所示。

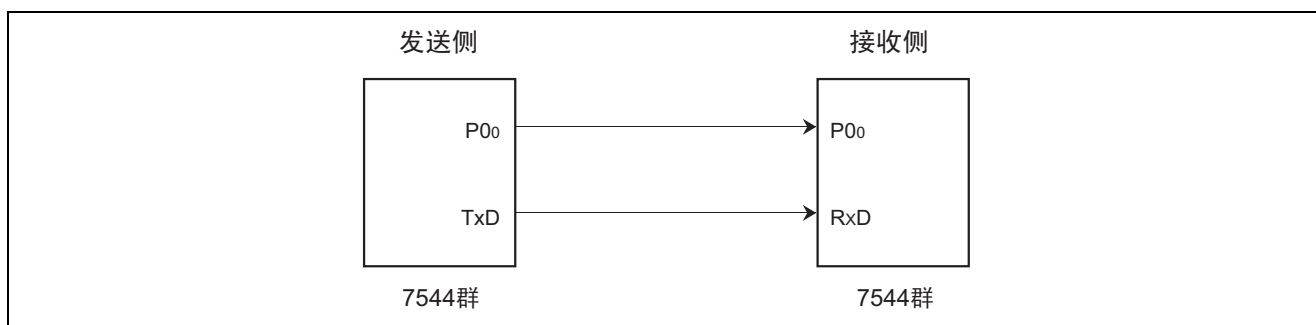


图 3 连接图

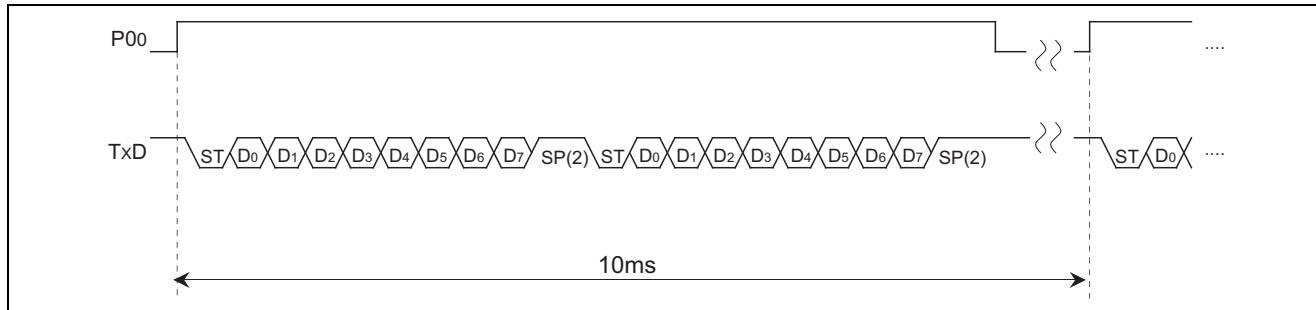


图 4 时序图

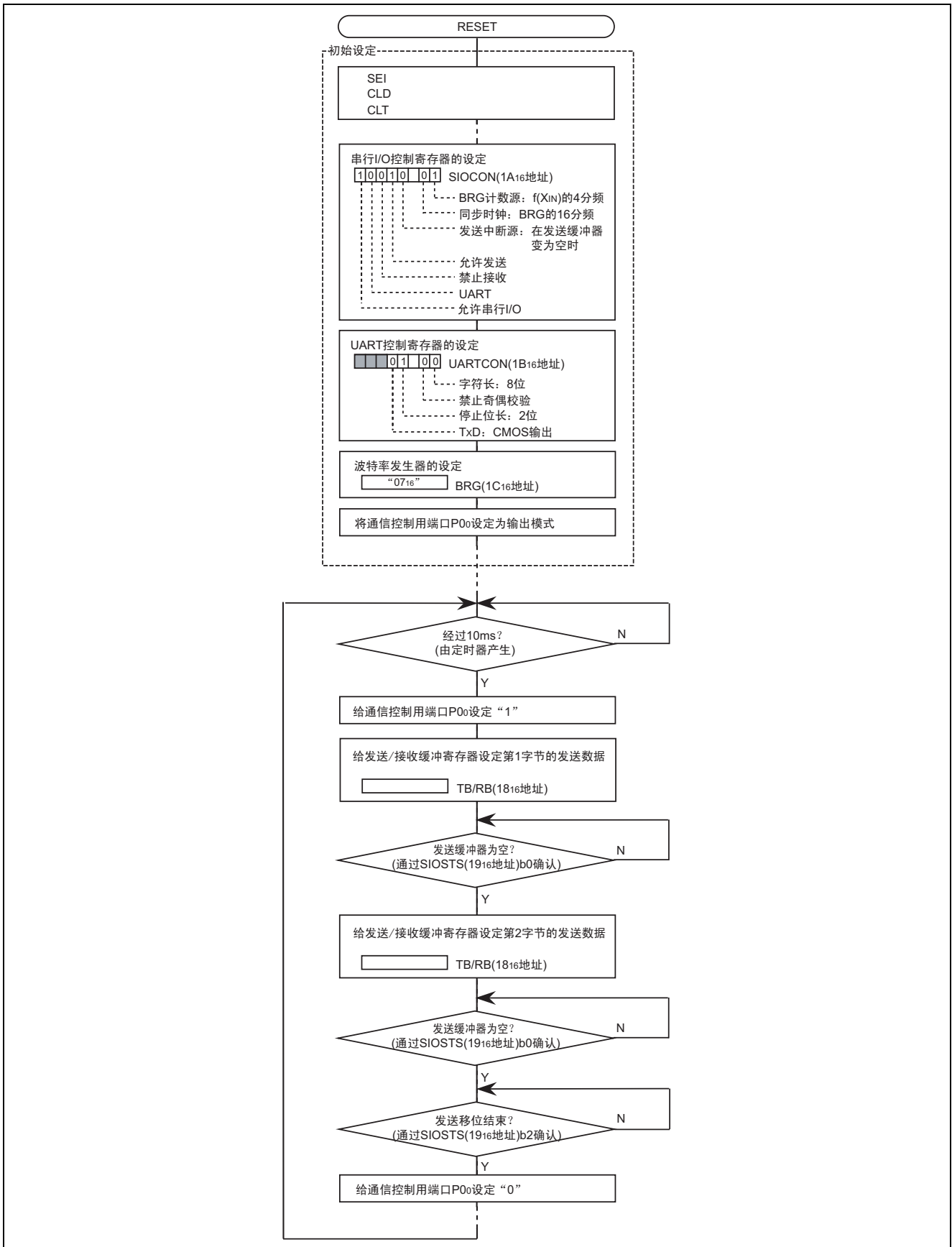


图 5 发送侧的控制步骤例子

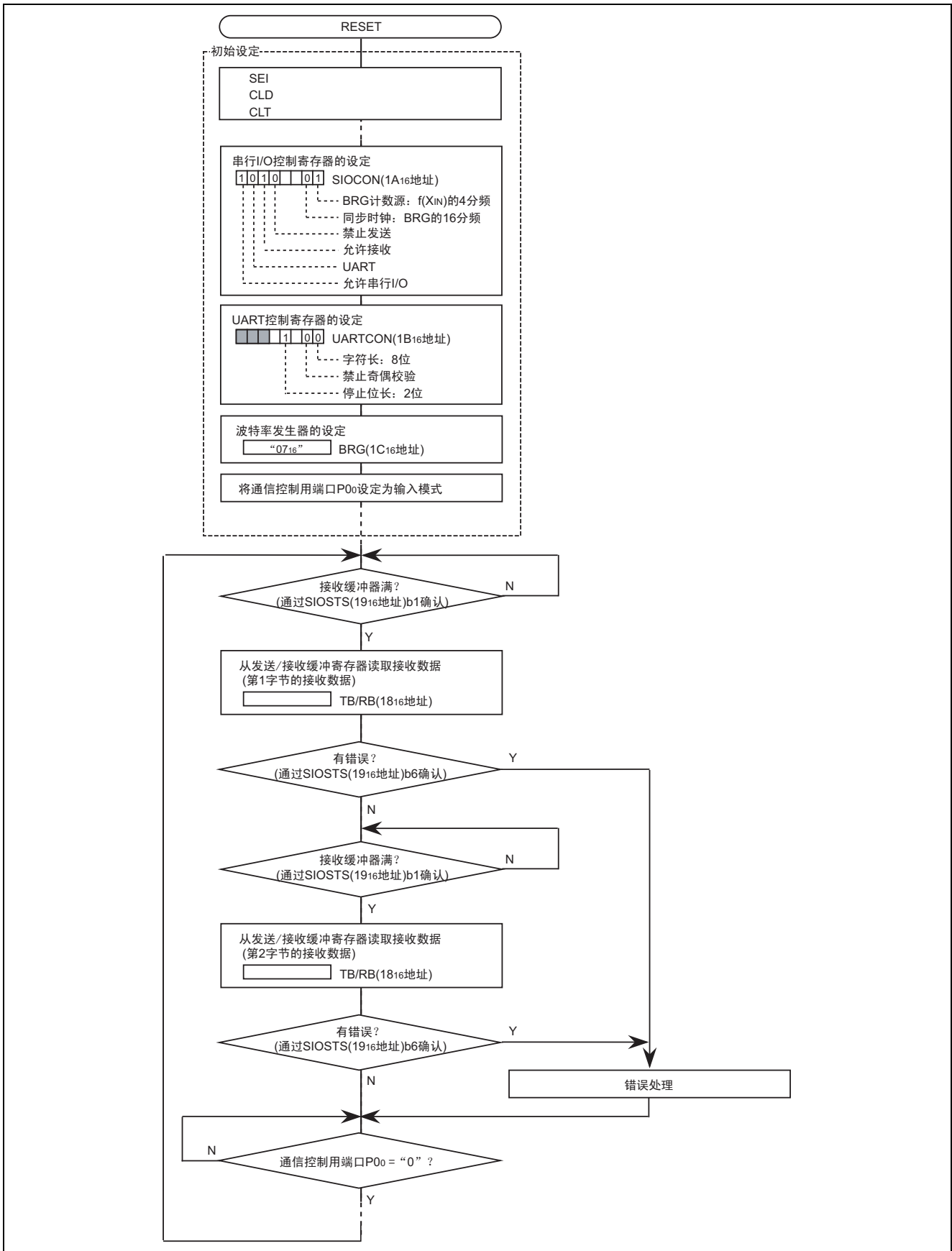


图 6 接收侧的控制步骤例子
