Chapter 3. Points for Caution

3.1 Note on updating the version

After the license manager is updated to V2.00.00 or a later version, the setting for using a floating license is disabled by default. If you wish to use a floating license, enable this through the following step.

Click on the [Option] button in the [License Manager] window, and then click on the [Enable] button in the [Floating License Option] dialog box.



Chapter 4. Changes

This chapter describes the main changes in the license manager from V2.01.00 to V2.02.00.

4.1 Support for version upgrade licenses

With updating of the version of the RH850 compiler CC-RH V1.07.00 to V2.00.00, the license manager now supports <u>a version upgrade license</u>. If you have a license to the version of the RH850 compiler before the update, you can register this license with the license manager and use it as a license equivalent to a license for the updated version.




Figure 4-1 Examples of Combinations of Licenses



4.2 Change of the display in the [License Manager] window

The registered name of a license displayed in the license area of the [License Manager] window has been changed.

For the RH850 compiler (professional edition V1) license:
