Chapter 1. User's Manuals

Please read the following user's manuals along with this document.

The stated version numbers may differ from that of the product depending on whether the user's manuals have been revised.

Chapter 2. Operating Environment

2.1 Hardware environment

- Processor: At least 1 GHz (support for hyper threading/multicore CPU)
- Main memory: At least 1 GB (2 GB or higher for Windows (64-bit OS)), 2 GB or higher recommended
- Display: Resolution at least 1,024 x 768; at least 65,536 colors

2.2 Software environment

The following software environments are supported.

- Windows 10 (32bit, 64bit)
- Windows 11
- Windows Server 2016 (Server Core is unsupported)
- Windows Server 2019 (Server Core is unsupported)
- Windows Server 2022 (Server Core is unsupported)
- Microsoft .NET Framework 4.5.2

For any of these, we recommend having the latest service pack installed.

Chapter 3. Improvements and Changes

This section describes changes on software for floating license management from V2.04.00 to V2.08.00.

3.1 Support for multi-user environments

The software for floating license management now supports multi-user environments where multiple users log in to a single PC for building with the use of a floating license.

When you are using a floating license in a multi-user environment, update both the software for floating license management and the license manager.

3.2 Improvement to the operation in the saving of log files

Problems listed below* in the log files to be saved have been rectified.

- Duplicated messages are recorded to indicate that a floating license assigned to a client has expired.
- The number of states of floating license usage that is indicated in some messages may differ from the actual number of states.

*The problems only applied to log files to be saved. There are no problems with operations for managing floating licenses.

3.3 Improvement to the operation of the function for saving the states of floating license usage

When the number of states of floating license usage is saved in a CSV file, the problem* of that number possibly differing from the actual number of states has been rectified.

*The problem only applied to CSV files to be saved. There are no problems with operations for managing floating licenses.

3.4 Improvement to the operation of the function for deleting multiple licenses

Multiple licenses cannot be deleted at once have been rectified.

Chapter 4. Uninstallation

To uninstall this product, select [Renesas MCU Tools Floating License Server] from [Apps & features] from [Settings] of Windows or [Programs and Features] of the control panel.

Chapter 5. Points for Caution

5.1 Points for caution regarding installation

5.1.1 Administrator privileges

Windows administrator privileges are required to install the software.

5.1.2 Execution environment

The Microsoft .NET Framework is required to run the installer. If the Microsoft .NET Framework is not installed, the floating license installer will install it.

5.1.3 Starting the installer

If the installer is started under a non-Japanese version of Windows and the path for starting the installer includes multi-byte characters, an error will occur and the installer will not start .

5.1.4 Network drives

The software cannot be installed from a network drive.
It also cannot be installed to a network drive.

5.1.5 Installation folder name

The available characters for specifying the installation folder are the same as for Windows.
The 12 characters / * : < > ? | " \ ; , # and %*nn* (*n*:number of hexadecimal) cannot be used. Folder names also cannot start or end with a space.

5.1.6 Required files after installation

The following folder is created after installation. Do not delete it, because it contains files that are necessary for the tools to run.

(32-bit Windows, and installation drive is C:)

C:\Program Files\Common Files\Renesas Electronics MCU Tools\

(64-bit Windows, and installation drive is C:)

C:\Program Files (x86)\Common Files\Renesas Electronics MCU Tools\

5.1.7 Modifying and repairing functions

To modify or repair the function of a tool that has already been installed, have the tool's installer package on hand, and run the installation program. The program maintenance program will start; select **Modify** or **Repair**.

Clicking on [Apps & features] from [Settings] of Windows or [Programs and Features] of the control panel will cause an error.

5.1.8 Changing the installation folder

To change the folder that tools are installed to, you must first uninstall all tools, and then perform installation again.

5.1.9 Version of installed tools

If the newer version tool is already installed, the older version tool may not be installed.

5.2 Points for caution regarding uninstallation

5.2.1 Administrator privileges

Windows administrator privileges are required to uninstall the software.

5.2.2 Uninstallation folder name

Depending on the order in which tools are uninstalled, the folders may not be completely deleted. If this happens, remove any remaining folders via Explorer or the like.

5.2.3 Adding/repairing via other than the installer

If you added or modified files to the folders in which tools and release notes were installed using other means than the installers, they cannot be deleted during uninstallation.

5.2.4 Microsoft Tools

Uninstall the Microsoft .NET Framework, separately from the floating license by using [Apps & features] from [Settings] of Windows or [Programs and Features] of the control panel.

5.3 Point for caution regarding updating a version

5.3.1 Updating the version of the license manager

License manager V2.08.00 is required to manage floating licenses with the software for floating license management V2.08.00. If you will be using a floating license, update the version of the license manager by downloading it from the Web page for the CS+ IDE or for the given compiler package.

5.3.2 Floating license (Offline Mode)

If you update the Software for floating license management V2.08.00, the "Floating License (Offline Mode)" that the license manager obtained from the Software for floating license management will be invalidated.

If you want to continue to use the "Floating License (Offline Mode)", force leaving the "Floating License (Offline Mode)" using the Software for floating license management and re-get the "Floating License (Offline Mode)" from the Software for floating license management using the license manager.
