### 1. 概要

本资料说明了定时器X的定时器模式的使用例。

#### 2. 前言

在本资料中说明的例子,适合以下单片机在下列条件下使用。

- 单片机 : R8C/10、R8C/11、R8C/12、R8C/13群
- 主时钟输入振荡频率 : 16MHz

和R8C/10群有相同SFR(外围控制寄存器)的其它的R8C/Tiny系列,也可以使用本程序。但有时会因增加一部分功能等情况而有所改变,所以必须通过手册进行确认。在使用本应用说明时必须进行充分的评价。

#### 3. 定时器模式的运行

- (1)如果将计数开始标志置"1",计数器则对计数源进行递减计数。
- (2)下溢时,重新装入再装入寄存器的内容,然后继续计数。同时,定时器X中断请求位变为"1"。
- (3)如果将计数开始标志清 "0",计数器则保持计数值并停止。

定时器模式运行的时序如图1所示。




图1 定时器模式运行时序



## 4. 应用例

#### 4.1 应用例的说明

(1) 定时器 X 每 4 ms 产生一次下溢。

 $4ms = (1/f1) \times (预分频器 X+1) \times (定时器 X+1)$ =  $62.5ns \times (255+1) \times (249+1)$ 

定时器X每下溢一次,就产生一次定时器X中断请求。通过程序对定时器X中断进行250次计数,就会建立1秒的时序,并更新显示数据。

(2) LED连接到端口P11~P14,显示"L"有效电平。显示数据为0000b~1111b,并且每过1秒就加上1。使用的引脚如图2所示。





图2 使用的引脚

另外,本样本程序在SFR的位分配的情况下,有可能对不使用的功能位进行操作。这些设定值请根据用户系统的使用情况进行设定。












