# **Special Page Subroutine**

#### 1.0 Abstract

This program is an example for using a special subroutine call.

#### 2.0 Introduction

The program branches to a subroutine at an address that is the address set in one of the special page vector tables (in 2 bytes each) plus FF0000H. The area in which control can branch to a subroutine is from address FF0000H to address FFFFFFH.

The special page vector tables are located in an area ranging from address FFFE00H to address FFFDBH. The special page number at address FFFE00H is 255 and that at address FFFFDAH is 18. A label can be used in place of a special page number.

Shown in this program are an example where labels are used for special page numbers 255 and 18 and an example where a special page number (254) is used directly.
