#### 2.0 Introduction

- Operation (1) Setting the A-D conversion start flag to "1" causes the A-D converter to start the conversion on voltage input to the AN<sub>o</sub> pin.
  - (2) After the A-D conversion of voltage input to the AN<sub>0</sub> pin is completed, the content of the successive comparison register (conversion result) is transmitted to A-D register 0.
  - (3) The A-D converter converts all pins selected by the user. The conversion result is transmitted to A-D register i corresponding to each pin every time A-D conversion on the pin is completed. The A-D conversion interrupt request bit does not change.
  - (4) The A-D converter continues operating until the A-D conversion start flag is set to "0" by software.

Note

In repeat sweep mode 0, the A-D conversion interrupt request bit does not change. By using Timer, it
is possible to make it synchronize with the timing which A-D conversion completes, and to read
conversion results repeatedly.





Figure 1. Operation timing of repeat sweep mode 0

Figure 1 shows the operation timing
