






TYPICAL CHARACTERISTICS ($T_A = 25^{\circ}C$)




SAFE OPERATING AREAS (TRANSIENT THERMAL RESISTANCE METHOD)









COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE
