




TEST CIRCUIT 1 AVALANCHE CAPABILITY

TEST CIRCUIT 2 SWITCHING TIME







TEST CIRCUIT 3 GATE CHARGE












FORWARD TRANSFER CHARACTERISTICS








R_{DS(o1)} - Drain to Source On-state Resistance - mΩ




R_{DS(on)} - Drain to Source On-state Resistance - mΩ






CAPACITANCE vs. DRAIN TO SOURCE VOLTAGE






DYNAMIC INPUT/OUTPUT CHARACTERISTICS

REVERSE RECOVERY TIME vs. DIODE FORWARD CURRENT






EQUIVALENT CIRCUIT




