
Performance Curves








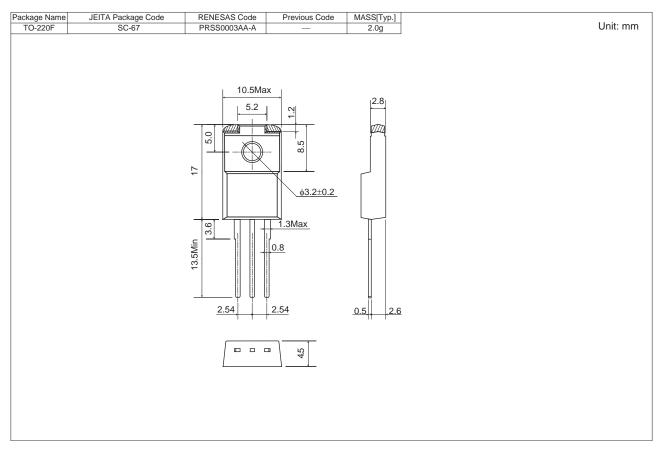
