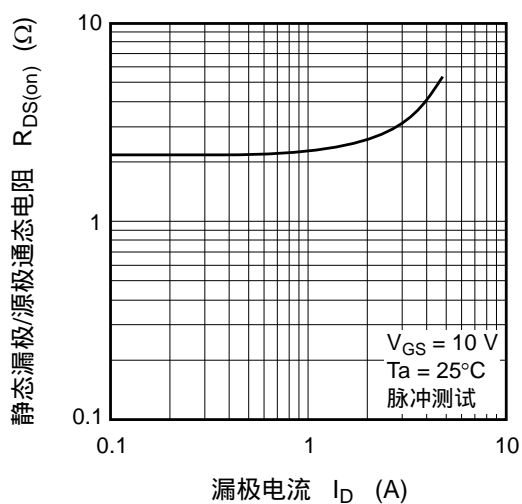

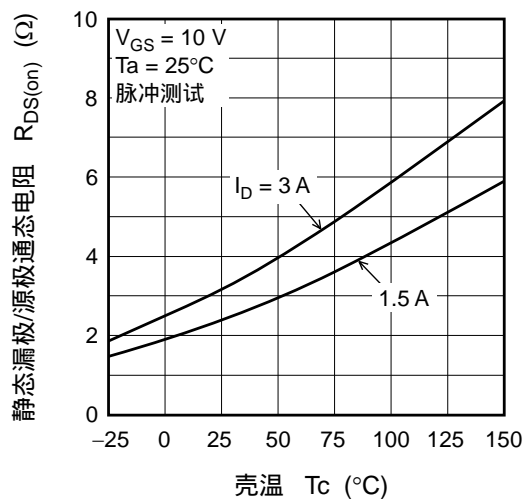

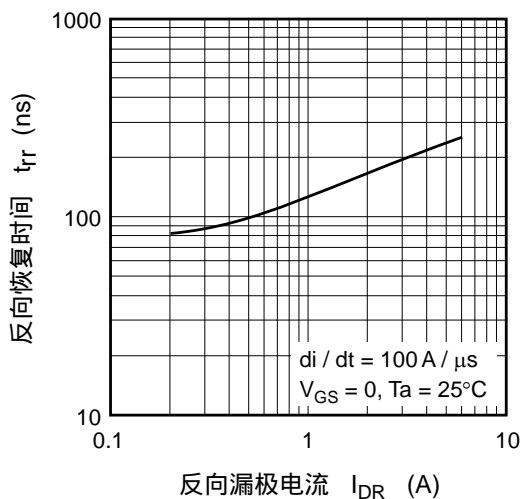

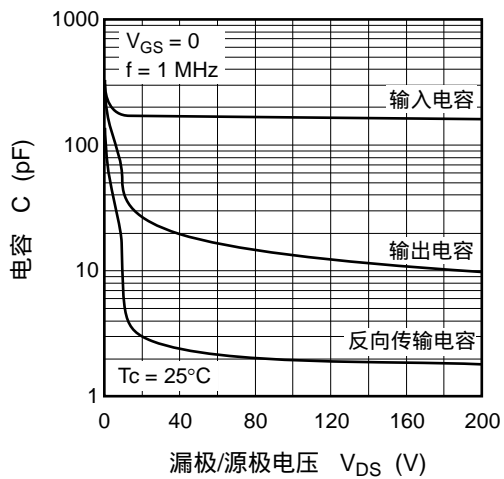
静态漏极/源极通态电阻-壳温 (典型)



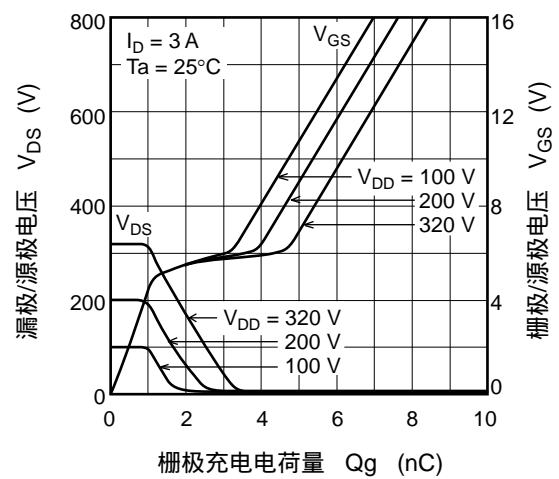

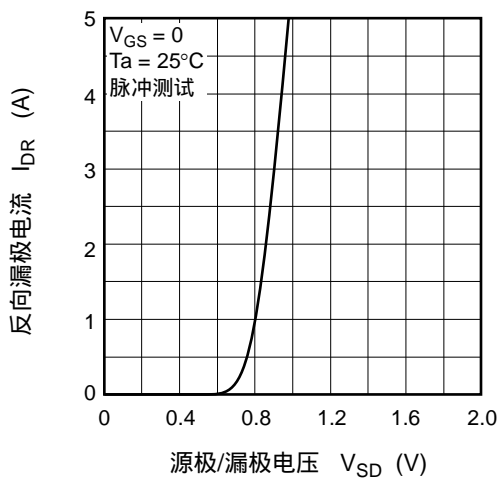

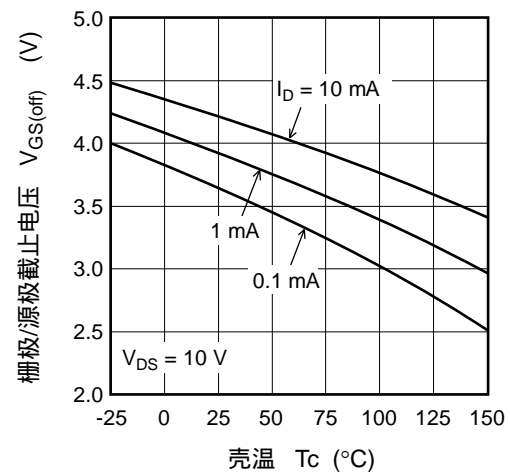

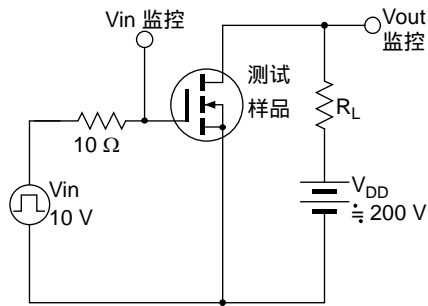

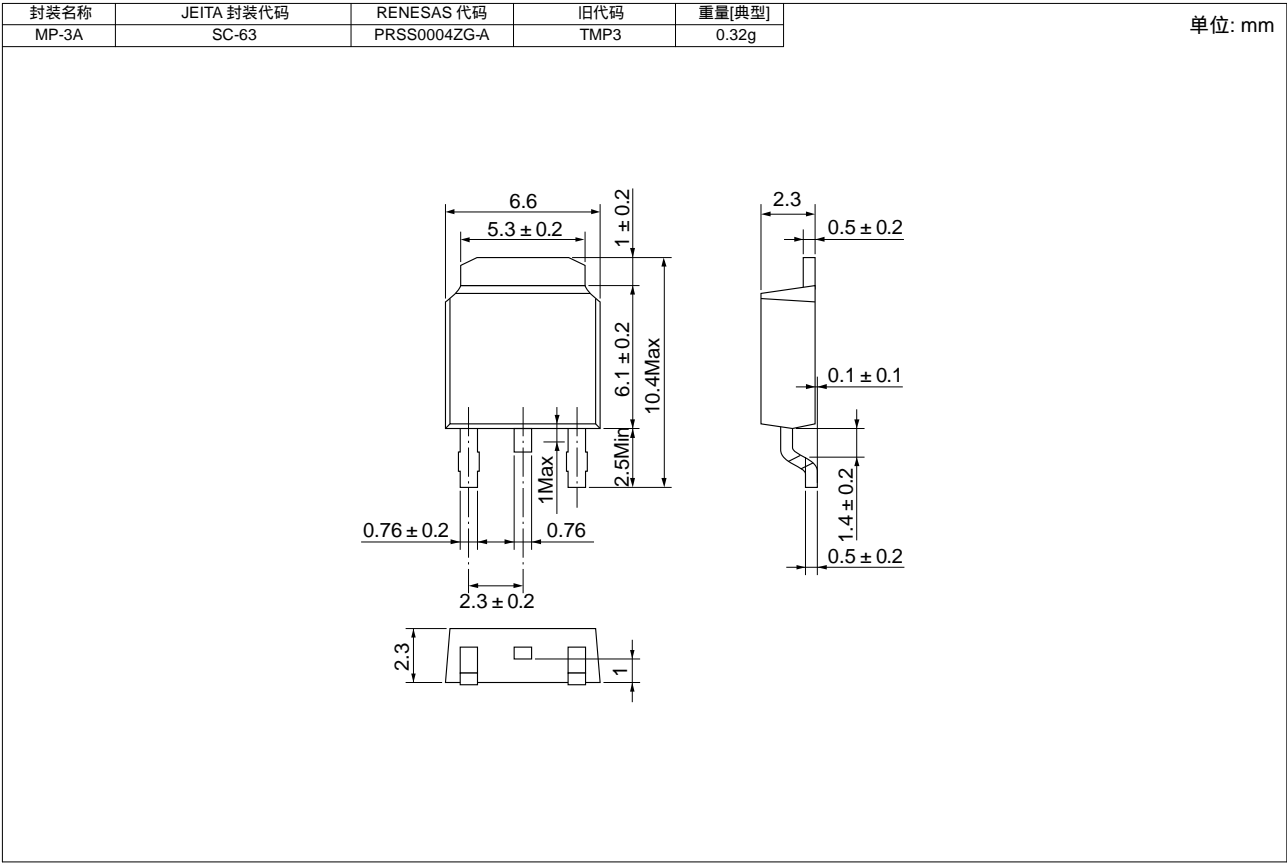
