Timer 2 / Timer 3 (Carrier Wave Form Control / Carrier Wave Output Control)

1. Abstract

The following article provides an application example of carrier wave generation (remote-control carrier wave output from P42/CARR) employing Timer 2 and Timer 3.

2. Introduction

The application example introduced in this issue is applied to the following condition:

· Applicable Microcomputer: 7545 Group

· Oscillation frequency: 4 MHz

3.1 Application Example of Carrier Wave Output Control

Outline

- · Form carrier wave by Timer 2.
- · Control output of carrier wave from P42/CARR using Timer 3.
- Switch output-enabled mode to output-disabled mode (or vice versa). Change On/Off of carrier wave output from P42/CARR pin every time Timer 3 underflow occurs. This switching operation is accomplished only when the carrier wave output trigger is valid.
- · By setting values to Timer 3, determine carrier wave interval for output period and non-output period.
- · Carrier wave is generated internally even when P42/CARR output is disabled.

Specification

· Carrier Wave: 40 kHz, Duty 1/2

· P42/CARR Output: Standard interval T=0.55 ms, 8T output On -4T output Off -T output On

Figure 1. shows auto-control of P42/CARR output by Timer 3, whereas Figure 2. illustrates the connection diagram of Timer and its divide ratio.




Figure 1. Auto-Control of P42/CARR Output by Timer 3




Figure 2. Connection Diagram of Timer and Dividing Ratio




Figure 3. Control Procedure
