1. Abstract

This document describes the setting procedure to use the A/D converter in repeat sweep mode 1.

2. Introduction

The application example described in this document applies to the following microcomputer (MCU):

• MCU: M16C/65 Group

This application note can be used with other M16C Family MCUs which have the same special function registers (SFRs) as the above group. Check the manual for any modifications to functions. Careful evaluation is recommended before using the sample code described in this application note.

3. Operation in Repeat Sweep Mode 1

This section describes operation when using the A/D converter in repeat sweep mode 1 with a software trigger.

- (1) When the ADST bit in the ADCON0 register is set to 1 (A/D conversion start), A/D conversion starts. The input voltage of the AN0 pin is converted.
- (2) After completing A/D conversion of the AN0 pin, the value in the successive conversion register (conversion result) is transferred to the AD0 register.
- (3) A/D conversion is executed in the order of AN0, AN1, AN0, AN2 though to AN7, then the conversion is repeated in the same order starting again from AN0. Every time A/D conversion for a pin is completed, the conversion result is transferred to the ADi (i = 0 to 7) register corresponding to the pin. The IR bit in the ADIC register does not become 1 (interrupt requested).
- (4) A/D conversion does not stop until the ADST bit in the ADCON0 register is set to 0 (A/D conversion stop) by a program.




Figure 3.1 Transition Diagram of Pins Used During A/D Conversion in Repeat Sweep Mode 1

Figure 3.1 shows the Transition Diagram of Pins Used During A/D Conversion in Repeat Sweep Mode 1.

4. A/D Conversion Time

This section describes how to calculate A/D conversion time.

4.1 A/D Conversion Cycle

Table 4.1 shows Cycles of A/D Conversion Item. A/D conversion time is described below.

Start processing time depends on which ϕAD is selected.

A/D conversion starts after the start processing time elapses by setting the ADST bit in the ADCON0 register to 1 (A/D conversion start). When reading the ADST bit before starting A/D conversion, 0 (A/D conversion stop) is read. In repeat sweep mode 1, inter-execution processing time is inserted between A/D conversions.

• Repeat sweep mode 1:


Start processing time + (A/D conversion execution time + inter-execution processing time + A/D conversion execution time + inter-execution processing time + ...)

4.2 Repeat Mode, Repeat Sweep Mode 0, and Repeat Sweep Mode 1

In repeat mode, repeat sweep mode 0, and repeat sweep mode 1, when reading the ADi register (i = 0 to 7) during the period when the ADi register value is rewritten, an undefined value may be read. Read the ADi register several times to determine whether the read value is valid. The period for reading an undefined value is one cycle of fAD.



The above diagram assumes the following:

- Bits MD1 to MD0 in the ADCON0 register are 11b, and the MD2 bit in the ADCON1 register is 0 (repeat sweep mode 0).
- Bits ADGSEL1 to ADGSEL0 in the ADCON2 register are 00b (AN0 to AN7 groups selected).
- Bits SCAN1 to SCAN0 in the ADCON1 register are 11b (AN0 to AN7 (8 pins) selected).




Figure 5.1 Setting Procedure When Using Repeat Sweep Mode 1

6.1 Sample Code Operation

In repeat sweep mode 1, functions listed in Table 6.1 can be selected. The settings used in the sample code are marked with "\sqrt{"}" in the table. The sample code operation is as follows; set the CPU clock as the main clock with no division by executing functions for CPU initialization, transition from 125 kHz on-chip oscillator mode to high-speed mode, then execute the function for A/D conversion in repeat sweep mode 1. Refer to 6.2 Function Tables for details on functions.

General Precautions in the Handling of MPU/MCU Products

The following usage notes are applicable to all MPU/MCU products from Renesas. For detailed usage notes on the products covered by this manual, refer to the relevant sections of the manual. 1. Handling of Unused Pins

Handle unused pins in accord with the directions given under Handling of Unused Pins in the manual.

The input pins of CMOS products are generally in the high-impedance state. In operation with an unused pin in the open-circuit state, extra electromagnetic noise is induced in the vicinity of LSI, an associated shoot-through current flows internally, and malfunctions occur due to the false recognition of the pin state as an input signal become possible. Unused pins should be handled as described under Handling of Unused Pins in the manual.

2. Processing at Power-on

The state of the product is undefined at the moment when power is supplied.

The states of internal circuits in the LSI are indeterminate and the states of register settings and pins are undefined at the moment when power is supplied.

In a finished product where the reset signal is applied to the external reset pin, the states of pins are not guaranteed from the moment when power is supplied until the reset process is completed.

In a similar way, the states of pins in a product that is reset by an on-chip power-on reset function are not guaranteed from the moment when power is supplied until the power reaches the level at which resetting has been specified.

3. Prohibition of Access to Reserved Addresses

Access to reserved addresses is prohibited.

 The reserved addresses are provided for the possible future expansion of functions. Do not access these addresses; the correct operation of LSI is not guaranteed if they are accessed.

4. Clock Signals

After applying a reset, only release the reset line after the operating clock signal has become stable. When switching the clock signal during program execution, wait until the target clock signal has stabilized.

— When the clock signal is generated with an external resonator (or from an external oscillator) during a reset, ensure that the reset line is only released after full stabilization of the clock signal. Moreover, when switching to a clock signal produced with an external resonator (or by an external oscillator) while program execution is in progress, wait until the target clock signal is stable.

5. Differences between Products

Before changing from one product to another, i.e. to one with a different part number, confirm that the change will not lead to problems.

— The characteristics of MPU/MCU in the same group but having different part numbers may differ because of the differences in internal memory capacity and layout pattern. When changing to products of different part numbers, implement a system-evaluation test for each of the products.
