

DESCRIPTION

The PS8802-1, -2 are optically coupled isolators containing an AlGaAs LED on the light emitting diode (input side) and a PIN photodiode and a high-speed amplifier transistor on the output side on one chip. The PS8802-1, -2 are designed specifically for high common mode transient immunity (CMR), the PS8802-2 is suitable for high density applications.





2. Test circuit for common mode transient immunity





- 2. By-pass capacitor of 0.1 μ F is used between V_{CC} and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
- 3. Avoid storage at a high temperature and high humidity.
- 4. Avoid cleaning with Freon based or halogen-based (chlorinated etc.) solvents.
- 5. Do not use fixing agents or coatings containing halogen-based substances.


TYPICAL CHARACTERISTICS (T_A = 25 °C unless otherwise specified)




HIGH LEVEL OUTPUT CURRENT vs. AMBIENT TEMPERATURE









Dependence of maximum safety ratings with package temperature


