Performance Curves









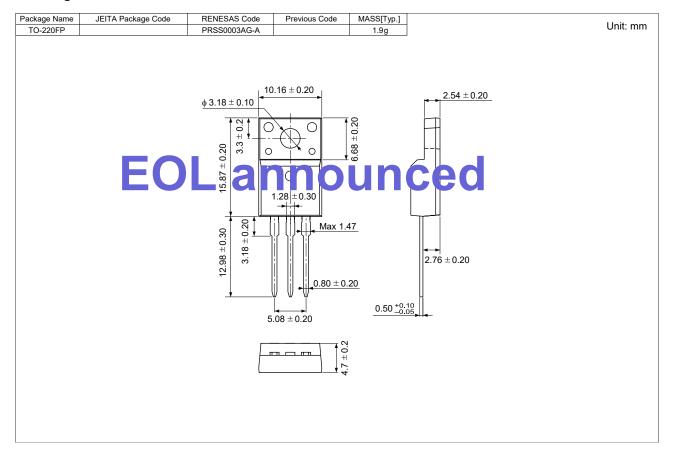
