QE for AFE: Analog Front End Tuning Guide

Introduction

This document explains how to operate the "QE for AFE" PC tool, which is for connection to the RX23E-B board to control the operation of the board. For details on the MCU, refer to the "RX23E-B Group User's Manual: Hardware".

The QE for AFE is used in combination with the RSSKRX23E-B board control program (which comes with the R01AN6364 application note).

1. Overview

1.1 System Overview

The QE for AFE is a development assistance tool that supports the development of embedded systems which perform highly accurate sensing with the use of microcontrollers that have a built-in analog front end (AFE). The QE for AFE handles serial communications with the RSSKRX23E-B board (hereafter referred to as the target board) via a USB connection to set the AFE registers of the RX23E-B mounted on the target board, control the operation of the AFE, and obtain values from A/D conversion or voltage values and display them as a graph. The QE for AFE also sets the operation of sample programs that run on the target board, and obtains the results of measurement and displays them as a graph.

The main functions are listed below.

(1) Evaluating the AFE, DSAD, and R16DA.

- a. Graphical setting of the operating conditions
- > Select and specify the register parameters on the block-diagram level.
- > Display the frequency-gain characteristic graph of an on-chip digital filter based on register settings.
- b. Directing the starting and stopping of A/D conversion, and obtaining and displaying the results.
- Dump the values from A/D conversion.
- > Display the waveform of the values from A/D conversion.
- > Analyze and display a histogram of the values from A/D conversion.
- > Display the average, maximum, and minimum values of the values obtained from A/D conversion.

(2) Controlling sample programs and user programs, and obtaining and displaying the measured values.

- > Set numerical parameters.
- Select functions.
- Obtain the measured values.
- > Display the values obtained from measurement (waveform or raw data).

2. Preparations

Using the QE for AFE requires the following preparations.

- Installing and executing the USB serial port driver
- Installing the QE for AFE
- Programming the board control program for the QE for AFE
- Setting up the target board

2.1 Installing and Executing the USB Serial Port Driver

The target board is equipped with an FT232H USB-to-serial conversion IC, made by Future Technology Devices International, Ltd. If you will need this driver at the time of USB connection, download and install the driver file from the FTDI Web page (http://www.ftdichip.com/).



2.2 Installing and Launching the QE for AFE

The QE for AFE is provided in a zip package. To install the QE for AFE, take the following steps.

- Unzip the zip file at a desired location on your PC.
 However, select a shallow layer in the folder hierarchy for this purpose.
 Note: Do not place it under the OS program folder (C:¥Program Files).
- (2) Double-click on "¥QE-AFE¥eclipse¥ qe-afe.exe" to start the QE for AFE.

- (3) The license agreement dialog box is displayed when you start the QE for AFE for the first time. Confirm the contents of the license agreement and select [Agree] or [Disagree].
- If you select [Agree] in the above step, the QE for AFE will be launched and ready to use.
- If you select [Disagree] in the above step, the QE for AFE will not start and you will not be able to use it.

2.2.1 Updating the QE for AFE

If you want to update the QE for AFE, obtain the updated version of the package and perform updating by following the same procedure as for installation.

2.2.2 Uninstalling the QE for AFE

If you want to uninstall the QE for AFE, simply delete the folder where you unzipped the zip file.

2.3 Programming the Board Control Program for the QE for AFE

The board control program is already written to the RX23E-B on the RSSKRX23E-B board as shipped. If the program for the RX23E-B requires re-writing during software development, write the board control program included in the RX23E-B Group RSSKRX23E-B Board Control Program Application Note (R01AN6364). For details, refer to "RSSKRX23E-B Renesas Solution Starter Kit for RX23E-B Quick Start Guide (R20QS0044)".



3. Examples of Evaluation

This application note provides register setting files that can be imported into the QE for AFE. This section describes the procedure for importing the register setting files and evaluating the operation. Table 3-1 lists the register setting files.

The detailed evaluation procedure is explained in "3.1 Evaluation Procedure", and a setting example is shown in "3.2 Example of Evaluating DSAD0".

3.1 Evaluation Procedure

This section describes the procedure of evaluation when the output of R16DA is input to the AMUX and A/D conversion is performed, as shown in Figure 3-1.

• Register setting file: qe_afe_sample_r16da.3eb

In this example, a reference voltage and input signal do not have to be supplied from outside the target board. This makes it easy to check how to use the QE for AFE.

3.1.1 Preparations

Make the preparations for using the QE for AFE by following the instructions in "2.Preparations".

- Install the QE for AFE.
- Write the board control program for the QE for AFE.
- Set up the target board.
 - Set the JP1 jumper pin on the target board to "Vbus".
 - Set the JP11 jumper pin on the target board to "Single Chip".

3.1.2 Connecting the Host PC to the Target Board

Connect the host PC to the target board in the manner shown below.

3.1.3 Starting the QE for AFE and Selecting the Device

Start the QE for AFE.

In the QE for AFE, select the device to be used in AFE tuning. Select "RX" for [Series] and "RX23E-B" for [Device], then click on the [OK] button.

3.1.4 Connecting the Target Board

In the QE for AFE, select the COM port and click on the [Connect] button.

3.1.6 Setting R16DA

With the selected register setting file, R16DA is used to generate a 1.5-V signal.

R16DA is set as shown in the figure below.

3.1.7 Setting DSAD0

With the register setting file, DSAD0 is used to set the output of DA0 and DAC GND as input signals.

Click on the icon shown below to write the register values to the RX23E-B on the target board.

Select the [Monitor] tab to switch to the monitor display.





Click on the [Start AFE monitoring] button to start AFE monitoring.

3.1.10 Displaying a Graph

In the initial state, a waveform is displayed on the left side of the window and a histogram is displayed on the right side. If the waveform is not displayed, click on the icon indicated below to display the waveform.

If the histogram is not displayed, click on the icon indicated below to display the histogram.

The values of the A/D conversion result registers are displayed graphically. Both the X-axis and Y-axis ranges of the graph can be adjusted for easier viewing.

3.2.1 Calibration

After the QE for AFE is connected to the target board, clicking on the icon indicated below allows making the settings for calibration of the analog characteristics.

Calibration can be performed for each channel. After selecting the channel for calibration, enter the voltage being input to the pin and click on the [Next] button to display the result of calibration.

Click on the [Finish] button to reflect the results of calibration in the register values for the filter and on the [AFE Connection] tabbed page.

To reflect the results of calibration in the RX23E-B registers, tick the checkboxes for the registers to be calibrated on the [AFE Connection] tabbed page, and be sure to write them to the RX23E-B on the target board.

The results of A/D conversion when the analog signals are input from the AIN0 and AIN1 pins are displayed as a graph as shown below in Figure 3-25, which only shows the waveform.

4. Explanation of Functions

The QE for AFE has three main functions. Each of the functions can be selected by using the tabs at the bottom of the QE for AFE.

Table 4-1 Function Tabs of the QE for AFE

Tab Name	Description
AFE Connection	Displays a block diagram of the analog functions, and setting for each of the analog functions can be made on the block diagram. The register values based on these settings are reflected in the registers of the RX23E-B.
Monitor	Obtains the A/D-converted values from the RX23E-B, and displays a waveform and histogram of them.
Application	Obtains the application monitoring data from the RX23E-B, and displays a waveform. An interface for setting values or triggers in the user program is also provided.



4.1 UART Connection

The default bit rate is 4,000,000 bps. The rate can be changed by clicking on the icon indicated below.

The board control program for the RSSKRX23E-B included as part of the RX23E-B Group RSSKRX23E-B Board Control Program Application Note (R01AN6364) communicates at a bit rate of 4,000,000 bps.

4.2 "AFE Connection" Function

By selecting the [AFE Connection] tab, the settings for the analog functions can be made on a block diagram.

The register values based on these settings can be reflected in the RX23E-B registers.

All of the settings can be exported to or imported from a register setting file, and the imported settings can be reflected in the QE for AFE.

By clicking on the icon indicated below, the values from A/D conversion can be displayed as a waveform.

The X-axis shows the time and the Y-axis shows the values from A/D conversion. The display ranges of both axes can be set with parameters.

The values from A/D conversion and voltage values can be displayed as raw data. For the display of raw data, refer to "4.3.4 Displaying the Raw Data".

4.3.3 Displaying a Histogram

By clicking on the icon indicated below, a histogram with the values from A/D conversion on the selected channel as the population can be displayed.

The X-axis shows the values from A/D conversion and the Y-axis shows their frequencies. The display range of the X-axis can be set by parameters. The Y-axis is displayed in the range from 0 to the value with the maximum frequency.

The values for each ranking can be shown as raw data. For the display of raw data, refer to "4.3.4 Displaying the Raw Data".

By clicking on the icons for both waveform display and histogram display, the waveform and histogram can be simultaneously displayed in two regions of the window. For an image of such a display, see Figure 4-10.

1. Precaution against Electrostatic Discharge (ESD)

A strong electrical field, when exposed to a CMOS device, can cause destruction of the gate oxide and ultimately degrade the device operation. Steps must be taken to stop the generation of static electricity as much as possible, and quickly dissipate it when it occurs. Environmental control must be adequate. When it is dry, a humidifier should be used. This is recommended to avoid using insulators that can easily build up static electricity. Semiconductor devices must be stored and transported in an anti-static container, static shielding bag or conductive material. All test and measurement tools including work benches and floors must be grounded. The operator must also be grounded using a wrist strap. Semiconductor devices must not be touched with bare hands. Similar precautions must be taken for printed circuit boards with mounted semiconductor devices.

2. Processing at power-on

The state of the product is undefined at the time when power is supplied. The states of internal circuits in the LSI are indeterminate and the states of register settings and pins are undefined at the time when power is supplied. In a finished product where the reset signal is applied to the external reset pin, the states of pins are not guaranteed from the time when power is supplied until the reset process is completed. In a similar way, the states of pins in a product that is reset by an on-chip power-on reset function are not guaranteed from the time when power is supplied until the power is supplied until the power reaches the level at which resetting is specified.

3. Input of signal during power-off state

Do not input signals or an I/O pull-up power supply while the device is powered off. The current injection that results from input of such a signal or I/O pull-up power supply may cause malfunction and the abnormal current that passes in the device at this time may cause degradation of internal elements. Follow the guideline for input signal during power-off state as described in your product documentation.

4. Handling of unused pins

Handle unused pins in accordance with the directions given under handling of unused pins in the manual. The input pins of CMOS products are generally in the high-impedance state. In operation with an unused pin in the open-circuit state, extra electromagnetic noise is induced in the vicinity of the LSI, an associated shoot-through current flows internally, and malfunctions occur due to the false recognition of the pin state as an input signal become possible.

5. Clock signals

After applying a reset, only release the reset line after the operating clock signal becomes stable. When switching the clock signal during program execution, wait until the target clock signal is stabilized. When the clock signal is generated with an external resonator or from an external oscillator during a reset, ensure that the reset line is only released after full stabilization of the clock signal. Additionally, when switching to a clock signal produced with an external resonator or by an external oscillator while program execution is in progress, wait until the target clock signal is stable.
6. Voltage application waveform at input pin

Waveform distortion due to input noise or a reflected wave may cause malfunction. If the input of the CMOS device stays in the area between V_{IL} (Max.) and V_{IH} (Min.) due to noise, for example, the device may malfunction. Take care to prevent chattering noise from entering the device when the input level is fixed, and also in the transition period when the input level passes through the area between V_{IL} (Max.) and V_{IH} (Min.).

7. Prohibition of access to reserved addresses

Access to reserved addresses is prohibited. The reserved addresses are provided for possible future expansion of functions. Do not access these addresses as the correct operation of the LSI is not guaranteed.

8. Differences between products

Before changing from one product to another, for example to a product with a different part number, confirm that the change will not lead to problems. The characteristics of a microprocessing unit or microcontroller unit products in the same group but having a different part number might differ in terms of internal memory capacity, layout pattern, and other factors, which can affect the ranges of electrical characteristics, such as characteristic values, operating margins, immunity to noise, and amount of radiated noise. When changing to a product with a different part number, implement a system-evaluation test for the given product.
