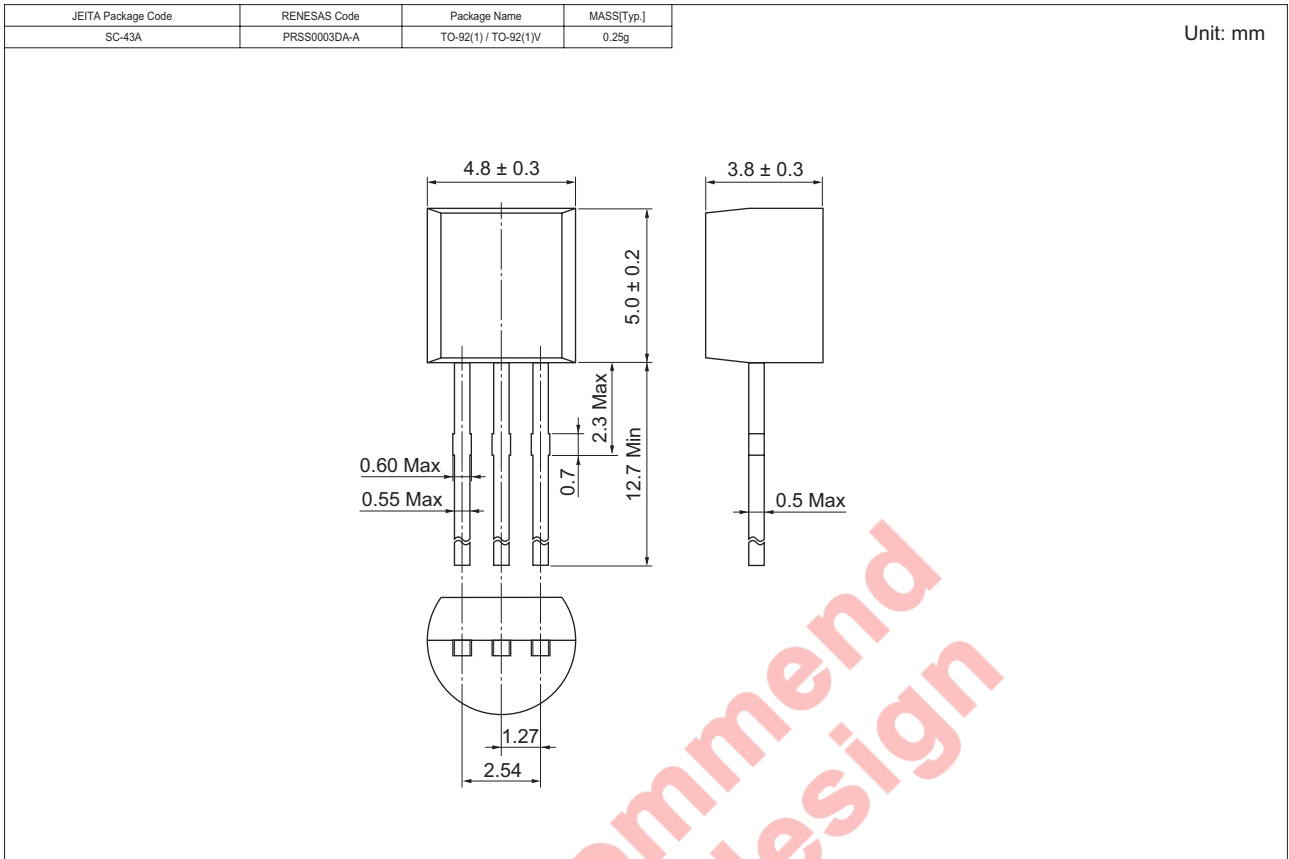
Main Characteristics
