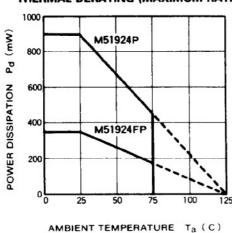

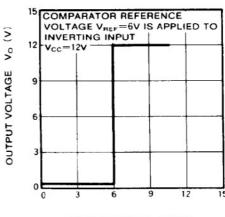

#### **OUTPUT VOLTAGE VS. INPUT VOLTAGE**

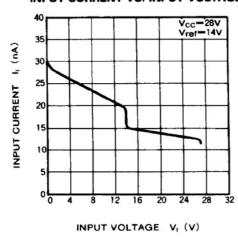

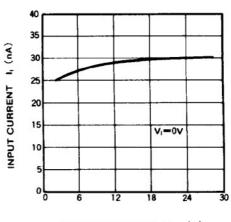

#### INPUT CURRENT VS. INPUT VOLTAGE

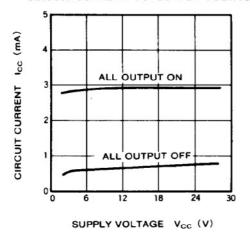


#### INPUT CURRENT VS. SUPPLY VOLTAGE

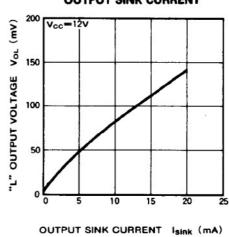


SUPPLY VOLTAGE VCC (V)

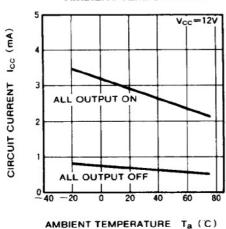
#### **CIRCUIT CURRENT VS. SUPPLY VOLTAGE**



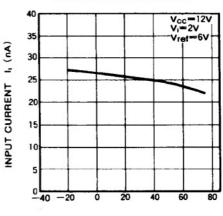
"L" OUTPUT VOLTAGE VS. OUTPUT SINK CURRENT
