**Revision 2:** This revised PDN notice is to update replacement part# for selective Clock devices that will be discontinued as shown in Attachment I. Last buy deadline for submission of order and last eligible ship date will be extended to 30-Jun-2014 and 30-Sep-2014 respectively.

**Background:**

- Recently, IDT issued End of Life Notices, for which there were retractions and amendments that were published later.
- The main reasons for these End of Life Notices were a shift from leaded to lead-free packages, and due to a Freescale fab continuity of supply.

**N-12-25 Revision History:**

- N-12-25 had different versions of MPC9230 parts, all of which are being discontinued. It identified 'leaded' replacement parts, which was an error.
- N-12-25R1 changed the leaded replacement parts to unleaded replacement parts.
- N-12-25R2 changes the replacement parts to 'None', as the earlier replacement parts are 'Not recommended for New Designs'.
