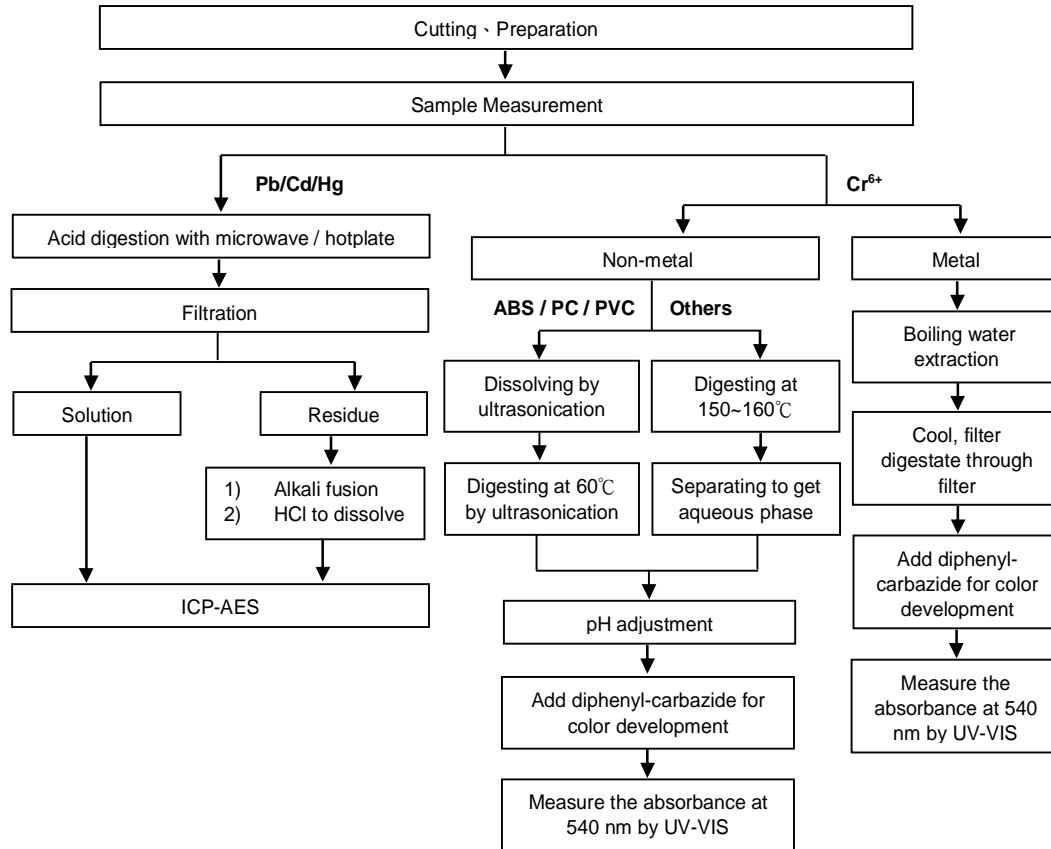

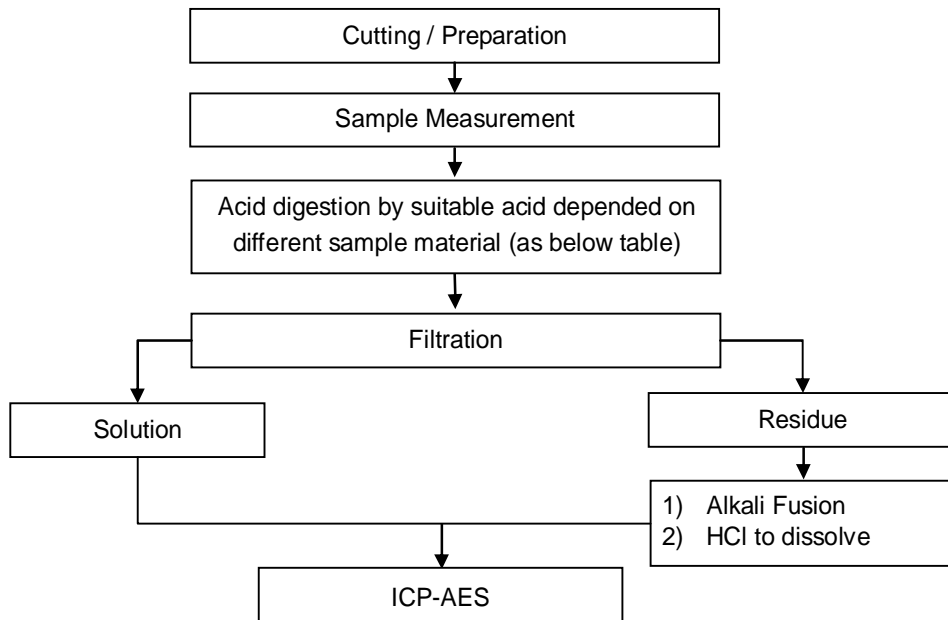

Flow Chart of digestion for the elements analysis performed by ICP-AES



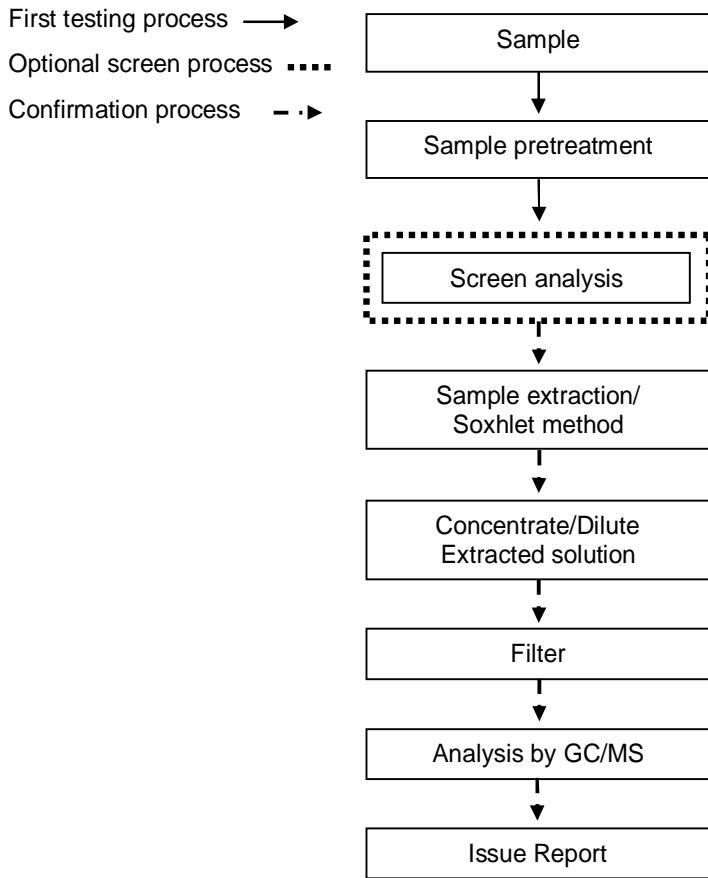

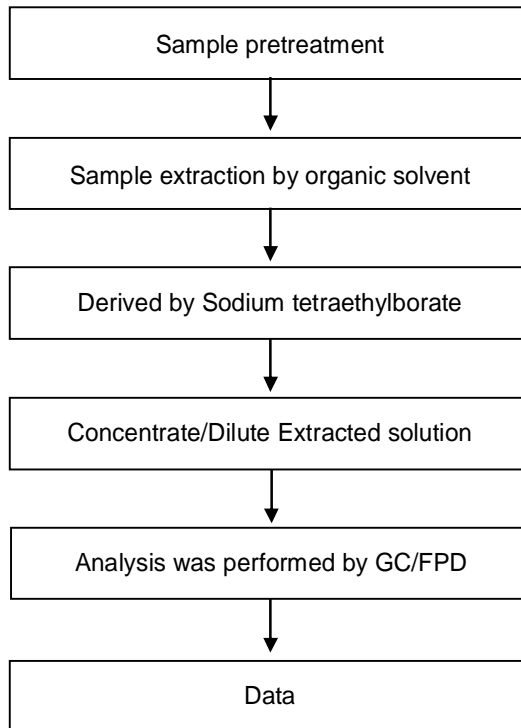

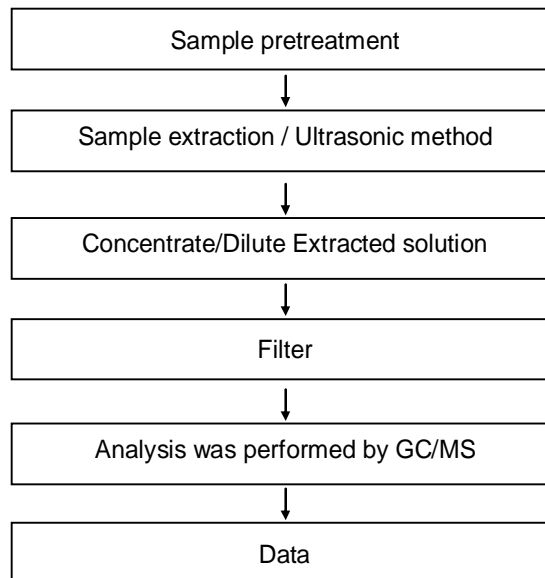

【Test item: HBCDD, Chlorinated Paraffins】



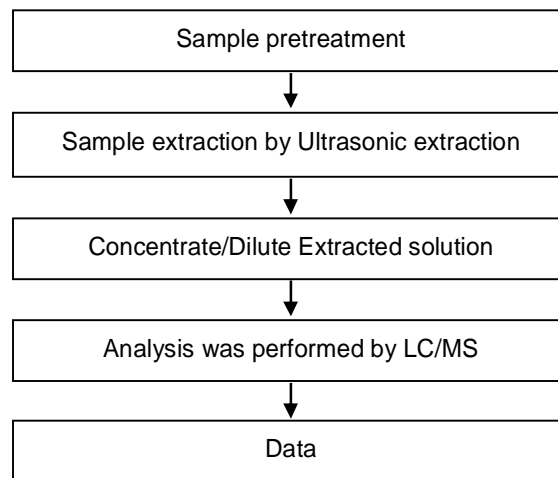

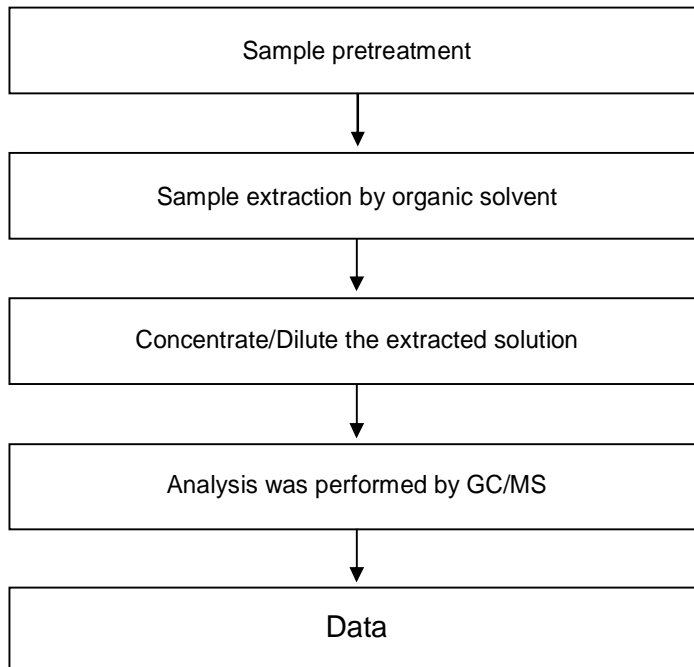
