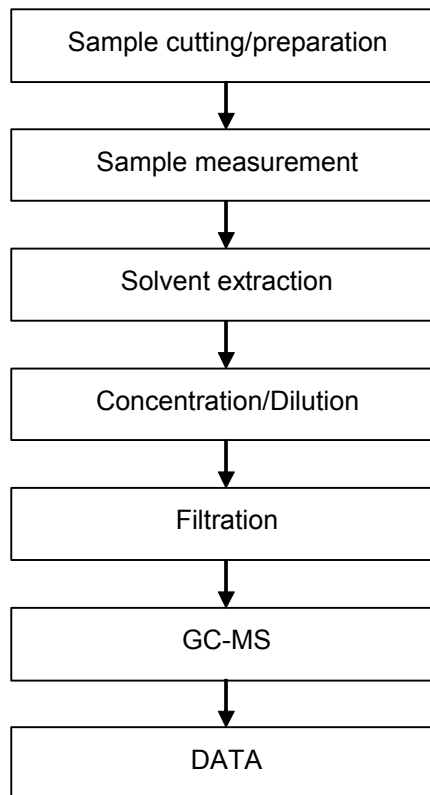

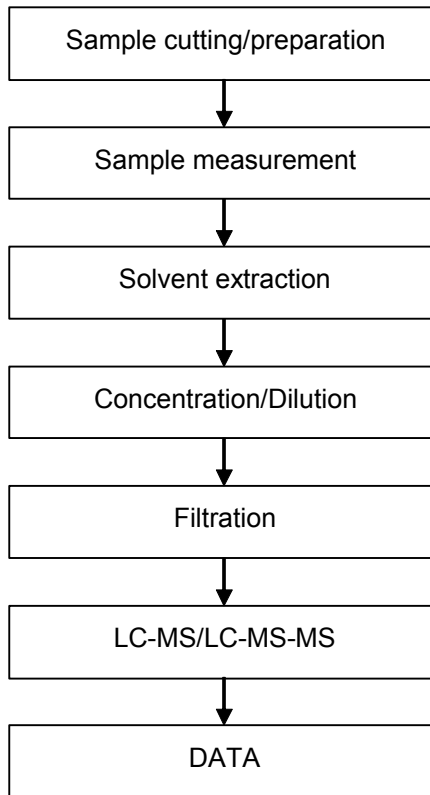

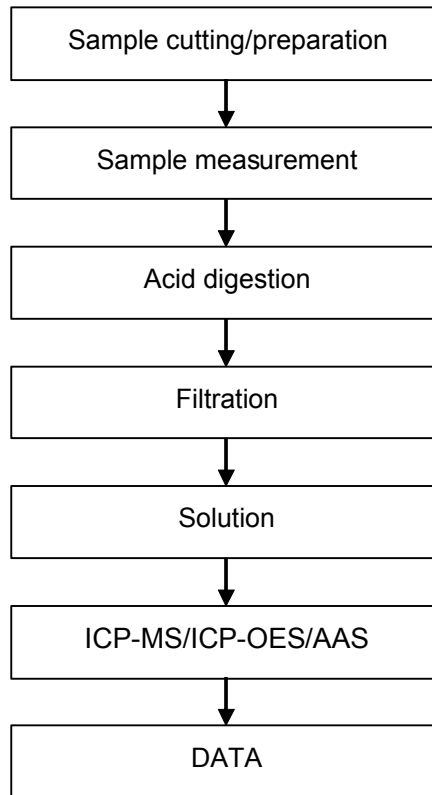

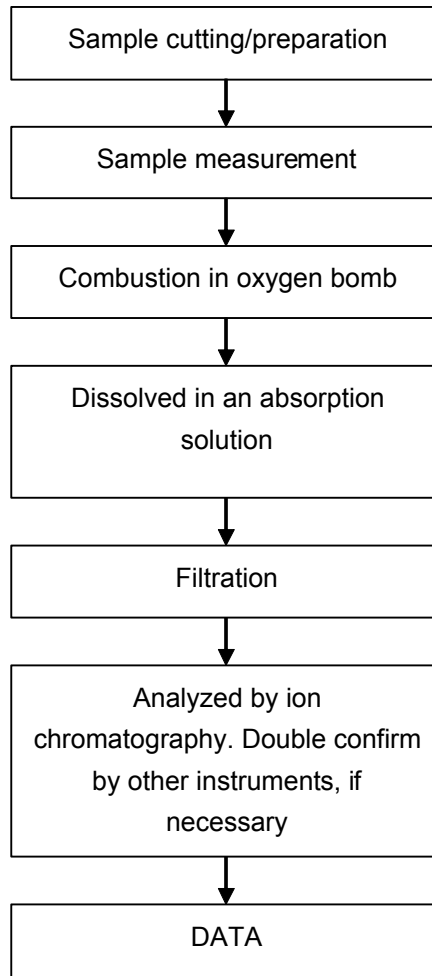

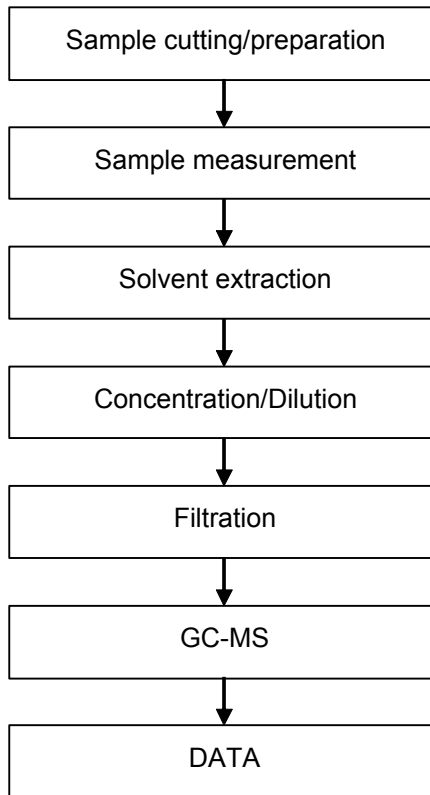

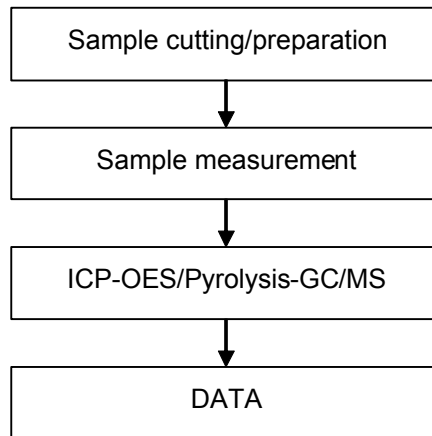

Red Phosphorus Testing Flow Chart

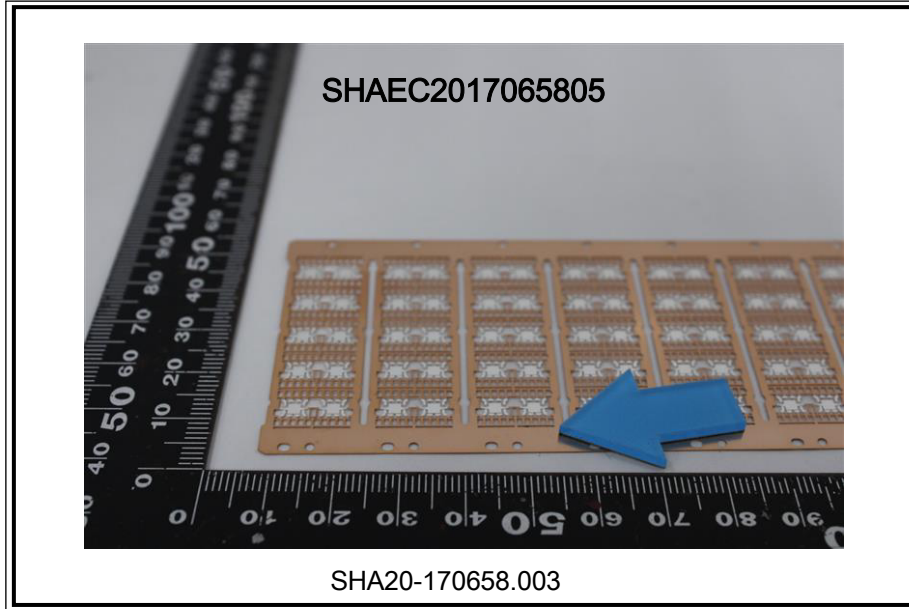
