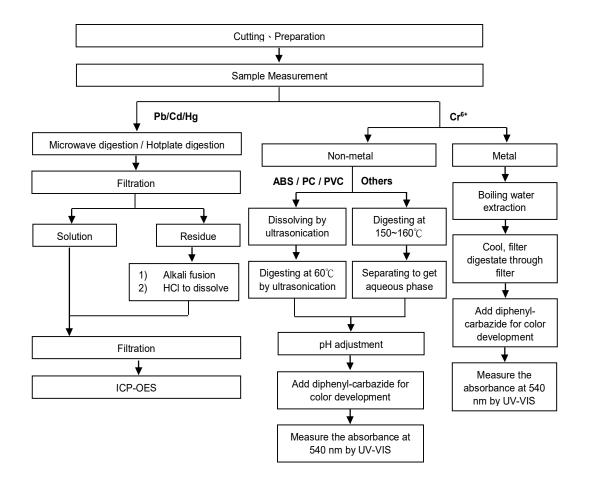

These samples were dissolved totally by pre-conditioning method according to below flow chart. (Cr<sup>6+</sup> test method excluded)



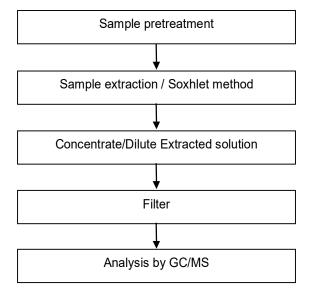

## PBB/PBDE analytical FLOW CHART





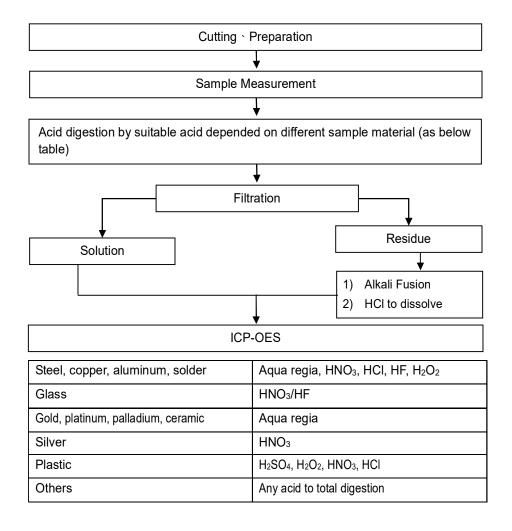

These samples were dissolved totally by pre-conditioning method according to below flow chart.



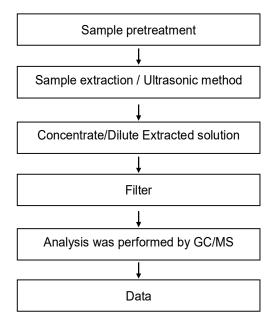

#### **HBCDD** analytical flow chart



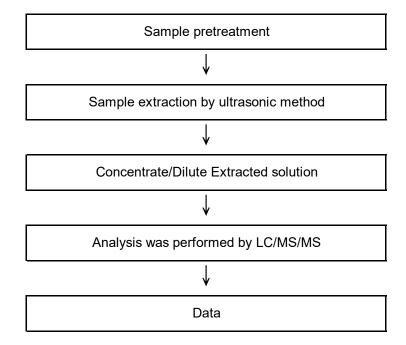

### **Analytical flow chart of PFOA/PFOS**



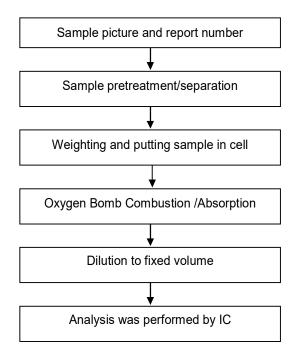

#### Analytical flow chart of Halogen





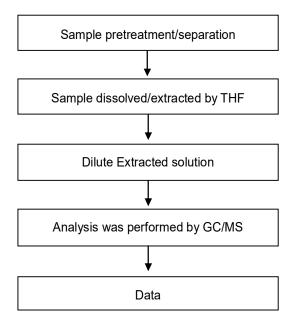

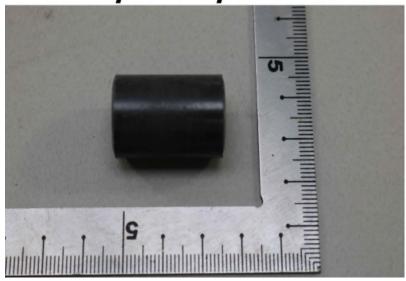
