Description of Change:

This notice is to inform you that Renesas Electronics America Inc will remove Country of Origin (COO) and Product Lot Details (Site Code, Date Code, Trace Code) from the bottom of package on the selective Renesas products. Product lot details remains on top of the package and COO is shown on the label. For details of change, please refer to Appendix B.

Reason for Change:

Bottom marking is same as top marking. This is to standardize to existing package marking, to which the product lot is marked on top of the package.

Impact on fit, form, function, quality & reliability:

The change will have no impact on the form, fit, function, quality, reliability and environmental compliance of the devices.

During the transition, shipments to customers may contain products with or without package bottom mark until the old inventory has been depleted.

Product Identification:

Product affected by this change is identifiable via Renesas's internal traceability system.

Note:

1. *Acknowledgement must be received by Renesas within 30 days or Renesas will consider the change as approved.*
2. *If timely acknowledgement is provided by Customer, then Customer shall have 90 days from the date of receipt of this PCN to make any objections to this PCN. If Customer fails to make objections to this PCN within 90 days of the receipt of the PCN then Renesas will consider the PCN changes as approved.*
3. *If customer cannot accept the PCN then customer must provide Renesas with a last time buy demand and purchase order.*


